- Community partnerships and stakeholder engagement








# MHSA planning benefits from community stakeholder input

- Consumers, family members, and providers
- Review programs and make recommendations
- Input for improvements outlined in Annual Update
- Plan reviewed (30 days) & public hearing at Behavioral Health Board







#### **MHSA Prevention & Early Intervention (PEI)**

 Programs designed to prevent mental illnesses from becoming severe and disabling, while improving timely access to services for high-risk and underserved communities.





## **PEI REGULATIONS**

- Up to 19% of total MHSA allocation
  SLO County's MHSA allocation = 19%
- At least 50% of county's PEI expenditures are delivered to children and youth
  - •SLO County's expenditures for youth = 56%
- Data Collection/Analysis
- Annual Reporting

## **PEI Budget**

- Fiscal Year 2022-23:
  \$4.6 million budget for PEI programs.
  - >\$4.1 million projected spend by July 2023.
  - >\$500k available funds for new or expansion of current programs.
