Hello! I am a concerned business owner of a gym in SLO County. We have been strongly recommending masks to our members but not enforcing them as intense physical exertion while wearing a mask can impede breathing and oxygen uptake. I am deeply concerned that mandating a mask will deter members from using our facility and from working out as intensely as they would like. We have already implemented a rigorous sanitizing schedule, rearranged our floor plan, have our trainers and staff wearing masks during all interaction with members, and are enforcing a capacity limit that allows for ample social distancing. I would like to know if I am required to turn away my members if they choose not to wear a mask while working out? Or can I allow them to take their mask off during high intensity training such as running on the treadmill or performing functional fitness? The health and longevity of our members is our number one priority. I am truly afraid that this mask-on mandate could impact us so severely that we may lose many members who have already gone too long without a proper workout and rely on us for their mental and physical health.
