#### **ACTION REQUIRED:**

It is requested that the Health Commission approve and authorize staff to submit the Health Commissioner application for Thomas Patrick O'Malley to the San Luis Obispo County Board Supervisors for appointment to a Consumer Seat on the County of San Luis Obispo Health Commission.

# **SUMMARY NARRATIVE:**

The composition of the Health Commission is dictated by article III, section 1 of the County of San Luis Obispo Health Commission bylaws which specify that the voting membership of the Health Commission shall consist of a majority of health care consumers. Of the remainder of the voting membership, two shall be indirect providers and three shall be direct providers who are representative of the health care system in San Luis Obispo County. The Heath Commission currently has 2 vacancies which are detailed below:

Efforts to achieve and retain full membership for the Heath Commission are ongoing and this item recommends one applicant for appointment to fill one vacant Consumer Seat.

The Health Commission bylaws require a minimum of six Health Care Consumer representatives. Thomas Patrick O'Malley is recommended for appointment to fill one empty Consumer Seat on the County of San Luis Obispo Health Commission.

The Nominating Committee recommends the approval of the Health Commissioner application for Thomas Patrick O'Malley based upon its review conducted on August 24, 2020.

# STAFF COMMENTS:

Staff recommends the approval of the appointment of Thomas Patrick O'Malley to a Consumer Seat on the County of San Luis Obispo Health Commission. Upon approval, staff will submit a recommendation for appointment by the Board of Supervisors at an upcoming meeting.

Application Questions for Tom O'Malley – 07/22/2020 –

Why I want to serve on the San Luis Obispo County Health Commission: My B.A. was in Economics (emphasis in Environment and Natural Resources) and M.A. was in Counseling. Beginning in 1976, I had a long career at the County Mental Health Department, as a licensed Marriage and Family Therapist and retired as the Administrator. I began serving as an Atascadero Planning Commissioner in 2000 and City Councilperson in 2002. I was impressed with research demonstrating that how Cities were designed, had a significant impact on lowering depression rates and improving physical health measures, resulting in cost reductions in these areas. More recently as Mayor, I have served on many Boards dealing with health-related issues including waste management, air quality and water quality. I was nominated for the 2011 Paul Wolff Accessibility Advocacy Award and am a longtime advocate for ADA accommodations. I like working with a diversity of folks interested in making our County a wonderful place to live, work and play, where all are healthy and safe. I believe I can make a difference in building consensus across all constituents in support of healthier environments and lifestyles.

What I envision contributing during my term on the Commission: I have experience in areas the Commission may have interest in: Appointed by the Governor to a five county Regional Water Quality Control Board, Past Chair of Boards in SLO County including: Council of Governments (SLOCOG), Regional Transportation Authority (RTA) where I advocated for public transportation for low-income folks to have medical services access, Air Pollution Control District Board (APCD), Integrated Waste Management Authority (IWMA) and the Economic Vitality Corporation (EVC). I volunteer with, and was a Board member of ECHO, the North County Homeless Services program. I have also served on several Boards related to substance abuse. I currently serve as Chair of the Atascadero Tourism Business Improvement District Board (A-TBID), representing the Lodging industry. I am President-Elect of Atascadero Kiwanis. This year, Kiwanis raised over \$55,000 for Atascadero Loaves & Fishes to provide food to those in need.

I have served on many Boards where building public trust, while resolving controversial issues and consensus building between representatives with wide divergent views, helped to craft solid policy.

I have strong experience in information systems management, fiscal and cost-benefit analysis and relationship building. I have experience in the public and private sectors and work to make sure both are integrated into a community effectively, so that our residents receive needed services through safe and healthy delivery systems. I will work with any willing groups that interface with our health care systems.

What Health issues are of interest or a concern to me: I would like all aspects of our community's health care system to be accessible, comprehensive, and effective. Of the current organizations that the Commission liaisons with, I am most interested in the Intimate Partner Violence Coalition, the SART Advisory Board, and the Suicide Prevention Council. As a former Therapist and Program Chief of the Forensic Mental Health Program, I worked extensively with sex offenders and victims of abuse. I am also interested in the SLO County Disaster Health Care Coalition, as I have attended FEMA disaster training and been a member of the County and City emergency response teams.

The expectation is that Commissioners will devote at least 10 hours a month.

I have never been on a Board that has taken less than ten hours a month, so this will not be a problem.

I write to recommend, without hesitation, that Tom O'Malley be appointed as a member of the Health Commission. He has proven experience in healthcare service delivery, in financial management, and in public service.

I have known Tom O'Malley since we played in band together at Atascadero High School in the late 1960s.

I was the elected SLO County Auditor-Controller from 1991 through 2012. During those years I had numerous interactions with Mr. O'Malley in his employment with the Sheriff's Department and the SLO County Health Agency. My staff audited his compliance with complicated state and federal health program regulations. We found that Tom consistently tried to meet these challenges, while at the same time creatively managed critical processes to optimize services and minimize costs.
