## **Proposed Negative Declarations**

A Negative Declaration is issued for projects that would not result in significant effects on the environment. In many cases, the project applicant has added mitigation measures to the project to reduce environmental impacts in order to qualify for a Negative Declaration. If you disagree with the issuance of a proposed Negative Declaration, you may provide comments or file a Request for Review (appeal) of the Negative Declaration. Requests for Review must be filed within two weeks of the date that the proposed Negative Declaration is posted and must address only environmental issues. There is a fee for the request. ## <u>Arroyo Grande</u>

#### DRC2014-00069

Request by Bethel Holding Co. for a Minor Use Permit to allow for construction of a single family residence, guesthouse, barn, outdoor features and driveway improvements. The project will result in the disturbance of approximately 1.0 acres and 814 cubic yards of cut and 778 cubic yards of fill on a project site totaling 612 acres. The project site is in the Rural Lands land use category on the north side of Lopez Drive, at 4455 Lopez Drive in Arroyo Grande, approximately 0.5 miles west of Lopez Lake and approximately 7.8 miles (southeast) of the City of San Luis Obispo. The site is in the in the Huasna-Lopez sub area of the South County planning area.

#### DRC2017-00017 (ED17-172)

Request by AT&T Mobility and Joe and Linda Lippe for a Conditional Use Permit to allow for the construction and operation of an unmanned wireless communications facility that includes the

following: Construction of a 60-foot high antenna support structure disguised as a pine tree ("monopine") containing: four (4), six-foot panel antennas and four (4) eight-foot panel antennas (split into two sectors of four (4) antennas each), and two (2), six-foot diameter dish antennas; Ancillary antenna support equipment within the branches of the mono-pine structure; Ground equipment including a 137-square foot, 12' 6" tall equipment shelter (containing equipment racks, battery pack, power plant, etc.), a backup power generator on a concrete slab, two air conditioning units, and emergency lighting; Fencing along the perimeter of the lease area consisting of a 6.5-foot tall standard concrete block (CMU) retaining wall along the north, east, and western perimeter and a wooden fence/gate along the southern perimeter; and Associated trenching for a v-ditch water drain and utility trenching for the installation of power/ communication lines. The proposed project is located at 10550 Little Quail Road within the North County Planning Area, Las Pilitas Sub Area, and within the Rural Lands land use category

## El Camino Real Bridge Replacement Project (ED17-181/300439)

A Mitigated Negative Declaration was prepared and issued for the El Camino Real Bridge Replacement Project, located in the community of Santa Margarita. The San Luis Obispo County Public Works Department proposes to replace the existing bridge on El Camino Real over Santa Margarita Creek with a new cast in place, concrete slab bridge on an improved alignment. The purpose of the project is to improve public safety along this portion of the roadway because the existing bridge is deteriorating and hydraulically inadequate. Implementation of the project will improve the roadway alignment with incorporation of a consistent 55-mile per hour posted speed corridor and a center turn lane. The project site is in the North County planning area, Salinas River subarea, within Supervisorial District 5.
