COMMENTS FROM OTHER AGENCIES

A) **Probation / Juvenile Hall / Coastal Valley Academy** – (Jim Salio) The numbers at Juvenile Hall are staying low. Less youth are being criminalized; wrap services credited with this shift. They are working on some reorganization with in the division.

CVA is going very well. The change from “group homes” to be complete in 8 months was discussed

B) **DSS / CWS** – (Elise Roberts) DSS Juvenile numbers are up. They are challenged with placing teen girls; the home are full. Foster rates are in flux at the State, but there is no increase to rates as yet. There are several family reunifications that will be reviewed.

The governor’s Budget impacts on their youth were discussed. there is money for Community College online courses and long-term money to support relatives going through the foster approval process.

C) **DA’s Office** – (James Graff-Radford) They are seeing an uptick in brazen assaults (4-5 in the last 2 weeks) – everything from bodily injury to battery to great bodily injury. They attended an event where they got good information on children on the autism spectrum and believe it will be helpful in some cases.

- D) **County Counsel** – (no comments)
- E) **SLOCOE** – (Karen Donaghe & Katherine Aaron) They just got through the Loma Vista graduation. The Special Ed and Court Schools continue. They will be sending a link to a survey that they encourage the commissioners to fill-out. 98% of their staff was laid off as they will now be requiring dual credentials at Loma Vista.
- They too are seeing serious violence, and have “all hands on deck” to handle it, and have had planning meetings with agencies. Staff is excited about the impact PBIS is having on the social/emotional learning.
- F) **Law Enforcement** – (Aaron Nix) The GREAT Camps are getting ready to kick-off. They are all fully booked.
- The RAVE app is up and running Countywide. Active Shooter training is going annually and is multi-jurisdictional. They are going for training all officers in the County.
- G) **Superior Court** – (no comments)

PRESENTATION: Strategic Planning

Bylaws: A review of our bylaws and the related WIC sections is desirable. Kayla will call Anne Duggan (our County Counsel); Kayla will send out the current Bylaws to all commissioners and to Maria.

Inspections: We need to look at our protocols for inspections; how do we review them consistently. We need to find a way to insure that no less than two commissioners are at each inspection.

New Commissioner Training: The CA Board of Corrections has a training for Juvenile Justice Commissioners; it was suggested that we look into that for all commissioners as well as new ones.

Youth Commissioners: continue seeking

Goals / Objectives / Ethics: After Bylaws and WIC review we should look at our goals and objectives. Commissioners were reminded to get themselves current on ethics training.

COMMITTEE / COMMISSIONER REPORT

- A) **Legislation** – (Jim Salio) AB 1214 is being completed – this would change the 602 statute so that no minor under 12 years could be filed as a 602. They are seeking exclusions so that the most violent offenses could still be filed.
- There is a bill in the second house with \$150 Billion to run prevention programs.
