- E) **SLOCOE** – (Karen Donaghe & Katherine Aaron) A final revision of the ALCAP was sent to the CE on September 12. An update on the results will be given at the next JJC / DPC meeting.

A new study hall was put in place in Court School; so far the program is a success. Student enrollment at Loma Vista is in the 90's, attendance is at 75-76 percent, Comprehensive High School is in the 90's as well.

- G) **Behavioral Health** – School is back in session and the Behavioral Health Department has their Health Intervention and Mental Health staff on Campus ready to assist. Cal Poly University will begin Thursday, September 20.

The Suicide Prevention Awareness Train the Trainer position has been filled. The Suicide Prevention Awareness Forum will be held on October 17 from 5:00 - 8:00 pm at Cuesta College Campus. This is a free forum. There will be a Suicide Prevention Walk at Mission Plaza on October 13.

Superior Court – (Judge Crandall) is working on a project to get Close Graduate Educational Services at the Juvenile Center. An update will be given at the next JJC – DPC meeting.

COMMITTEE / COMMISSIONER REPORT

- A) **Legislation** – (Jim Salio)

SB439 This bill would modify the ages that a person must be to fall within the jurisdiction of the juvenile court or adjudged a ward of the court under these circumstances to between 12 years of age and 17 years of age, inclusive, except that any minor who is under 12 years of age when he or she is alleged to have committed murder or rape, sodomy, oral copulation, or sexual penetration by force, violence, or threat of great bodily harm would still be within the jurisdiction of the juvenile court and may be adjudged a ward of the court. The bill was amended; currently the amendments include rape, sodomy, oral copulation, or sexual penetration by force. CPOC is opposing this bill.

SB1391- Changes the age from 14 to 16 that a Juvenile can be transferred to the Adult court for a 707b offense. CPOC has a neutral opposition on this bill.

AB 1214 This set the time limits for Juvenile Competency Restoration in the Juvenile Court. This would set a one-year time frame for a felony.

B) **Children's Services Network** – (Kayla Plourde) SLO County Human Trafficking Summit is scheduled for September 15, 2018 from 8:30 am- 2:00 pm.

C) **Truancy Board Meeting** – (Amalia Plemons) Next meeting will take place sometime in November.
