SUBJECT:	Ongoing Update: Mid-Higuera Bypass Project					

<u>Update</u>

- Grant Funding Applications
 - CNRA Grant (\$6,000,000): In February, the City presented a virtual tour of the project site, its benefits, and scope to CNRA as a part of step 2 of the grant application process. This allowed CNRA to ask detailed questions regarding the project, in preparation of further review from the grant committee. We expect to hear back in early summer (May/June) if the project is proceeding to step 3.
 - DWR Grant (\$6,078,707): The City submitted this grant in November 2020, and has yet to hear back from the grant committee. An update from DWR is expected in April/May.
- Project Design
 - Wallace Group is reviewing the City's comments on the 90% on plans, specifications, and estimates and making additional revisions.
 - Details that remain to be finalized include: permitting, Utility B letters, final project report (HEC-RAS)
 - City staff are preparing for negotiations with impacted properties (Madonna Properties & Todd R. Family Trust).
- Environmental
 - Draft Biological Agreement (BA) for steelhead: Rincon Consultants has prepared a Draft BA for steelhead and provided it to Public Works Environmental (PW Env) on 3/17. The Draft BA is currently under review by PW Env staff and is a required attachment for the permits.
 - Programmatic Biological Opinion for CA red legged frog (CRLF): PW Env staff is reviewing the Army Corps of Engineers existing Programmatic Biological Opinion for CRLF to determine if this agreement document can be used in support of the project. If no, a BA for CRLF would need to be prepared by PW Env staff.
 - Impact Calculations: Wallace Group has provided finalized Impact Area Calculations and plans. These calculations help determine permit fees, restoration ratios, and are an integral part of the permit applications. Permit applications are underway by PW Env.
 - Diversion & Dewatering Plan (DDP): It has been determined that the DDP is a Wallace Group task, and a request has been made to Wallace Group to prepare a report style DDP from existing D/D schematics that are shown in the design plans.

 Habitat Mitigation Monitoring Plan (HMMP): The HMMP draft is currently being prepared by PW Env staff. PW Env staff are coordinating in-house, appropriately timed botanical surveys of the project area to determine existing baseline conditions for vegetation. Botanical surveys conducted in support of the project's Environmental Impact Report are 10+ years old. Surveys will be conducted as soon as possible.

SUBJECT: Ongoing Update: Creek Maintenance

<u>Update</u>

The City has been active in reviewing the creeks and identifying where debris jams has accumulated. The City has worked on 4 or 5 debris jams in the mainstem SLO Creek upstream of Los Osos Valley Road and there is a major one in Prefumo Creek right behind Vista Lago Park that the City tried to cut a channel through, but it is mostly all little floating sticks etc that accumulated along a 50-foot section of the creek. It is a total barrier to fish and the City Biologist will work with Public Works as we will be doing silt removal at this location again this year in October so it will be removed. Dead and down trees have been removed from the creeks in various locations and follow-up surveys have been completed to ensure everything is clean. I plan to focus on Prefumo Creek in the next year above and below Laguna Lake due to the near miss we had with the Atmospheric River.

The City has funding for goats to be deployed in the creek as well for the next fiscal year, so we are working on updating our CDFW permit right now too.

<u>Update</u>

The consultant, Schaaf and Wheeler, is currently completing the existing conditions assessment and has set up a preliminary model based on data provided by the County and the City. Surveying has been completed for all cross sections and bridges/culverts located in the public right-of-way. County staff will be contacting property owners to secure right-of-entry permits to complete surveying of the East Fork on private property where necessary for model development.
