Prop 1 Round 2 Implementation Grant



DWR Workshop May 6th, 2021

- Grant schedule is subject to change pending potential drought funding in state budget
- 2 deadlines March 2022 or September 2022, each funding area/region will choose preferred deadline
 - SLO IRWM Region targeting September 2022
- Awards for March deadline expected by Summer 2022
- Might have heavier drought emphasis than Round 1
- DWR will hold optional individual meetings with applicants to answer questions and provide feedback
- GSAs will be eligible to receive funding for Groundwater management



Expectations

- SLO RWMG will follow project selection process in 2019 IRWM Plan
 - Section 6.4
- Selection criteria to be based on DWR scoring criteria
 - RWMG will confirm
- RWMG Working Group to be created for project selection recommendation to RWMG, WRAC, then to BOS
- All agencies with a proposed project must have adopted the 2019 IRWM Plan



RESOLUTION ADOPTING THE 2019 SAN LUIS OBISPO COUNTY INTEGRATED REGIONAL WATER MANAGEMENT PLAN AND FINDING THAT THE PROJECT IS EXEMPT FROM SECTION 21000 ET SEQ. OF THE CALIFORNIA PUBLIC RESOURCES CODE (CEQA)

RESOLUTION NO.

The following Resolution is hereby offered and read:

WHEREAS, the State of California has established an Integrated Regional Water Management grant program pursuant to the Water Quality, Supply, and Infrastructure Improvement Act of 2014 (Vater Code Section 79700 et sea) (also known as "Proposition 1"); and

WHEREAS, a Memorandum of Understanding (Attachment "1"), which has been signed by the agencies listed in Attachment "2" and who constitute the Regional Water Management Group for the San Luis Obispo County Region as of the date of this Resolution, designates the San Luis Obispo County Flood Control and Water Conservation District as the lead agency responsible for plan development and adoption but also provides for the adoption of the plan by each member of the Regional Water Management Group; and

WHEREAS, the concepts, direction and approach to water resources management embodied in the State's Integrated Regional Water Management program guidelines closely match those of the [INSERT AGENCYORGANIZATION NAME HERE], and


2.1 Arroyo Grande Area

Community Characteristics

The City of Arroyo Grande is one of the seven incorporated cities located in the County of San Luis Obispo. Arroyo Grande is the largest of the "Five Cities" communities. It is bordered by Pismo Beach and Grover City on the west and northwest, and agricultural or rural residential lands on the north, east, and south.²⁶ Rancho Arroyo Grande, a Mexican land grant, became the political township of Arroyo Grande in 1862 and was incorporated in 1911.²⁷

- Arroyo Grande includes three disadvantaged communities
- Village area (Block Group 60790118004)
- Fair Oaks area (Block Group 60790119025)
 Halcyon Road-Arroyo Grande Creek area (Block Group 60790119012).
