# Proposed Negative Declarations

A Negative Declaration is issued for projects that would not result in significant effects on the environment. In many cases, the project applicant has added mitigation measures to the project to reduce environmental impacts in order to qualify for a Negative Declaration. If you disagree with the issuance of a proposed Negative Declaration, you may provide comments or file a Request for Review (appeal) of the Negative Declaration. Requests for Review must be filed within two weeks of the date that the proposed Negative Declaration is posted and must address only environmental issues. There is a fee for the request. #### Paso Robles Area

A request by Daniel Daou for a Minor Use Permit to allow an increase to the case production at an existing winery from 10,000 cases per year to 100,000 cases. Implementation of the proposed increase to case production will not result in any site disturbance on the approximate 117 acre parcel because the existing Waste Water System can accommodate the proposed increase to production. The proposed Minor Use Permit is to authorize the existing winery to increase their wine case production to full capacity. The applicant is not requesting a tasting room or any special events at this location. The proposed project is within the Agriculture land use category and is located at 2740 Hidden Mountain Road, Paso Robles, CA 93446, approximately 3.5 miles west of the City of Paso Robles. The site is in the Adelaida Sub Area of the North County planning area. DRC2016-00042 (ED16-213)

#### Paso Robles Area

Request by Brian Brown for a Minor Use Permit to allow the construction of a 10,085 square foot (sf) winery production and storage facility which includes a 417 sf public tasting room. Also proposed are driveway improvements, parking, and other related improvements. A modification is requested to reduce the required 200-foot setback from property lines for a winery with public tasting room to 103 feet (north), 12 feet (east), and 178 feet from west property lines. The project also includes a request to modify the required 400-foot setback distance to 277 feet from the nearest off-site residence. The project will result in

1.86 acres of disturbance on a 12.25-acre parcel. The proposed project is located on the north side of Vineyard Drive, one mile west of Highway 46 West, three miles west of the community of Templeton. The site is within the North County Planning Area, Adelaida sub-area and is located in the Agriculture land use category. Project location is 4060 Vineyard Drive, Paso Robles, CA 93446. DRC2016-00003 (ED16-084).
