Meeting Guidelines

To keep the meetings focused and productive, they will be conducted in accordance with the following guidelines:

1. There is a common understanding that

- The Paso Robles Groundwater Basin (Basin) is an essential agricultural, environmental, and human resource.¹

- Studies have shown there are declines in groundwater levels in some areas of the Basin.

- Committee members are committed to effectively managing this resource and implementing solutions to stabilize or improve groundwater levels.

- The strategies needed to protect this resource are diverse and will likely entail costs and/or sacrifices by the stakeholders.

- These costs and/or sacrifices should be equitably borne by the stakeholders.

2. Conversation will be focused on solutions, with the prioritized list of solutions approved by the Blue Ribbon Committee as the basic foundation and starting point, and will therefore not include:

- A review or rehash of past failures

- Discussion about the past actions or character of any individual community member in relation to the water issue

September 09, 2015 Draft Meeting Minutes

Approximately 2:00 pm the meeting is called to order.

- 1. Introductions and determination of a Quorum- Quorum established.
- <u>Approve August 20th Meeting Minutes</u> The August 20th Paso Basin Advisory Committee (PBAC) meeting minutes were reviewed. Alternate Member Friedman expresses her concerns about accurate reflection of the public comment section of the minutes. Alternate Member Friedman moves to amend the August 20th minutes, seconded by none. Alternate Member Friedman requests that her failed motion to amend the minutes be mentioned in the minutes. Member McKinley moves to approve the August 20th minutes, seconded by Member Cunha. (12-1-6-5).
- 3. General Public Comment Member Sinton discusses the no-export ordinance, a potential concern by City of SLO, and suggests language revision. Alternate Member Friedman discusses the article by Supervisor Mecham and suggests adding an item to the future agenda to discuss solutions mentioned in the article. Member Luft responds by suggesting the In-Basin Subcommittee take up the action of reviewing said solutions. Member Werner reminds the committee that such a process had already been done two years prior and a list of 25 vetted solutions were presented to the Board of Supervisors (BOS). Alternate Member Friedman suggests voting members of the PBAC disclose any conflict of interest prior to voting. Greg Grewal expresses his concern about the August 20th PBAC minutes not accurately reflecting what took place and his concern about the no-export clause. Courtney Howard, County Public Works, introduces Carolyn Berg, County Public Works as the new PBAC Secretary, and explains the staff and roles of the new Water Resources Division. The committee and audience expresses their appreciation of Courtney Howard and her efforts, and she does the same for the efforts of the committee. Member McKinley clarifies the sources of treatment plant water and export out of the basin.
- 4. County Efforts
 - a. <u>Water District Application Review Process Update</u> John Diodati, County Public Works, gives an update of the LAFCO meeting on August 20th and the status of the application. He states: (a) That the item was continued to September 17th at 9 am in the BOS Chambers; (b) That exclusion requests will be accepted until August 28th; (c) That the water district will not have the power to export, with

language crafted by David Church, LAFCO Executive Director; (d) That the County is preparing for the conclusion of LAFCO proceedings and getting ready for a formation vote, as well as Prop 218 process, on November 10th; (e) That the election vote will take place on March 8th, 2016; (f) Flood Control District will propose local funding for SGMA compliance on November 10th; (g) That Prop 218 will create a Zone of Benefit, approved by the BOS; (h) That ballots should be available on February 8th.

A question regarding the basin boundary is posed, and John Diodati replies that LAFCO is considering the Fugro Boundary. Discussion ensues on potential outcomes of Prop 218 voting, and potential boundary revisions. A question is posed regarding choosing the basin boundary, and Mr. Diodati responds that at this time, the County has not been directed to submit a basin boundary revision. Discussion ensues on inclusion of the Heritage Ranch in the different basin boundary guidelines are only in draft form. Chair Luft notes that the staff report will be available on Thursday. Greg Grewal questions the ability of LAFCO to use a non-DWR-approved boundary, and Mr. Diodati responds that it is within LAFCO's authority to do so. A discussion ensues regarding the text of the Prop 218 ballot and the clarity of items to be voted on, as well as future annexations.

- b. Countywide Water Conservation Program Development Update Mike Hanebutt, County Planning and Building, announces two meetings: (1) October 6th is when the program is formally introduced; (2) October 27th is the full hearing where staff will have a presentation with public comment. Mr. Hanebutt announces a soon-to-come press release and other outreach opportunities. Mr. Hanebutt reiterates, from the August PBAC Meeting, that Planning Commission comments and the EIR are now online. Alternate Member Friedman asks for clarification on the removal of the Courtesy Notice, and Mr. Hanebutt explains that the notice is for a ministerial process, not discretionary. Member Kalvans expresses appreciation for accepting his comments. Member Kalvans also inquires about new plantings since the expiration of the urgency ordinance, and Mr. Hanebutt states that there have not been reports as of now. A discussion ensues on the logistics of reporting new plantings and the issue of "pitting neighbor against neighbor", with Mr. Hanebutt noting that staff resources are limited. Courtney Howard mentions that the County Ag Commissioner would be a resource for irrigated agriculture information. Greg Grewal inquires about good neighbors who are not planting and are dry farming. A question is posed about property changing hands, and Mr. Hanebutt confirms there are no restrictions in place to stop planting in such a situation and no permits are needed. Chair Luft asks the Management Subcommittee to take another look at the PBAC comments and revised language online.
- c. <u>Consider advising the Board of Supervisors regarding County efforts –</u> Chair Luft states that no action items have been brought forward.
- 5. Subcommittee Reports/ Recommended PBAC Actions

- a. <u>Computer Model Update</u>- Courtney Howard states that the calibration process should be complete within 1-2 weeks, with the Model Update Subcommittee to meet at the end September or beginning of October. She also states that the model should be presented at the October PBAC meeting.
- b. <u>Conservation</u>- Member Best gives an update of the Conservation Subcommittee meeting and states that more information should be available in early 2016.
- c. <u>In-Basin Projects</u>- Member Werner gives an update of the previous In-Basin Subcommittee meeting: Christine Halley gave an update of the wastewater treatment plant and discussed options for supplemental water. Alternate Member Gage gave an update on the USDA retention basin program and the associated convoluted paperwork process. An update was given on the Paso water treatment plant, which is close to being fully operational and has batch tests underway, with the first year of operation being under warranty. Member Werner notes the importance of the treated water. An update is given on the success of the Naci Recovery Well, and it is noted that the new AMWC well levels are increasing and that three shallow wells have been activated. Progress on water conservation by the City of Paso is also noted.

Alternate Member Friedman suggests involving Congresswoman Capps to expedite the lengthy paperwork process of the USDA retention basin program, and discussion ensues on the difficulty of expediting such a process. Member Frost questions funding of the tertiary wastewater treatment facility.

d. Management- Member Brown gives an update of the Management Subcommittee meeting. The subcommittee invited Atascadero Mutual Water Company (AMWC) and Templeton Community Services District (TCSD) to attend and discussed the Atascadero Sub-basin and Sustainable Groundwater Management Act (SGMA) compliance. GEI Consultants are drafting a Groundwater Sustainability Plan (GSP). Member Briltz discusses the staged approach to drafting a GSP, with public comment and an informational brochure to come this fall, as well as regular team updates and coordination. Member McKinley states that currently the focus for the City is getting water, not pushing to form a Groundwater Sustainability Agency (GSA). Member Brown discusses the cost impact of SGMA. The subcommittee agrees to table the no-export ban language and address that topic at a later date. John Diodati's comments spoke to cost distribution for rural residents. Member Brown further discusses shared powers of the County and the Paso Basin Water District. Member Kalvans inquires why the San Miguel CSD was not invited to that meeting, Member Brown states that the discussion was regarding the Atascadero Sub-basin. Member Kalvans states that San Miguel CSD would like to "go their own way" in the formation of a GSA. Greg Grewal questions the costs for the GSP. Paso City Councilmember Strong comments on the previous objections to Prop 218 which cost \$3 million in delays.

- e. <u>Outreach and Education</u>- The Outreach and Education Subcommittee elected not to meet last month.
- f. <u>Supply Options</u>- Member Briltz gives an update on the Supply Options Subcommittee and announces a meeting next Friday, September 19th. Member Merrill discusses his desire to see an increase in public relations efforts, as well as the need to move ahead with feasibility analysis of projects to tell voters what's possible. Alternate Member Friedman inquires if the PBAC can recommend that the BOS use Flood Control District reserve funds to pay for such analysis. Member McKinley states that Paso is interested in regional solutions, that the tertiary plant is designed for 4 MGD, and that they are quickly pursuing Prop 1 funding.
- 6. <u>Nacimiento Project Water Delivery Entitlement Contracts Update</u> Carolyn Berg states that so far, the Flood Control District has not received any requests from the participants. Members McKinley and Briltz state that they have been in continuous dialogue with County Staff but have had some challenges and delays. There is a new conceptual allocation without an allocation to the FCD. They state that they met with staff and the participants are set to proceed with allocation on a pro-rated basis, with CSA 10 potentially receiving 16 AFY, TCSD receiving 158 AFY, and so on. It is noted that this process is the surest and fasted way for Nacimiento Water to help the groundwater basin because the water can be declared surplus and sold. A discussion ensues on what is left for the Paso Basin Water District, and on the surplus water. Alternate Member Friedman asks why the FCD/County cannot discount the project with reserve funds. Paso City Councilmember Strong states that it is against the law to make a gift of public funds and it is not the water that costs money, it is the infrastructure to distribute it. Greg Grewal states that the overliers have the primary water right, not the water purveyors. Member Kalvans inquires about a regional water treatment plant, and Member Briltz says that each participant uses water differently.
- 7. Discuss concerns associated with drilling deep wells in the Paso Basin Rich Lichtenfels, County Environmental Health, discusses the unprecedented number of well drilling applications being submitted in the last few years. Mr. Lichtenfels discusses the issues of deep well drilling in the Paso Basin, such a deep well intersecting multiple aquifers and degrading water quality. He also discusses the Koda well in Creston and the associated water quality impacts. A member of the public inquires about drilling additional wells. Chair Luft inquires about location of screened intervals, and Mr. Lichtenfels states that drillings must work with a certified geologist. Alternate Member Cunha discusses the use of e-logs in drilling, and Mr. Lichtenfels talks about the seals in a recently drilled 1500 foot well. Chair Luft comments on the lack of "safe yield" for these deeper zones. Alternate Member Baugh and Mr. Lichtenfels discuss the lack of recharge of the older water in lower aquifers. Member Clark asks about well permits moving from ministerial to discretionary, and Mr. Lichtenfels states that permits may move in that direction.

8. Update on Proposition 1 grant funding and consideration of recommendation to request County pursue the "Counties with Stressed Basins" solicitation for the Paso Basin (attachment) – Alternate Member Cunha moves to extend the meeting by 10 minutes, seconded by Member Tracy (20-0-0-4). Carolyn Berg presents updates on the Prop 1 funding. She notes there is \$100 million available for Sustainable Groundwater Planning Grant Program, 10% of which is designated for Severely Disadvantaged Communities, with a 50% cost share requirement. Funding is prioritized for the best projects, doing the most public good, in high/medium priority basins, using new and innovative practices. Projects and proposals must enhance sustainable management of groundwater. She notes that funding is not available for adjudicated basins. Regional projects that are part of an IRWM plan are excluded and there are various compliance requirements for project proposals. Ms. Berg discusses the "Counties with Stressed Basins" funding, which consists of \$10 million at 50% cost share and is designed to develop ordinances or plans to advance sustainable groundwater management. Ms. Berg notes that public comments are currently being accepted, assistance workshops will be in November 2015, application due dates have yet to be determined, and final awards will be announced in March 2016. Comments are due on either document by October 5th, 2015.

Questions are posed regarding comments from the PBAC to help the County with their efforts and the possibility of the County pursuing a grant for the Paso Basin. A comment is made that many partnerships are desirable in the eyes of the State. A member of the audience asks for clarification on a slide regarding exportation, and another asks for the slides to be posted to the website.

- <u>Consider rescheduling October meeting date if necessary</u> Chair Luft suggests a tentative replacement date contingent on the LAFCO proceedings. Member Kalvans moves to reschedule the PBAC meeting to October 22nd, if needed, seconded by Member Spencer (20-0-0-4).
- 10. <u>Public Comment</u> Paso City Councilmember Strong announces that DWR is organizing a conference at UC Davis on water for food security on October 5th/6th. He notes that the final chapter of the State Groundwater Update 2013 is now online, and that the water use efficiency website has now been updated. On Wed/Thurs of next week, the CA Water Commission is meeting on implementation of SGMA and the water storage investment program. Also, on Friday of next week, there will be a workshop on grant funds. A question is posed to Councilmember Strong on the future of recycled tertiary water use, and Councilmember Strong discusses a water element of the general plan and purple pipe distribution. Member Kalvans discusses water conservation and management in Japan. Carolyn Berg reminds the committee that the PBAC sunsets in March of 2016.
- 11. <u>Future meeting topics/Committee comments</u> Member Werner inquires about the water surface elevation trends and maps, and Courtney Howard notes the County updates the hydrographs every April and that staff has not received direction to update the maps as of yet.
- 12. <u>Adjourn</u>- Meeting adjourned approximately 4:10 pm.

On September 17, 2015 the Local Agency Formation Commission (LAFCO) approved the Water District application, with all requested powers (the emergency ordinance power was amended by the State Legislature). However, LAFCO did condition that the Water District would not have the ability to export groundwater out of the Water District boundary.

On October 6, 2015 the Board of Supervisors, acting as the board of the Flood Control and Water Conservation District, will notice their intent to hold public hearings on November 10, 2015 in order to form a Zone of Benefit (Zone 19) which will allow the County to proceed with the funding, formation and Board of Director votes that are necessary to determine if the Water District will be created. The election day for these decisions is anticipated to be March 8, 2016.

The Department of Water Resources (DWR) released the draft Guidelines related to the \$100million Proposition 1 Sustainable Groundwater (SGWP) Grant Program. The SWGP Grant Program is designed to encourage sustainable management of groundwater resources by providing funding for projects that support sustainable groundwater management planning and implementation. DWR also published the first round of grant funding draft Proposal Solicitation Package (PSP) for Counties with Stressed Basins. The draft PSPs work in conjunction with the Guidelines to disburse Proposition 1 SGWP funds (\$10-million) made available to Counties with stressed groundwater basins to do the following:

- Update or develop County groundwater ordinances to improve sustainable management of groundwater.
- Update or develop plans that protect basins and their beneficial uses and help facilitate basin-wide sustainable groundwater management or actions that will lead to the update or development of such plans.

DWR Staff held public comment workshops during the last week of September, and collected written comments through October 5, 2015. DWR anticipates releasing the final Guidelines and PSPs in October. County proposals are expected to be due in November 2015, and final awards will be published in early 2016.

1. Carolyn Berg gave an update on the Prop 1 grant opportunities and how they could apply to our basin. SLO County could potentially acquire grant(s) up to \$250,000 in matching funds. The emphasis of the program is to support GSA and GSP creation. They could be used to fill data gaps.

The grants will be awarded in February 2016 and must be completed by 12/31/17. Carolyn and her staff have a very short window to prepare their proposal. About a month. They need to aim their efforts at all 5 of the stressed basins in the County.

A pilot study that could be replicated in the other 4 SLO basins would be a good approach.

We discussed various ideas from our Priority list of solutions and projects that came from our Blue Ribbon Committee. (See attached list). We decided that projects to slow or detain runoff to recharge the basin would give the greatest return for the efforts. We want to create a study to define the best areas in the basin for capturing runoff with the highest potential for water infiltration back into the groundwater. We want to fund exploratory efforts to document these areas. This geophysical analysis could include drilling cores, seismic survey or other ground trothing efforts.

We unanimously passed a resolution to the PBAC to support Carolyn in these efforts. Please see attached.

2. The minutes from the September meeting were reviewed and were accepted unanimously.

In-Basin Committee Recommendations October 1, 2015

At the In-Basin Committee meeting of October 1, 2015 the committee unanimously voted to:

Recommend that the PBAC request that the County follow DWR's draft guidelines with the intent of pursuing a grant application for "stressed basins" and work with PBAC on developing the scope of work

Specifically:

Prepare a Feasibility Study to analyze opportunities to increase water infiltration by defining where best to implement retention, recharge and infiltration projects. This would be a study that could be replicated in the other County basins and in partnership with local agencies such as RCD.

The Study would analyze opportunities for both in stream- HuerHuero Creek and the Estrella River as well as other Catchment Basins in the Paso Basin

The Study would:

Identify opportunities and constraints utilizing the following approaches:

- o Review topography to identify general areas
- Narrow down to practical areas
- Perform core samples
- Potentially perform seismic analysis
- Potentially use ground penetrating radar
- Calculate potential quantity of aquifer recharge.
- o Determine potential effectiveness
- o Identify any data gaps
- Determine the permitting and regulatory process
- o Determine potential incentives for landowners to cooperate
- o Identify strategies to engage stakeholders in cooperation

This is a discrete and defined project to generate long term projects to enhance the basin.

- 2. <u>Approve September Management Subcommittee Notes</u>: Subcommittee Member Cunha moved to approve August 31, 2015 meeting notes; seconded by Member Frost; passed unanimously with abstention by Member Clark.
- 3. <u>Water District Formation Update</u>: A consent item will be on the BoS agenda on October 6th to announce a hearing for November 10th, which will include consideration of establishment of a zone of benefit (Zone 19) for the Paso Basin, to allow the Flood Control District to manage the basin if the water district formation vote fails. The boundaries are proposed to be the basin boundaries as adopted by LAFCO.

4. <u>Discuss and consider transition plan for specific powers that may transfer from the County to the Paso Basin Water District</u>: As a related item, John Diodati described the process for the water district to obtain revenue if the parcel tax is approved. After the meeting, he verified some items via email. Items for the FY 16/17 tax roll have to be submitted by 8/10/16. Tax bills are due 12/16 and 4/17. The Auditor will transfer funds as they come in. Typically half are paid in December and half in April, but some people do pay in full in December. Since the FCD is sponsoring the parcel tax, funds will be transferred to the FCD and then by contract, to the water district. This means the water district would not have any funds until December at the earliest. If the water district wants to meet and spend money prior to December, either a line of credit from a local bank or a loan from the County FCD would be needed to get through until December revenue starts coming in.

LAFCO outlined seven powers that may need County approval before transitioning to the water district. The transition process, as outlined in the LAFCO application, may include a resolution from the water district board, consideration by the County BoS/FCD, and adoption of a resolution by the BoS/FCD. A one-time agreement would be used to transfer these powers. These powers include the power to adopt ordinances, collect data and conduct studies, prepare or receive annual reports, prepare groundwater management plans, issue new well permits, and exercise groundwater management needed to improve the basin. Most of these powers were considered by the subcommittee to be logical for the water district to request at the start. The power to issue new well permits was discussed at length, in light of the potential for well permit applications to become discretionary at some point. This power would probably not be requested until the Groundwater Sustainability Plan was developed. A model might be Paso, where the permit issued by the City is discretionary (although it is now subject to a moratorium by the City) and the County permit is ministerial (verification of sanitary seal, etc.).

The subcommittee reviewed an emailed question from Member Harvey, who was unable to attend the meeting. The Water Code section (10723(c)(1)) in question - which appears to allow the governing board of a special act district to make findings to assume authorities regardless of the authorizing act - did not appear to the subcommittee to be applicable to the Paso Basin Water District, since is not a "special act district" under the Water Code. A special act district is formed by the legislature without LAFCO review and a vote of the affected landowners/residents.

5. <u>Verification of the final ag offset language in Title 22</u>: Member Frost and other subcommittee members confirmed that the revisions which were requested by the PBAC in their July 17, 2015 letter have been incorporated into the language which will be considered by the BoS on October 27, 2015. Member Luft suggested some language for the PBAC to consider in a letter of support to the BoS. With modifications, Member Frost moved; seconded by Member Clark; passed unanimously to request the PBAC approve the following language:
