7. BAC Business & Discussion

A. <u>Las Flores Bike Lanes</u>

Discussion: Las Flores was recently overlayed. The road width is approximately 36' feet wide with plan for two 12' foot travel lanes and two 6' bike lanes on each side. Public Works has proposed the installation of class II bike lanes and has been approved by the Board of Supervisors through the County Bikeways Plan. Letters to the residents on Las Flores have been sent out to notify the proposed installation of the Class II bike lanes.

Staff Recommendation: Public Works recommends the installation of the Class II Bike Lanes on South Las Flores between Tefft and Division.

B. County Bikeway Ranking

Discussion: The County Bikeway Plan adopted a 500-point ranking system for both proposed Class I and Class II bikeways. The County Bikeways Advisory Committee periodically reviews the ranking and updates if desired. Members have expressed a desire to review the current rankings. Public Works staff has reviewed the existing ranking methodology and determined that it could benefit from additional points for safety.

- Price Canyon Road: Project Completion is currently expected by end of 2017
- Main/US 101 Interchange: Scoping phase with Caltrans is tentatively scheduled to be completed late 2017. Construction is tentatively not forecasted.
- <u>Bob Jones Trail</u>: NEPA documents have been submitted. County Parks and Recreation working on selecting a consulting firm to prepare construction documents and right of way exhibits. ATP grant application has been submitted.
- <u>Left turn lanes Octagon Barn, Higuera Project:</u> Project to add left turn lane and parking of octagonal barn is expected to begin construction September 2017.
- Morro Bay to Cayucos Connector: Currently in the process of NEPA and Construction documents to be finished by Cannon Associates firm.
- <u>Templeton to Atascadero Connector</u>: In process of finishing the NEPA documents. Right of way buy-in being planned. The construction documents will be developed by mid to late 2017. ATP grant application has been submitted.
- Main Street, Templeton Overlay: Overlay expected to be initiated in 2018 which incorporates proposed class II bike lanes.
