



### **Project Overview**

#### Site Requirements

- Soils /Geotech (Clay/rock)
  - Foundation design (caissons recommended)
  - Retaining Walls (sloping site)
  - Stormwater Control (low infiltration)

#### **Facility Requirements**

- Meet the Probation Department's needs for next 20 years
  - Two- Story, Fire Sprinklered, +/- 35,000 SF Building
  - B Occupancy (w/ A-3/S-2 spaces)
  - Not built to Essential Services standards
  - LEED Silver Standard (w/o Certification)
- SLO City Coordination Required
  - $\circ$  Utilities
  - Street Frontage Improvements
  - Fire Review

Preliminary Project Budget: \$20-30 Million




LOWER FLOOR PLAN

# **New Probation Department Building** Why Design-Build vs Design Bid Build

- Establish Collaborative Environment
- Allows for Creativity thru Design Competition
- Single Entity Responsible for Design/Construction
- Provide Best Value for Project and Builder
- Risk Management



# **New Probation Department Building** Design-Build Entity Selection Process

### **Two-Step Process:**

#### **1- Request for Statements of Qualifications (RSOQ)**

- Request for submittals from interested Design Build Entities (D-BE)
- Questionnaire and information on D-BE's experience, team structure, and financial capacity
- Interviews (at County's discretion)
- Top-3 ranked submitters invited to participate in the 2nd step (RFP)

### 2- Request for Proposals (RFP)

- o Confidential Meetings / Presentations
- o Issue Addenda to RFP
- o D-BE's provide proposal to design/construct the facility, incl. Enhancements
- Interviews / Presentations by D-BE's
- Selection / Award
- o \$25K stipend will be offered to the unsuccessful proposers
