In 2016, Community Action Partnership San Luis Obispo (CAPSLO), 5Cities Homeless Coalition (5CHC), and El Camino Homeless Organization (ECHO) were awarded funding for the Coordinated Entry Program (CEP) to provide a system of screening, diversion, and case management services to homeless individuals and families throughout the county. Together with county staff, the partners have developed an integrated system that prevents duplication of services and streamlines access to the most appropriate service provider to meet client needs. Since its inception in 2017, this collaborative program has served approximately 5,000 households. Through the CEP, each agency covers a different region of the county. CAPSLO focuses on serving the homeless population in and around the City of San Luis Obispo & Morro Bay/Los Osos. 5CHC operates in South County/Coast, and ECHO in the North County/Coast.

This program provides a foundation for prioritizing services for those who are unsheltered, have experienced homelessness the longest amount of time, and who have multiple and severe services needs that inhibit their ability to identify and secure housing on their own quickly. Each agency brings a wealth of expertise and a variety of services that address broader issues impacting housing stability, including medical, mental health, substance use, and employment challenges.

If a client qualifies for services within CAPSLO, ECHO or 5CHC, they will receive services to help them achieve stability, including help to find or maintain permanent housing. If they do not qualify each agency works with other providers and each other to ensure that these individuals are tablet to receive the needed services to end their experience of homelessness. Those with chronic issues may be assigned a case manager. The case manager will work with each client's household to develop an individualized case plan with short- and long-term goals ultimately leading to stable housing and increased economic stability. Services may include advocacy, self-sufficiency counseling, and linkages to needed community support services. Case managers will regularly evaluate client plans to ensure that the established goals remain a priority.

CES providers in SLO county provide outreach, shelter, navigation, and housing resources to those experiencing homelessness, although on a much smaller scale than the CES agencies. SLO County CES proposes to address its largest barrier – the bifurcation of the homeless services system and CES between CAPSLO, ECHO, and 5CHC and those agencies not part of the CES. In the grant year, these providers will bring in other providers into CES and will now provide a foundation for prioritizing services for those who are unsheltered, have experienced homelessness for the longest time, and have multiple and severe service needs that inhibit their ability to identify and secu

One example of sharing information is the HSOC meetings that all homeless service providers attend. Data is also distributed in person, over the phone, or through email. In addition, to reach those with the highest barriers to access, CAPSLO, 5 Cities Homeless Coalition, and ECHO staff visit locations that are frequented by the chronically homeless community,

including off-beat locations such as creek beds. Word-of-mouth among the population is a key aspect of outreach - case managers are sought out by those who need that assistance. Clients routinely drop in looking for assistance and resources.

Additionally, in the current grant year, this screening tool was adopted as the universal intake for all CES providers and added in questions that would allow agencies to determine a participant's eligibility for all housing programs, increasing efficiencies for all programs and making this process more client-centered.

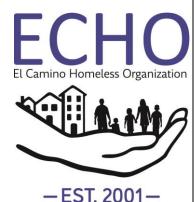
