1. Call to Order and Introductions	Mariam called the meeting to order.		
2. Public Comment	<p>George passed on a comment from Public Works that the Blue Bag program was not included in the 2021 County budget.</p> <p>Devin informed the group that there are plans to move the Safe Parking program from the Vets Hall to the Department of Social Services building on South Higuera Street. At present there are between 20-30 cars using the Safe Parking program overnight.</p>

<p>4.1. Discussion Item: Grant Updates</p> <p>4.1.1. Discussion Item: Homeless Emergency Assistance Program (HEAP)</p> <p>4.1.2. Discussion Item: Continuum of Care Grant</p>	<p>Laurel provided updates on the various grants.</p> <p>The County is working with ECHO (El Camino Homeless Organization) and the City of Paso Robles to find possible alternate sites for their HEAP-funded project. The situation should be clearer by the end of July, but it's possible some HEAP funds could be reallocated if ECHO feel they cannot spend it before the expenditure deadline. If this does happen, ECHO will most likely seek replacement funding under the HHAP program, which has a longer expenditure timeline.</p> <p>The HHAP funding has not yet been awarded, in part due to the impact of COVID. The 2019 CESH funds have not been allocated yet either. The County intends to release a joint RFP for HHAP and CESH, most likely in late summer after working with State TA (Technical Assistance) to look at planning and coordination around these funding programs, and opportunities to address long term needs, particularly in light of the new funding streams that have been made available. Laurel confirmed that the intent of the funding will continue to be what HSOC voted on.</p>		

	<p>The Committee discussed options for ECHO's HEAP-funded project, such as repurposing the HEAP funds to 5CHC (5Cities Homeless Coalition) who have projects ready to begin but are waiting on funding, and using HHAP funds for ECHO instead. HHAP funding has a much longer expenditure window, which would allow ECHO time to find an alternate site.</p> <p>Laurel noted that the Board of Supervisors would need to approve a change of this nature.</p> <p>Janna cautioned that ECHO is on the cusp of acquiring property and so if HEAP money was repurposed now, and they had to wait until late summer for the HHAP RFP, they could lose this acquisition.</p> <p>Laurel clarified that any HEAP funds not expended by June 30 2021 would have to be given back, but funds already spent would not be affected.</p> <p>The Committee discussed the impact of COVID on homelessness as a priority for the State, as prior to the pandemic, a number of new funding programs were announced. Laurel confirmed that homelessness is still a priority for the State, but given the financial impact of COVID, it seems unlikely that we will continue to see new funding streams in the next couple of years. Laurel confirmed</p>

	<p>that there is no indication of HHAP funds being reappropriated by the State.</p> <p>Mariam asked if the Blue Bag program, which is no longer being funded by the County, would be eligible for funding under one of these grant programs. Laurel confirmed that street outreach is an eligible activity under ESG, and trash pickup could potentially fall under this, though she has not seen similar programs funded through ESG before. Janna shared that 5CHC have an arrangement with the City of Grover Beach where the City are collecting trash from an encampment. The process is complicated and expertise would be more important than just having bags provided.</p> <p>Laurel shared that the HUD (US Department of Housing and Urban Development) audit of the CoC (Continuum of Care) grant which had been scheduled for this year will now not be happening, due to COVID. An audit is now expected early next year.</p>

Discussion Item: CARES (Coronavirus Aid, Relief, and</p>	<p>Laurel shared that the Board of Supervisors awarded HSOC's recommended funding under the five different grant programs at their June 16th meeting. These grant programs include the CDBG-CV (Community Development Block Grant – Coronavirus), Federal and State ESG-CV (Emergency</p>		

<p>Economic Security) Act grants and California COVID-19 Emergency Homelessness Funding</p> <p>4.2.2. Discussion Item: Coordination and planning</p>	<p>Solutions Grant – Coronavirus), COVID Emergency Homelessness Funding, and State ESG (Emergency Solutions Grant). The County is also due to receive nearly \$6.3 million under the second round of Federal ESG-CV. Permanent Housing is not an eligible use for this funding, but homelessness prevention, rapid rehousing, conversion and renovation are eligible. This funding will have an expenditure deadline of September 2021. Supervisor Gibson asked that HSOC undertake some planning activities before allocating this funding, and has asked County staff to look into the number of people who may become homeless based on available data.</p> <p>It is possible that the County may receive additional State ESG-CV funding, and that the State may receive second round funding for CDBG-CV, which may be available to Grover Beach as a non-entitlement jurisdiction.</p>		
<p>4.3. Discussion Item: 2021 Homeless Point in Time Count</p>	<p>Laurel explained that County staff are working on an RFP for a vendor for this work. It is too soon to tell what the COVID situation will be in January 2021 when the count will take place, but may require changes in how the count is done, e.g. providing masks.</p>
