#### **SUMMARY NARRATIVE:**

The U.S. Department of Housing and Urban Development (HUD) released the FY2019 CoC Program Funding Notice of Funding Availability (NOFA) on July 3, 2018. Per HUD's NOFA, the San Luis Obispo County CoC is eligible to apply for \$939,693 to renew existing CoC projects, \$115,568 for new bonus projects or expansion of existing renewal projects, and \$140,196 for new Domestic Violence (DV) Bonus projects.

The County released a local Request for Proposals for project applications on July 12, 2019 and held an informational meeting on July 12, 2019 where County staff met with potential project applicants to explain the grant application process and project quality criteria. The local rating criteria, which was published to the County's Homeless Services website on July 12, 2019, is based on HUD's application evaluation criteria and point system in the FY2019 HUD NOFA.

An Ad Hoc Grant Review Committee (Grant Review Committee) met on August 6, 2019. Laurel Weir from Department of Social Services attended to guide the discussion. Six applications were submitted for ranking, including five renewal applications and one bonus funding application. Two additional renewal-consolidation applications were submitted, however they are not competitive and therefore are not ranked among the other applications. If HUD accepts the renewal-consolidation projects, they will assume a ranking position associated with the original renewal projects to which they are tied. The Planning Project is also non-competitive, and is allocated based on the CoC's total award from HUD.

#### **Funding Availability and Project Ranking**

As CoC funding availability continues to be highly competitive, HUD requires that CoCs rank applications based on funding priority using a two-tier ranking system. Tier 1 is guaranteed to be awarded to the CoC and equals 94% of the CoC's Annual Renewal Demand (ARD), or amount of funding needed to renew all existing CoC projects. Tier 2 consists of the remaining 6% of the ARD, and any Bonus or DV Bonus projects. Projects ranked in Tier 2 are subject to the National CoC Competition, and therefore are not guaranteed to the CoC. Any project that is partially funded by Tier 1 is considered a "Straddling Project." Straddling Projects may be

funded up to the amount available in Tier 1, with the Tier 2 portion of the project subject to the National CoC Competition. FY2019 CoC funding amounts available to the San Luis Obispo County CoC are listed below:

#### **Project Review Criteria**

HUD continues to encourage CoCs to use performance data and measures to rank and review existing CoC projects. The local application review criteria considered factors such as a subrecipient's past performance, project cost efficiency, severity of needs served, financial capacity, returns to homelessness, housing first policies, client income stability, client housing retention, HMIS data quality, and consistency with local HSOC priorities and plans. An analysis of cost efficiency was provided to the Grant Review Committee regarding each project's cost per client for Permanent Supportive Housing (PSH) and Coordinated Entry projects. In addition, the Grant Review Committee was also provided performance measures derived from HMIS data and Annual Performance Reports for each of the renewal projects. The Bonus application was rated based on severity of needs served and subrecipient performance in project type.

The Grant Review Committee ranked all submitted applications based on their local application review criteria scores. The Coordinated Entry Project and Permanent Supportive Housing renewal projects with existing clients were placed into Tier 1. Coordinated Entry is now a mandatory federal component for Continuum of Care jurisdictions and its associated CoC and Emergency Solutions Grant (ESG) projects. The Central Coast Permanent Supportive Housing (PSH) project, San Luis Obispo City PSH project, and Bordeaux Expansion PSH project applications by Transitions Mental Health Association (TMHA) were ranked within the Tier 1 category because they provide permanent housing and supportive services throughout the County and serve the most vulnerable clientele.

The committee recommends that the HMIS project be placed straddling Tier 1 and Tier 2 to ensure the other renewal projects maintain their level of funding and operation. In the previous CoC competition, the project straddling Tier 1 and Tier 2 ended up receiving full funding, however, the project in Tier 2 is not without risk.

The CoC only received one Bonus funding application: an expansion of the SLO City PSH project, which would serve an additional seven clients. The Grant Review Committee ranked this Bonus project as number 1 in Tier 2. If the CoC is awarded any Bonus funds following the

National CoC Competition, the funds will be incorporated into the CoC's future ARD, increasing the County's baseline CoC funding.

The HSOC recommendation will go to the San Luis Obispo County Board of Supervisors as a consent item on September 10, 2019 for further action.

#### **BUDGET/FINANCIAL IMPACT:**

This will have no financial impact to the HSOC. Should HUD approve all the proposed projects, then CoC funding to the County will increase from \$979,997 to \$1,095,745.

ITEM: AUTHORIZE THE CONTINUUM OF CARE COORDINATED ENTRY SYSTEM TO MAKE PRIORITIZED CLIENT REFERRALS AND PROVIDE OTHER ASSISTANCE AS APPROPRIATE TO THE HOUSING AUTHORITY OF SAN LUIS OBISPO'S MAINSTREAM VOUCHER PROGRAM

#### **ACTION REQUIRED:**

Authorize the County of San Luis Obispo's Continuum of Care Coordinated Entry System to make prioritized client referrals and provide other assistance as appropriate to the Housing Authority if San Luis Obispo's (HASLO's) Mainstream Voucher Program, should HASLO's application for the vouchers be funded by the U.S. Department of Housing and Urban Development (HUD).

#### **SUMMARY NARRATIVE:**

On July 2, 2019, HUD published a Notice of Funding Availability for the Mainstream Voucher (MV) Program<sup>1</sup>. The MV Program provides new Housing Choice Vouchers to local Public Housing Authorities (PHA) to use to serve non-elderly persons with disabilities in community-based housing. The NOFA encourages PHAs to partner with local Continuum of Care Coordinated Entry Systems and other partners to refer people to the MV program and provide additional supports by providing additional points in the competition for those PHAs that can demonstrate such a partnership. Grant applications are due September 5, 2019.

The Housing Authority of San Luis Obispo (HASLO) will be applying for the grant and has requested that the San Luis Obispo County Continuum of Care (CoC) Coordinated Entry System (CES) agree to provide referrals to the program and other assistance as appropriate. Should HASLO receive the grant, HASLO proposes to prioritize the Mainstream Vouchers for non-elderly persons with disabilities who meet one of the following criteria: currently homeless persons, persons who are at risk of homelessness, persons who are formerly homeless and living in permanent supportive housing but who are ready to move into more

independent housing, and persons who are participating in Rapid Rehousing programs but who may need longer term housing subsidies in order to stay stably housed.

The San Luis Obispo CoC CES currently assesses chronically homeless persons and other homeless persons with significant housing barriers, using a standardized assessment tool and additional criteria such as length of time persons have been homeless, to make prioritized referrals to CoC-funded housing and other housing programs that accept CES prioritized referrals. These programs include the 70 Now Program and the Housing and Disability Advocacy Program.

It is requested that the Homeless Services Oversight Council (HSOC), as the CoC advisory body, authorize the San Luis Obispo County CoC CES to make prioritized referrals to the HASLO MV Program, should the program be funded by HUD. It is further requested that the CoC CES be authorized to provide the following to the HASLO MV Program:

- 1) Provide assistance with a timely transition to the unit through housing search or placement assistance or referrals to such assistance, as appropriate and allowed by existing funding or resources for such assistance; and
- 2) Provide assistance with or referrals to supportive services, including housing stabilization services, as appropriate and allowed by existing funding or resources for such assistance.

#### **BUDGET/FINANCIAL IMPACT:**

There is no financial impact to the HSOC.

#### **STAFF COMMENTS:**

Staff recommend that this item be adopted. Should HASLO receive the grant, it would increase housing resources for homeless persons and persons at risk. In addition to housing persons who are currently homeless, it could potentially open up beds in existing permanent supportive housing programs by allowing persons in those programs who are ready to live more independently to move out of those units.
