ORDINANCE NO. 3553

ORDINANCE AMENDING COUNTY FEE SCHEDULE TO UPDATE HEALTH AGENCY ENVIRONMENTAL HEALTH FEES

WHEREAS, the County of San Luis Obispo Health Agency's Environmental Health Services Division to has a need to amend the County Fee Schedule for FY 2025-26 to align with the Division's forecasted, FY 2025-26 salaries expenses; and

WHEREAS, the amended Fee Schedule will allocate forecasted Emergency Response Activities costs that are not recoverable through hourly billing, primarily to the Division's Hazardous Waste Program's permit fees; and

WHEREAS, County Staff has reviewed the fee recommendations and concurs with the recommended changes.

NOW THEREFORE, the Board of Supervisors of the County of San Luis Obispo, State of California, ordains as follows:

SECTION 1: The Board finds and determines:

a. That it has the authority to revise fee charges for providing any product, service, or enforcement of various regulations under the general laws of the State of California, including Government Code Sections 54985 et seq. and 66016 et seq.

b. The Board has adopted a policy (Resolution No. 75-396) requiring the County Administrator and the Auditor-Controller to annually review changes in fees and charges for specific County products, services and costs of enforcement with the departments making those charges, and make recommendations to this Board as to whether said charges should remain the same, be increased or be decreased.

c. On November 12, 2024, Ordinance No. 3520 was adopted establishing or reaffirming all county fees. Said ordinances, and any other ordinances subsequently adopted amending the fee schedule, shall continue in effect unless modified by this ordinance. All fees to be charged in Fiscal Year 2025-26 as set forth in Schedule "B" of this ordinance have been subject to review by the County Administrator and the County Auditor-Controller. All fees presented on Schedule "B" are attached and incorporated by reference herein.

d. The Auditor-Controller has certified to this Board that the overhead rates are calculated in accordance with accounting standards set by the Federal Government's Office of Management and Budget, in accordance with Circular A-87.

e. The fees and charges shown on Schedule "B" hereto reflect the Board approved charges

for providing any product or service, or the cost of enforcing any regulations, which are limited to those items included in the Federal Office of Management and Page 1 of 3 ATTACHMENT 2 Budget Circular A-87; provided, however, that fees for zoning and planning matters, including municipal and district organizational and re-organizational matters, as specified in Government Code Section 66016, do not exceed estimated reasonable costs of those services for which the fees are charged.

f. Capital facilities fees do not exceed actual construction costs as defined in Government Code Section 54999.1.

g. By definition, these charges are not a "tax" and are exempt from voter approval pursuant to California Constitution, Article XIII C. Section 1, paragraph (e)(1)[charge for specific benefit conferred]/(2)[charge for specific service provided]/(3)[charge for issuing license or performing inspection]/(4)[charge for use of government property]/(5)[fine or penalty imposed for violation of law] (Prop. 26).

h. Public Notice has been given in accordance with Government Code Section 66016 and 66018.

SECTION 2: The fee schedules are amended as follows:

a. That the fee changes attached and incorporated by reference herein shown on Schedule "B" as "Revisions" are hereby approved, and shall be effective November 20, 2025.

b. That the changes to footnotes attached and incorporated by reference herein shown on Schedule "B" are hereby approved, and shall be effective November 20, 2025.

SECTION 3: All departmental managers and divisional managers whose services are listed in Schedule "B" are hereby directed to, upon the dates specified in Section 2 above, amend their fees for services to reflect the fees shown in Schedule "B" as "Revised", including all additions or deletions.

SECTION 4: This ordinance shall take effect and be in full force and effect as set forth in Section 2 above; and before the expiration of fifteen (15) days after passage of this ordinance, it shall be published once with the names of the members of the Board of Supervisors voting for and against the ordinance in a newspaper of general circulation published in the County of San Luis Obispo, State of California.



1	An hourly rate is added for those that require more than the projected average number of staff hours. A minimum of 2 hours may be charged for plan check consultations and plan reviews for prepackaged incidental retail food sales or other incidental plan reviews that typically involve one field visit. It is also used when conducting CEQA related reviews for well construction permitting. The hourly rate can be added for mobile food commissaries and those facilities that require more than the projected average number of staff hours.
2	Move towards Board of Supervisors policy of full cost recovery.
3	Veterans with an honorable discharge operating a business in the incorporated and unincorporated areas of the county and subject to these fees will receive an exemption from health permits as authorized by the Business and Professions Code, Sections 16000 et seq.
4	Non-profit organizations with proof of non-profit status will receive an exemption from these Environmental Health Fees, for up to four events per year.
5	Non-profit organized camps are exempted from the fees in this program.
6	In addition to the County approved fee, an additional State surcharge is applicable and is subject to change after this publication.
7	A fee reduction equivalent to 1/2 hour of the BOS authorized hourly rate shall be applied when CUPA facilities are subject to two or more programs.
8	This fee will be charged at 1.5 times the hourly rate when work is performed during overtime conditions.
9	In addition to unscheduled reinspections, the hourly rate will be applied to facility/site inspections or other services where there is not an applicable health permit (i.e.: biosolids, unpermitted housing complaint site inspections, California Assembly Bill 1276 {2021-2022 session} enforcement, etc.). Planning and Building and/or Sheriff may collect the fee on behalf of Environmental Health Services for joint inspections/investigations or other unpermitted activities.
10	The CUPA may authorize a CalARP facility risk management plan audit in compliance with CCR, Title 19, Division 2, Chapter 4.5, Section 2775.2 and CUPA Policy P-04 to be conducted by the County's consultant. The fee is charged to the CalARP facility and passed through to the consultant.
11	Environmental Health may authorize a consultant to review and oversee site remediation/clean up projects. Review and oversight consists of but is not limited to review site work and safety plans, oversee customer field work to verify compliance with site health and safety plans, review phase 1 and phase II site investigation reports and provide verbal and written reports to Environmental Health regarding additional work needed, provide draft recommendations regarding site closure and/or required mitigation. Actual cost of consultant is charged to the customer and passed through to the consultant.

12	In the case of a new business required to pay an annual fee pursuant to resolution of the Board of Supervisors, annual fees shall be prorated on a Quarterly basis for the remaining part of the year, however no fee shall be prorated to an amount less than the BOS approved hourly rate.
13	This fee will be charged for consultant services such as technical geology review for the well program. Actual consultant costs incurred by Environmental Health Services are charged to the permit applicant.
14	Consistent with the action taken by the Board of Supervisors on August 27, 2013, the Health Officer, by and through her environmental health officers or duly authorized representatives, is delegated the authority to waive well construction permit fees in connection with the replacement of a domestic well that has gone dry if she finds that all of the following conditions have been met: (1) the well owner submits a letter of explanation documenting the failure of the current domestic well to provide adequate water (dry well) (such letter could include a statement from a licensed and bonded well drilling contractor verifying the well failure, the well completion report or driller's log for the dry well, the original permit issued by the Health Officer for the dry well and receipts for hauled water to the subject property); (2) the well owner verifies that the dry well was drawing groundwater from an area that has been certified as Level of Severity III as part of the County's Resource Management System by locating said dry well accurately on a map and by providing the Assessor's Parcel Number, section/township/range, street address and GPS coordinates of the location of the dry well/property; and (3) a licensed and bonded well drilling contractor submits a well construction permit for a new domestic well to replace the dry well.
