	Term of 1 day to 1 year. An additional up-front fee of \$100 will be assessed for each site visit estimated to be required during the processing or management of the permit. Some of the difference between actual staff costs and the proposed fee shown in this analysis will be made up through the additional site visit charges, where applicable. A higher fee is not recommended because it may result in fewer users requesting permits, and the most significant purpose of the permit is to reduce the County's exposure to liability.
	Film Permit fees consists of a \$250 non-refundable Application Fee for review of application, plus \$450 Permit Fee to issue the permit. Permit is valid for up to 7 consecutive days and 7 locations. On a case-by-case basis, requests to change a Film Application or Permit are subject to an additional \$75 fee per requested change. Additional fees may apply for impacts to Parks or other County facilities, encroachment permits, fire review, extended term of permit, or excess County staff hours (defined as staff time exceeding 10 hours per permit). Permits requiring more than 10 hours of staff time will be charged the full cost recovery hourly rate for time that exceeds 10 hours. Although staff costs are not fully recovered at a fee of \$700, a higher fee is not recommended because it is already near the top of the range of nearby counties. The California Film Commission endorses lower fees since their industry brings in a great deal of revenue to local businesses for any filming event.
