Footnote #	Footnote Narrative
1	The proposed fee structure and amounts are based on California Business and Professions Code section 12240 which states "...the Board of Supervisors, by ordinance, may charge an annual registration fee, not to exceed the county's total cost of actually inspecting or testing the devices as required by law, to recover the costs of inspecting or testing weighing and measuring devices required of the county sealer pursuant to Section 12210, and to recover the cost of carrying out Section 12211." For FY 2024-25, the projected total costs of the device program is \$558,100.88, based on current workload and projected costs. The proposed FY 2024-25 device registration revenue is \$247,630.65, based on the total number and type of locations registered and the number and type of devices inspected. This represents a projected cost recovery of 44.37% for the device inspection and enforcement program.
2	The Federal Standard Mileage rate, as set by the Internal Revenue Service January of each year, will be used for all mileage charges associated with hourly inspection fees.
