Your OFFICIAL VOTE-BY-MAIL BALLOT is included with this Voter Information Guide and is accompanied by a postage-paid return envelope. This will be your only official mailing from the County.

THE VOTE-BY-MAIL PERIOD BEGINS NOW. As soon as you are ready, return your VBM ballot and MAKE YOUR VOICE HEARD EARLY!

Return your Vote-by-Mail ballot during the voting period of October 7th through 8:00 pm on November 5th.

You can return your ballot by:

Mail. Be sure it is postmarked on or before Election Day. No postage necessary.

In person at any Elections Office, Vote Center, Polling **Place, or Official VBM Ballot Drop Box** located in the State of California. The location of drop boxes in San Luis Obispo County can be found on the Vote-by-Mail instructions included with your guide or at www.slovote.com.

Prefer to vote at your designated polling location between 7:00 am and 8:00 pm on Election Day?

To do that, please bring your unvoted Vote-by-Mail ballot AND its return envelope with you to surrender at your polling place.

The location of your polling place is listed at the top of your Vote-by-Mail ballot.

IMPORTANT TO KNOW BEFORE YOU VOTE

The office of California U.S. Senator has TWO separate contests on the November 5, 2024, General Election ballot. You may vote on both. The first contest is the regular election for the full 6-year term of office beginning on January 3, 2025 (the full term).

The second contest is a special vacancy election, since the current officeholder is temporarily filling the vacancy. This contest is for the remainder of the term ending on January 3, 2025 (the partial/unexpired term).

TOP TWO CANDIDATES

The Top Two Candidates Open Primary Act requires that all candidates for a voternominated office be listed on the same ballot. Voter-nominated offices include state legislative offices, U.S. congressional offices, and state constitutional offices.

In both the open primary and general elections, you can vote for any candidate regardless of what party preference you indicated on your voter registration form. In the primary election, the two candidates receiving the most votes—regardless of party preference—move on to the general election. If a candidate receives a majority of the vote (at least 50 percent + 1), a general election still

must be held. California's open primary system doesn't apply to candidates running for U.S. President, county central committee, or local offices.

In a direct primary, voters directly select their preferred candidate for a particular political party to run in the general election. This means that each voter can vote for their chosen candidate, and the one with the most votes becomes the party's nominee.

On the other hand, voting for electors, such as in the presidential election in CA, involves voters choosing electors who are pledged to a specific candidate. Each state, including CA, has a specific number of electors based on its representation in Congress (the sum of its Senators and Representatives).

ELECTIONS IN CALIFORNIA

VOTER-NOMINATED OFFICES

Political parties are not entitled to formally nominate candidates for voter-nominated offices at the primary election. A candidate nominated for a voter-nominated office at the primary election is the nominee of the people and not the official nominee of any party at the general election.

A candidate for nomination to a voter-nominated office shall have their qualified party preference, or lack of qualified party preference, stated on the ballot, but the party preference designation is selected solely by the candidate and is shown for the information of the voters only. It does not mean the candidate is nominated or endorsed by the party designated, or that there is an affiliation between the party and candidate, and no candidate nominated by the voters shall be deemed to be the officially nominated candidate of any political party.

The parties may submit a list of the candidates for voter-nominated offices who have received the party's official endorsement (see the Political Party Endorsements page).

NON-PARTISAN OFFICES

Political parties are not entitled to nominate candidates for nonpartisan offices at the primary election, and a candidate at the primary election is not the official nominee of any party for the specific office at the general election.

A candidate for nomination to a nonpartisan office may not designate their party preference, or lack of party preference, on the ballot. The top two vote-getters at the primary election move on to the general election for the nonpartisan office.

Any candidate for a nonpartisan office who receives a majority of the vote (at least 50 percent + 1) in the primary election will be elected to that office and the contest will not appear on the ballot for the general election.

Any voter may vote for any candidate for a voter-nominated office, if they meet the other qualifications required to vote for that office. The top two vote-getters at the primary election move on to the general election for the voter-nominated office, even if both candidates have specified the same party preference designation.

ELECTIONS IN CALIFORNIA

REQUIREMENTS FOR FIRST-TIME VOTERS

The Help America Vote Act (HAVA) requires first-time federal voters to show identification prior to voting.

Unless you already provided it, you will be required to show your current valid photo I.D. and/or a copy of one of the following that shows your name and address when you go to the polls on Election Day: current utility bill, bank statement, government check, government paycheck, or a government document.

You will be required to send a copy of one of the above documents with your voted Vote-by-Mail ballot. If you have questions about your status as a first-time voter, please contact the Elections Office.

WHY YOUR BALLOT WOULD NOT BE COUNTED

Your voice is important. The Elections Office makes every effort to ensure that each vote cast is counted. That said, the following are reasons that a ballot would NOT be counted:

1. The ballot is not postmarked by November 5 and/or does not arrive within 7 days after Election Day.

- 2. The VBM return envelope is not signed.
- 3. The signature on the VBM return envelope does not match any signature in the voter's record.



- 4. The ballot is returned without the VBM return envelope.
- 5. There are multiple ballots in one VBM return envelope.

VBM CURE PROCESS

The law requires the Elections Office to send a letter and verification form to voters who forgot to sign their return envelope or whose signature did not match their signatures on file.

In order for these ballots to be counted, voters must sign and return their form prior to the deadline, which is two days before the election is certified.

WHY VOTE NOW?

Because VBM ballots received before Election Day are counted and included in the Election Night results

But don't worry: Every VBM ballot postmarked correctly and received within 7 days of the election will be counted

ELECTION SAFETY AND SECURITY

California's election systems are extremely safe and secure, and all 58 counties have a proven track record of conducting accessible and accurate elections. The California Secretary of State's Office makes this possible by overseeing one of the most extensive voting system testing and certification programs in the nation.

Unfortunately, misinformation about elections is widespread, and it continues to confuse voters and lead to distrust in the process.

The fact remains that the Elections Office in San Luis Obispo County carefully follows statewide elections code and takes many steps to ensure election security locally, including making the processing and counting of ballots publicly observable.

CALIFORNIA ELECTION SECURITY SAFEGUARDS

There are a number of steps that we take to ensure your vote is safe and secure throughout the election. Here are a few examples:

- County voting systems are not connected to the Internet, and all ballots are paper.
- Only authorized staff have access to systems relevant to their role.
- We conduct routine threat monitoring, vulnerability scanning, and security assessments in collaboration with our state and federal partners.

CHECK YOUR VOTER STATUS ONLINE

- VoteCal is a centralized statewide voter registration database. VoteCal checks against official records and is regularly updated.
- Ballot drop boxes are secured and monitored.
- Signatures are verified on all Voteby-Mail envelopes.
- Ballots remain in dual (two-person) custody at all times.

HOW YOUR VOTE IS COUNTED

Polling places close at 8:00 pm on Election Night, but it can take a few hours for all locations to report results, and weeks before the final totals are known. Ever wondered why? Here's a quick look at what happens to your ballot after you cast it.

ELECTION NIGHT

The first results are posted shortly after 8:00 pm—these are the Vote-by-Mail ballots that were returned and processed early, prior to Election Day.

After that, we must wait for the first of the polling places across the county to complete their paperwork, pack up their supplies, and return the ballots; this can take more than an hour.

As polling places report in, their results are tabulated and compiled into countywide results. The posted results are updated periodically throughout the night at www. slovote.com.

When all polling places have reported, the Election Night counting is done; however, there are still more ballots to count and a lot more work to do before the results become official (see below).

BALLOTS COUNTED AFTER ELECTION DAY

Vote-by-Mail Ballots Received After the First Weekend in November: Voteby-Mail ballots that arrive the day before or on Election Day (either by mail, returned at a polling place, or deposited in an official ballot drop box) are processed and counted in the days after Election Day and therefore are **not** included in the Election Night results posted.

Postmarked Vote-by-Mail Ballots:

Under California law, ballots may be counted even if they arrive after Election Day, as long as they are received by mail no later than 7 days after the election and are postmarked on/before Election Day.

Missing or Mismatched Signature:

A voter's signature on the returned Vote-by-Mail identification envelope **must** compare with the signature(s) in the voter's registration record. If the voter did not sign the ballot envelope, or if the Elections Official has determined that the signature on the envelope does not match with the signature(s) of the voter in the voter's record, the Elections Office will provide the voter with the appropriate form to correct the missing or mismatched signature. This notice must be returned to the

Elections Office no later than 2 days prior to the certification of the election.

Ballots: These are

the last ballots counted because they must be researched and verified. It may take a few weeks, but every valid vote will be counted.

WARNING: CORRUPTING THE VOTING PROCESS IS PROHIBITED

VIOLATIONS CAN LEAD TO FINES AND/OR IMPRISONMENT

IT IS PROHIBITED TO ENGAGE IN ANY OF THE FOLLOWING ACTIVITIES:

- DO NOT commit or attempt to commit election fraud.
- DO NOT bribe or provide any sort of compensation to, in any fashion, or by any means induce or attempt to induce, a person to vote or refrain from voting.
- DO NOT illegally vote.
- DO NOT attempt to vote or aid another to vote when not entitled to vote.
- DO NOT engage in electioneering; photograph or record a voter entering or exiting a polling place; or obstruct the entrance, exit, or parking.
- DO NOT challenge a person's right to vote or prevent voters from voting; delay the process of voting; or fraudulently advise any person that he or she is not eligible to vote or is not registered to vote.
- DO NOT attempt to ascertain how a voter voted their ballot.
- DO NOT possess or arrange for someone to possess a firearm in the immediate

vicinity of a polling place, with some exceptions per Elections Code 18544(b).

- DO NOT appear or arrange for someone to appear in the uniform of a peace officer, guard, or security personnel in the immediate vicinity of a polling place, with some exceptions per Elections Code 18544(b).
- DO NOT tamper or interfere with any component of a voting system.

The corruption of voting prohibitions summarized here are set forth in Articles 2, 3, and 4 of Chapter 6 of Division 18 of the California Elections Code.

- DO NOT forge, counterfeit, or tamper with the returns of an election.
- DO NOT alter the returns of an election.
- DO NOT tamper with, destroy, or alter any polling list, official ballot, or ballot container.
- DO NOT display any unofficial ballot collection container that may deceive a voter into believing it is an official collection box.

- DO NOT coerce or deceive a person who cannot read or an elder into voting for or against a candidate or measure contrary to their intent.
- DO NOT act as an election officer when you are not one.



EMPLOYERS cannot require or ask their employee to bring their Vote-by-Mail ballot to work or ask their employee to vote their ballot at work. At the time of payment of salary or wages, employers cannot enclose materials that attempt to influence the political opinions or actions of their employees.

POLL WORKERS cannot attempt to determine how a voter voted their ballot or, if that information is discovered, disclose how a voter voted their ballot.

The prohibitions on activity related to corruption of the voting process summarized here are set forth in Chapter 6 of Division 18 of the California Elections Code.

ELECTIONEERING IS PROHIBITED

VIOLATIONS CAN LEAD TO FINES AND/OR IMPRISONMENT

WARNING: The following activities are prohibited within the immediate vicinity of a person in line to cast their ballot OR within 100 feet of the entrance to a polling place, curbside voting, or official ballot drop box.

- DO NOT ask a person to vote for or against any candidate or ballot measure.
- DO NOT display a candidate's name, image, or logo.
- DO NOT block access to or loiter near any ballot drop boxes.

The electioneering prohibitions summarized here are set forth in Article 7 of Chapter 4 of Division 18 of the California Elections Code.

- DO NOT provide any material or audible information for or against any candidate or ballot measure near any polling place or official ballot drop box.
- DO NOT circulate any petitions, including for initiatives, referenda, recall, or candidate nominations.
- DO NOT distribute, display, or wear any clothing (hats, shirts, signs, buttons, stickers) that includes a candidate's name, image and/or logo, or that supports or opposes any candidate or ballot measure.
- DO NOT display information or speak to a voter about the voter's eligibility to vote.

OBSERVING ELECTIONS

The public is invited to participate as a poll watcher or election observer. Both roles provide important insight into the process.

Rules for conduct are outlined in the California Elections Code, and more information can be found online at www.slovote.com. Poll watchers observe operations at polling locations on Election Day, while election observers check in at the County Elections Office and are then able to observe various steps in the ballot processing and tabulation process. In both cases, there may be space limitations that impact how many can participate.

ASSISTANCE FOR VOTERS WITH DISABILITIES

San Luis Obispo County is committed to ensuring every voter can cast their ballot privately and independently. Below is detailed information about assistance offered to voters with disabilities.

Vote-by-Mail: Mark your ballot. Once completed, sign and seal your envelope. If you are unable to sign, make your mark and have a witness sign in the designated spot. Return your ballot by mail, or in person at any drop box, elections office, or polling site in California.

Vote at a Polling Place: On Election Day, you may choose up to two people to help you vote at any polling place or at the County Elections Office. This person cannot be your employer or anyone who works for your employer, your labor union leader, or anyone who works for your labor union.

• Accessible ballot-marking (ICX) machines are available at every polling place on Election Day and at the County Clerk-Recorder's Office beginning 29 days prior to the election. The ICX can mark a ballot in a number of ways and generate a paper ballot with a QR code for tabulating.

- Curbside Voting: If you arrive at a polling place and cannot get to the voting area, call for assistance: **1-805-781-1888**
- Voter Information Guides are available on the County Clerk-Recorder's website for use with personal accessible navigational tools and screen reader technology.
- Large print format of the County Voter Information Guide and of the state ballot measures is available upon request.

REMOTE ACCESSIBLE VOTE-BY-MAIL (RAVBM)

The Elections Office offers voters the use of a Remote Accessible Vote-by-Mail system that allows a voter to mark their selections on a personal computer, using their own compatible technology or assistive device(s) (screen readers, tactile switches, closed captioning, sip and puff system, etc.) as needed, to vote independently and privately in the comfort of their own home.

VOTER BILL OF RIGHTS



You have the right to vote if you are a registered voter. You are eligible to vote if you are: a U.S. citizen living in California; at least 18 years old; registered where you currently live; not currently serving a state or federal prison term for the conviction of a felony; and not currently found mentally incompetent to vote by a court.



You have the right to vote if you are a registered voter, even if your name is not on the list. You will vote a provisional ballot. Your vote will be counted if elections officials determine that you are eligible to vote.



You have the right to vote if you are still in line when the polls close.



You have the right to cast a secret ballot without anyone bothering you or telling you how to vote.



You have the right to get a new ballot if, prior to casting your ballot, you believe you made a mistake. You can ask an election official at a polling place for a new ballot; exchange your Vote-by-Mail ballot for a new one at an elections office or at your polling place; or vote using a provisional ballot.



You have the right to get help casting your ballot from anyone you choose, except from your employer or union representative.



You have the right to drop off your completed Vote-by-Mail ballot at any polling place in California.



You have the right to get election materials in a language other than English if enough people in your voting precinct speak that language.



You have the right to ask questions to elections officials about election procedures and watch the election process. If the person you ask cannot answer your questions, they must send you to the right person for an answer. If you are disruptive, they can stop answering you.



You have the right to report any illegal or fraudulent election activity to an elections official or the Secretary of State's Office.

THE PEOPLE OF THE CITY OF GROVER BEACH DO ORDAIN AS FOLLOWS:

SECTION 1. RESOLUTION NO. 23-37, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GROVER BEACH, CALIFORNIA, AMENDING THE MASTER FEE SCHEDULE FOR WATER AND WASTEWATER RATES", adopted December 11, 2023, IS HEREBY REPEALED in accordance with Section 3 of Article XIII C of the Constitution of the State of California.

SECTION 2. This measure may not be amended, except upon voter approval.

CITY OF GROVER BEACH IMPARTIAL ANALYSIS OF MEASURE G-24

Initiative Measure G-24 asks the voters whether City of Grover Beach Resolution No. 23-37, setting new and increased water and wastewater rates, should be repealed.

Background. On December 11, 2023, the Grover Beach City Council approved Resolution No. 23-37 and implemented new water and wastewater rates to address increased operations, maintenance, and planned capital project costs. On April 22, 2024, City Council discussed the increasing costs related to the Central Coast Blue ("CCB") project, the City's current water supply, and its future water needs. Council voted to withdraw from the CCB project and reduced water rates to those in effect immediately prior to approval of Resolution No. 23-37.

Proposed Initiative Measure. On January 8, 2024, a citizen's ballot initiative was proposed to repeal Resolution No. 23-37, thereby reducing water and wastewater rates to the levels in effect prior to the approval of Resolution No. 23-37 on December 11, 2023. The initiative petition gathered sufficient signatures for placement on the ballot and was certified by the City Clerk.

Effect of Measure. If Initiative Measure G-24 is approved by a majority of voters, Resolution No. 23-37 will be repealed. The repeal of Resolution No. 23-37 will reduce the City's water and wastewater rates to the levels in place immediately prior to the adoption of Resolution No. 23-37. The water and wastewater fees collected by the City are utilized for ongoing costs related to the operation of the City's water and wastewater systems, including ongoing maintenance, repair, upgrades and replacement. The fees ensure that water and wastewater systems will remain operational, reliable, and compliant with health and environmental standards. Under California law, water and wastewater rates must be based on the cost of service. Any revenue collected from these fees must be allocated to their respective enterprise funds to ensure they are ultimately used for water and wastewater-related services and projects. Revenue from water and wastewater fees is essential for the City to obtain bonding because it provides a reliable source of income to service debt, ensuring investors of the City's ability to repay bonds used for infrastructure projects. This financial stability and assurance make the bonds more attractive to investors, facilitating the City's access to necessary funding. Adoption of the initiative measure will reduce the revenues for both water and wastewater funds. Any shortfall in funds within the City's enterprise funds will require supplementation from the City's general fund.

PROJECT LIST

The Board of Education of the Lucia Mar Unified School District is committed to improving the quality of education in our local public schools by providing safe, secure, modern classrooms, labs and technology needed to support high quality instruction in math, science, engineering, technology and the skilled trades. To that end, the Board evaluated the District's urgent and critical facility needs, including safety issues, class size reduction, **basic repairs**, computer and information technology in developing the types of projects to be funded by this measure as described below.

In approving this Project List, the Board of Education determines that the District must:

- (i) REPAIR or replace deteriorating roofs, plumbing, gas lines, sewer lines, heating, and electrical systems, where needed; and
- (ii) UPDATE the classrooms, facilities and technology needed to support high quality instruction in math, science, engineering, and technology; and

For example, thousands of students attend class in 93 portable classrooms that are decades old, are falling apart and most have structural damage or water leaks. Older schools have hazardous materials like asbestos and lead pipes. Most schools do not meet current health codes, building safety codes or provide full access for students with disabilities. This measure will remedy these problems.

All money raised by this measure will stay local to support our students and cannot be taken by the State or used for other purposes.

Goals and Purposes:

Some schools built so long ago that underground pipes and infrastructure are failing, resulting in gas leaks, water leaks and sewage backups. We need to fix these problems.

If we want our kids to succeed in college and in-demand careers, they must be skilled in the use of today's technologies and have advanced classes in science, math, engineering and technology. This measure will make this possible.

- Provide modern labs and career technical education facilities and equipment, so students are prepared for college and in-demand careers in fields like health sciences, engineering, technology, and skilled trades.
- Create modern, multi-use classrooms to support hands-on science instruction and learning-by-doing.
- Keep computer systems and instructional technology up-to-date.
- Provide the classrooms and facilities needed to support high quality instruction in music, visual and performing arts.

Provide the classrooms, facilities and instructional technology needed to support high quality instruction in math, science, engineering, and technology.

In addition to the projects listed above, the repair and renovation of each of the existing school facilities may include, but not be limited to, some or all of the following: add or renovate student and staff restrooms; repair and upgrade electrical, plumbing, heating, ventilation and air conditioning systems; upgrade of facilities for energy efficiencies and financial savings; repair and replace worn-out and deteriorated roofs, windows, walls, floors, doors and drinking fountains/hydration stations; construct or renovate offices and facilities for multipurpose and indoor/outdoor learning spaces, more efficient areas for professional development and administration and for the safety of students on campuses; install wiring and electrical systems to safely accommodate computers, technology and other electrical devices; upgrade or construct support facilities including administrative, physical education, music, art, and performing and fine arts classrooms or facilities, science, computer labs/classrooms, career technical facilities, media centers/libraries and buildings, covered eating areas, shade and rain shelter, playgrounds, administrative and maintenance facilities and yards; acquire modular/portable classrooms; repair and replace fire alarms, emergency communications, public address and security systems; improve facilities to satisfy ADA and seismic requirements; as needed, removal of hazardous materials like asbestos and lead paint from older schools; resurface or replace asphalt, broken concrete and improve hard courts, turf, tracks, irrigation, and downspout drainage systems and campus landscaping; install signage, solar panels systems and fencing; improve recycling and composting facilities; expand parking and improve pick-up and drop-off areas; improve all site utilities; acquire land; construct new school buildings; upgrade or replace interior and exterior painting, floor covering, including carpets, and school facades; demolition; upgrade kitchens, food service and school cafeterias; construct various forms of storage and support spaces and classrooms; improve outdoor learning environments and guads; repair, upgrade and install interior and exterior lighting systems and back-up power generators; improve playgrounds, play structures, athletic fields, lockers and facilities to support student health, fitness and safety; construct aquatic facilities, pool filtration systems, plaster and decking; replace outdated security fences and security systems (including access control systems), provide lunch shelters, indoor space for assemblies or for rainy day lunch; upgrade music labs, multi-purpose rooms, learning centers and media centers; add or upgrade parking lots. In addition to the listed projects stated above, the Project List also includes the acquisition of a variety of instructional, maintenance and operational equipment, including the reduction or retirement of outstanding lease obligations and interim funding incurred to advance fund projects from the Project List; payment of the costs of preparation of all facility planning, facility studies, assessment reviews, facility master plan preparation and updates, environmental studies (including environmental investigation, remediation and monitoring), design and construction documentation, DSA oversight, and temporary housing of dislocated District activities caused by construction projects.

The upgrading of technology infrastructure includes, but is not limited to, network rewiring, cabling, computers, portable interface devices, servers, switches, routers, modules, sound projection systems, laser printers, scanners and copiers, digital white boards, document projectors, upgrade voice-over-IP, clock/telephone/ intercom systems, call manager and network security/firewall, wireless technology systems, refresh classroom technology, miscellaneous IT and instructional equipment, data storage, archiving and preservation, phones, identity cards and the construction and installation of a data center in the cloud for the District's enterprise systems, such as resource planning, websites, domain name systems, cloud applications and information security.

The budget for each project is an estimate and may be affected by factors beyond the District's control. The final cost of each project will be determined as plans and construction documents are finalized, construction bids are received, construction contracts are awarded and projects are completed. Based on the final costs of each project, certain of the projects described above may be delayed or may not be completed. Demolition of portable classrooms and existing facilities and reconstruction of facilities scheduled for repair and upgrade may occur, if the Board determines that such an approach would be more cost-effective in creating more enhanced and operationally efficient campuses. Necessary site preparation/restoration may occur in connection with new construction, renovation or remodeling, or installation or removal of relocatable or modular classrooms, including ingress and egress, removing, replacing, or installing irrigation or drainage systems, utility lines, trees and landscaping, relocating fire access roads, and acquiring any necessary easements, licenses, or rights of way to the property. The listed projects will be completed as needed. Each project is assumed to include its share of furniture, equipment, architectural, engineering, and similar planning costs, connection fees, program and project management, staff training expenses and a customary contingency for unforeseen design and construction costs. Proceeds of the bonds may be used to pay or reimburse the District for the cost of District bond audits and staff when performing work on or necessary and incidental to bond projects. Bond proceeds shall only be expended for the types of projects and purposes identified herein. The District shall create an account into which proceeds of the bonds shall be deposited and comply with the reporting requirements of Government Code § 53410.

FISCAL ACCOUNTABILITY: THIS MEASURE REQUIRES A CLEAR SYSTEM OF ACCOUNTABILITY, INCLUDING A PROJECT LIST DETAILING HOW THE MONEY WILL BE USED, A CITIZENS' OVERSIGHT COMMITTEE, AND INDEPENDENT AUDITS TO ENSURE MONEY IS SPENT PROPERLY.

In accordance with Education Code Section 15272, the Board of Education will appoint a citizens' oversight committee and conduct annual independent audits to assure that funds are spent only on District projects and for no other purpose. The expenditure of bond money on these projects is subject to stringent financial accountability requirements. By law, performance and financial audits will be performed annually, and all bond expenditures will be monitored by an independent citizens' oversight committee to ensure that funds are spent as promised and specified. The citizens' oversight committee must include, among others, representation of a bona fide taxpayers association, a business organization and a senior citizens organization. No District employees or vendors are allowed to serve on the citizens' oversight committee.

No Administrator Salaries: Proceeds from the sale of the bonds authorized by this proposition shall be used only for the acquisition, construction, reconstruction, rehabilitation, or replacement of school facilities, including the furnishing and equipping of school facilities, and not for any other purpose, including teacher and school administrator salaries and other operating expenses.

IMPARTIAL ANALYSIS OF MEASURE H-24

Bonds are financial instruments used to borrow money. Under the California Constitution, school districts may issue bonds if approved by at least 55 percent of voters within the district boundaries who are voting on a measure authorizing the issuance of bonds. Obtaining voter approval for the issuance of bonds is a common financing method used by school districts for funding new school construction and improvements to existing school facilities. The bonds are sold to the public and constitute a debt of the district. The principal and interest on the bonds are repaid by an annual property tax levy on all taxable real property within the school district's jurisdiction, calculated on the current assessed value of each property ("an *ad valorem* tax").

The Board of Education of the Lucia Mar Unified School District ("the District") has placed Measure H-24 on the ballot, proposing the sale of bonds in an amount not to exceed \$143,220,000 and at interest rates not exceeding the legal limits. The District's Tax Rate Statement, included in the voter information guide mailed to voters of the District, reflects an estimate of the maximum property tax levies required to service the bonds.

Proceeds from the bond sales (i.e., funds generated by the bonds) may only be used for the purposes identified in the measure. The general purposes are to upgrade, repair, expand, improve and modernize school facilities and infrastructure, including to ensure school facilities meet current health and safety standards and are accessible to those with disabilities. The specific types of projects to be funded by the sale of bonds are more specifically described in the full text of the measure. Depending on the final costs of each project, certain projects listed in the measure may be delayed or not completed.

The law prohibits use of bond proceeds to pay for teacher and administrator salaries or other operational expenses. The District must follow certain accountability requirements for overseeing the funds collected and expended, including the establishment of an independent citizens' oversight committee, the annual completion of performance and financial audits, and issuance of annual reports detailing the proceeds received by bond sales and the expenditures made. These requirements are reflected in the full text of measure.

The District's Tax Rate Statement provides the District's best estimate of the highest tax rate to be levied, which is 2 cents per \$100 (or \$20 per \$100,000) of assessed valuation. The final fiscal year in which the tax is anticipated to be collected is 2059-60.

TAX RATE STATEMENT FOR MEASURE H-24

An election will be held in the Lucia Mar Unified School District (the "District") on November 5, 2024, to authorize the sale of up to \$143,220,000 in bonds of the District to finance improvements to educational facilities as described in the proposition. If such bonds are authorized and sold, principal and interest on the bonds will be payable only from the proceeds of *ad valorem* tax levies made upon the taxable property in the District. The following information is provided in compliance with Sections 9400-9404 of the Elections Code of the State of California.

- 1. The best estimate of the average annual tax rate which would be required to be levied to fund this bond issue over the entire duration of the bond debt service, based on a projection of assessed valuations available at the time of filing this statement, is 1.976 cents per \$100 of assessed valuation (or \$19.76 per \$100,000 of assessed valuation). The final fiscal year in which it is anticipated that the tax will be collected is 2059-60.
- The best estimate of the highest tax rate which would be required to be levied to fund
 this bond issue, based on a projection of assessed valuations available at the time of
 filing this statement, is 2 cents per \$100 of assessed valuation (or \$20.00 per \$100,000
 of assessed valuation). It is estimated that such rate would be levied in fiscal year
 2025-26.
- The best estimate of the total debt service, including the principal and interest that would be required to be repaid if all the bonds are issued and sold, is approximately \$320.6 million.

Voters should note that the estimated tax rate is based on the ASSESSED VALUE of taxable property on the San Luis Obispo County official tax rolls, <u>not</u> on the property's market value. Property owners should consult their own property tax bills to determine their property's assessed value and any applicable tax exemptions.

Attention of all voters is directed to the fact that the foregoing information is based upon the District's projections and estimates only, which are not binding upon the District. The actual tax rates, debt service and the years in which they will apply may vary from those presently estimated, due to variations from these estimates in the timing of bond sales, the amount of bonds sold and market interest rates at the time of each sale, and actual assessed valuations over the term of repayment of the bonds. The dates of sale and the amount of bonds sold at any given time will be determined by the District based on need for construction funds and other factors. The actual interest rates at which the bonds will be sold will depend on the bond market at the time of each sale. Actual future assessed valuation will depend upon the amount and value of taxable property within the District as determined by the County Assessor in the annual assessment and the equalization process.

- Your dog's license is his ticket home if he is ever picked up running at large. Animal Control Officers would rather reunite you with your pet than impound him. If he's wearing a current license, they'll bring him home instead of to the shelter.
- License revenues help support Animal Services efforts to address the needs of homeless and neglected pets and to resolve our community's animal-related problems.
- It's the law.

HELPFUL INFO

- The metal tag your vet gives you when your pet is vaccinated is not a license tag.
- State law requires all dogs to have a current rabies vaccination before they can be licensed. If your dog doesn't have vaccination information on file with Animal Services, you will need to submit it with your application.
- License fees are significantly discounted if your dog has been spayed or neutered.
- By law, the duration of your dog's license validity cannot exceed the expiration date of his current rabies vaccine.
