Your **OFFICIAL VOTE-BY-MAIL BALLOT** is included with this Voter Information Guide and is accompanied by a postage-paid return envelope. This will be your only official mailing from the County.

THE VOTE-BY-MAIL PERIOD BEGINS NOW. As soon as you are ready, return your VBM ballot and **MAKE YOUR VOICE HEARD EARLY!**

Return your Vote-by-Mail ballot during the voting period of October 7th through **8:00 pm** on November 5th.

You can return your ballot by:

 **Mail.** Be sure it is post-marked **on or before Election Day.** No postage necessary.

 **In person** at any **Elections Office, Vote Center, Polling Place, or Official VBM Ballot Drop Box** located in the State of California. The location of drop boxes in San Luis Obispo County can be found on the Vote-by-Mail instructions included with your guide or at www.slovote.com.

Prefer to vote at your designated **polling location** between 7:00 am and 8:00 pm on Election Day?

To do that, please **bring your un-voted Vote-by-Mail ballot AND its return envelope** with you to surrender at your polling place.

The location of your polling place is listed at the top of your Vote-by-Mail ballot.

IMPORTANT TO KNOW BEFORE YOU VOTE

The office of California U.S. Senator has TWO separate contests on the November 5, 2024, General Election ballot. You may vote on both. The first contest is the regular election for the full 6-year term of office beginning on January 3, 2025 (the full term).

The second contest is a special vacancy election, since the current officeholder is temporarily filling the vacancy. This contest is for the remainder of the term ending on January 3, 2025 (the partial/unexpired term).

TOP TWO CANDIDATES

The Top Two Candidates Open Primary Act requires that all candidates for a voter-nominated office be listed on the same ballot. Voter-nominated offices include state legislative offices, U.S. congressional offices, and state constitutional offices.

In both the open primary and general elections, you can vote for any candidate regardless of what party preference you indicated on your voter registration form. In the primary election, the two candidates receiving the most votes—regardless of party preference—move on to the general election. If a candidate receives a majority of the vote (at least 50 percent + 1), a general election still

must be held. California's open primary system doesn't apply to candidates running for U.S. President, county central committee, or local offices.

In a direct primary, voters directly select their preferred candidate for a particular political party to run in the general election. This means that each voter can vote for their chosen candidate, and the one with the most votes becomes the party's nominee.

On the other hand, voting for electors, such as in the presidential election in CA, involves voters choosing *electors* who are pledged to a specific candidate. Each state, including CA, has a specific number of electors based on its representation in Congress (the sum of its Senators and Representatives).

ELECTIONS IN CALIFORNIA

VOTER-NOMINATED OFFICES

Political parties are not entitled to formally nominate candidates for voter-nominated offices at the primary election. A candidate nominated for a voter-nominated office at the primary election is the nominee of the people and not the official nominee of any party at the general election.

A candidate for nomination to a voter-nominated office shall have their qualified party preference, or lack of qualified party preference, stated on the ballot, but the party preference designation is selected solely by the candidate and is shown for the information of the voters only. It does not mean the candidate is nominated or endorsed by the party designated, or that there is an affiliation between the party and candidate, and no candidate nominated by the voters shall be deemed to be the officially nominated candidate of any political party.

The parties may submit a list of the candidates for voter-nominated offices who have received the party's official endorsement (see the Political Party Endorsements page).

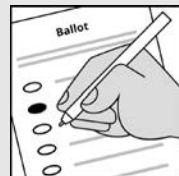
NON-PARTISAN OFFICES

Political parties are not entitled to nominate candidates for nonpartisan offices at the primary election, and a candidate at the primary election is not the official nominee of any party for the specific office at the general election.

A candidate for nomination to a nonpartisan office may not designate their party preference, or lack of party preference, on the ballot. The top two vote-getters at the primary election move on to the general election for the nonpartisan office.

Any candidate for a nonpartisan office who receives a majority of the vote (at least 50 percent + 1) in the primary election will be elected to that office and the contest will not appear on the ballot for the general election.

Any voter may vote for any candidate for a voter-nominated office, if they meet the other qualifications required to vote for that office. The top two vote-getters at the primary election move on to the general election for the voter-nominated office, even if both candidates have specified the same party preference designation.



ELECTIONS IN CALIFORNIA

REQUIREMENTS FOR FIRST-TIME VOTERS

The Help America Vote Act (HAVA) requires first-time federal voters to show identification prior to voting.

Unless you already provided it, you will be required to show your current valid photo I.D. and/or a copy of one of the following that shows your name and address when you go to the polls on Election Day: current utility bill, bank statement, government check, government paycheck, or a government document.

You will be required to send a copy of one of the above documents with your voted Vote-by-Mail ballot. If you have questions about your status as a first-time voter, please contact the Elections Office.

WHY YOUR BALLOT WOULD NOT BE COUNTED

Your voice is important. The Elections Office makes every effort to ensure that each vote cast is counted. That said, the following are reasons that a ballot would NOT be counted:

1. The ballot is not postmarked by November 5 and/or does not arrive within 7 days after Election Day.

2. The VBM return envelope is not signed.

3. The signature on the VBM return envelope does not match any signature in the voter's record.



4. The ballot is returned without the VBM return envelope.

5. There are multiple ballots in one VBM return envelope.

VBM CURE PROCESS

The law requires the Elections Office to send a letter and verification form to voters who forgot to sign their return envelope or whose signature did not match their signatures on file.

In order for these ballots to be counted, voters must sign and return their form prior to the deadline, which is two days before the election is certified.

WHY VOTE NOW?

Because VBM ballots received before Election Day are counted and included in the Election Night results

But don't worry: Every VBM ballot postmarked correctly and received within 7 days of the election will be counted

My voter registration changed, even though I didn't make an update. What's going on?

We sometimes hear this question from people who don't realize that their voter registration can be updated as part of DMV processes. So, if you find your registration is different from what you remember, it may have been updated during a DMV transaction. If you give us a call, we can look it up and verify that for you.

ELECTION SAFETY AND SECURITY

California's election systems are extremely safe and secure, and all 58 counties have a proven track record of conducting accessible and accurate elections. The California Secretary of State's Office makes this possible by overseeing one of the most extensive voting system testing and certification programs in the nation.

Unfortunately, misinformation about elections is widespread, and it continues to confuse voters and lead to distrust in the process.

The fact remains that the Elections Office in San Luis Obispo County carefully follows statewide elections code and takes many steps to ensure election security locally, including making the processing and counting of ballots publicly observable.

CALIFORNIA ELECTION SECURITY SAFEGUARDS

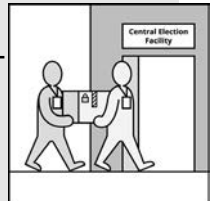
There are a number of steps that we take to ensure your vote is safe and secure throughout the election. Here are a few examples:

- County voting systems are not connected to the Internet, and all ballots are paper.
- Only authorized staff have access to systems relevant to their role.
- We conduct routine threat monitoring, vulnerability scanning, and security assessments in collaboration with our state and federal partners.

CHECK YOUR VOTER STATUS ONLINE

VoterStatus.sos.ca.gov

- VoteCal is a centralized statewide voter registration database. VoteCal checks against official records and is regularly updated.
- Ballot drop boxes are secured and monitored.
- Signatures are verified on all Vote-by-Mail envelopes.
- Ballots remain in dual (two-person) custody at all times.



HOW YOUR VOTE IS COUNTED

Polling places close at 8:00 pm on Election Night, but it can take a few hours for all locations to report results, and weeks before the final totals are known. Ever wondered why? Here's a quick look at what happens to your ballot after you cast it.

ELECTION NIGHT

The first results are posted shortly after 8:00 pm—these are the Vote-by-Mail ballots that were returned and processed early, prior to Election Day.

After that, we must wait for the first of the polling places across the county to complete their paperwork, pack up their supplies, and return the ballots; this can take more than an hour.

As polling places report in, their results are tabulated and compiled into countywide results. The posted results are updated periodically throughout the night at www.slovote.com.

When all polling places have reported, the Election Night counting is done; however, there are still more ballots to count and a lot more work to do before the results become official (see below).

BALLOTS COUNTED AFTER ELECTION DAY

Vote-by-Mail Ballots Received After the First Weekend in November: Vote-by-Mail ballots that arrive the

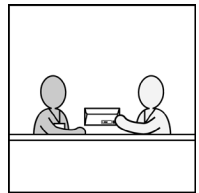
day before or on Election Day (either by mail, returned at a polling place, or deposited in an official ballot drop box) are processed and counted in the days after Election Day and therefore are **not** included in the Election Night results posted.

Postmarked Vote-by-Mail Ballots:

Under California law, ballots may be counted even if they arrive after Election Day, as long as they are received by mail no later than 7 days after the election and are postmarked on/before Election Day.

Missing or Mismatched Signature:

A voter's signature on the returned Vote-by-Mail identification envelope **must** compare with the signature(s) in the voter's registration record. If the voter did not sign the ballot envelope, or if the Elections Official has determined that the signature on the envelope does not match with the signature(s) of the voter in the voter's record, the Elections Office will provide the voter with the appropriate form to correct the missing or mismatched signature. This notice must be returned to the Elections Office no later than 2 days prior to the certification of the election.



Provisional

Ballots: These are the last ballots counted because they must be researched and verified. It may take a few weeks, but every valid vote will be counted.

WARNING: CORRUPTING THE VOTING PROCESS IS PROHIBITED

VIOLATIONS CAN LEAD TO FINES AND/OR IMPRISONMENT

IT IS PROHIBITED TO ENGAGE IN ANY OF THE FOLLOWING ACTIVITIES:

- DO NOT commit or attempt to commit election fraud.
- DO NOT bribe or provide any sort of compensation to, in any fashion, or by any means induce or attempt to induce, a person to vote or refrain from voting.
- DO NOT illegally vote.
- DO NOT attempt to vote or aid another to vote when not entitled to vote.
- DO NOT engage in electioneering; photograph or record a voter entering or exiting a polling place; or obstruct the entrance, exit, or parking.
- DO NOT challenge a person's right to vote or prevent voters from voting; delay the process of voting; or fraudulently advise any person that he or she is not eligible to vote or is not registered to vote.
- DO NOT attempt to ascertain how a voter voted their ballot.
- DO NOT possess or arrange for someone to possess a firearm in the immediate

vicinity of a polling place, with some exceptions per Elections Code 18544(b).

- DO NOT appear or arrange for someone to appear in the uniform of a peace officer, guard, or security personnel in the immediate vicinity of a polling place, with some exceptions per Elections Code 18544(b).
- DO NOT tamper or interfere with any component of a voting system.

The corruption of voting prohibitions summarized here are set forth in Articles 2, 3, and 4 of Chapter 6 of Division 18 of the California Elections Code.

- DO NOT forge, counterfeit, or tamper with the returns of an election.
- DO NOT alter the returns of an election.
- DO NOT tamper with, destroy, or alter any polling list, official ballot, or ballot container.
- DO NOT display any unofficial ballot collection container that may deceive a voter into believing it is an official collection box.

- DO NOT coerce or deceive a person who cannot read or an elder into voting for or against a candidate or measure contrary to their intent.
- DO NOT act as an election officer when you are not one.

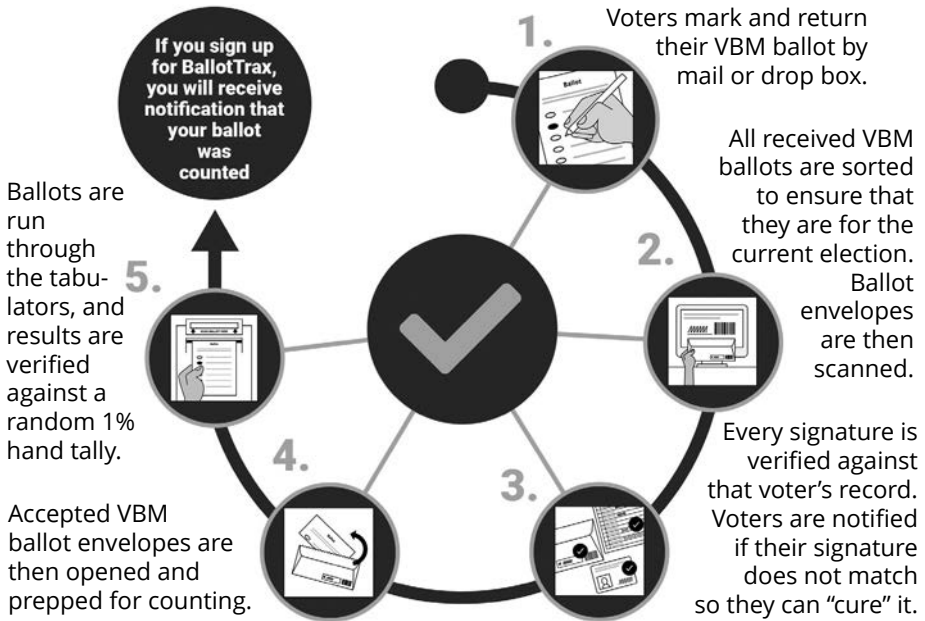

EMPLOYERS cannot require or ask their employee to bring their Vote-by-Mail ballot to work or ask their employee to vote their ballot at work. At the time of payment of salary or wages, employers cannot enclose materials that attempt to influence the political opinions or actions of their employees.

POLL WORKERS cannot attempt to determine how a voter voted their ballot or, if that information is discovered, disclose how a voter voted their ballot.

The prohibitions on activity related to corruption of the voting process summarized here are set forth in Chapter 6 of Division 18 of the California Elections Code.

A VOTE-BY-MAIL (VBM) BALLOT FROM VOTE TO TABULATION



ELECTIONEERING IS PROHIBITED

VIOLATIONS CAN LEAD TO FINES AND/OR IMPRISONMENT

WARNING: The following activities are prohibited within the immediate vicinity of a person in line to cast their ballot OR within 100 feet of the entrance to a polling place, curbside voting, or official ballot drop box.

- DO NOT ask a person to vote for or against any candidate or ballot measure.
- DO NOT display a candidate's name, image, or logo.
- DO NOT block access to or loiter near any ballot drop boxes.
- DO NOT provide any material or audible information for or against any candidate or ballot measure near any polling place or official ballot drop box.
- DO NOT circulate any petitions, including for initiatives, referenda, recall, or candidate nominations.
- DO NOT distribute, display, or wear any clothing (hats, shirts, signs, buttons, stickers) that includes a candidate's name, image and/or logo, or that supports or opposes any candidate or ballot measure.
- DO NOT display information or speak to a voter about the voter's eligibility to vote.

The electioneering prohibitions summarized here are set forth in Article 7 of Chapter 4 of Division 18 of the California Elections Code.

OBSERVING ELECTIONS

The public is invited to participate as a poll watcher or election observer. Both roles provide important insight into the process.

Rules for conduct are outlined in the California Elections Code, and more information can be found online at www.slovote.com.

Poll watchers observe operations at polling locations on Election Day, while election observers check in at the County Elections Office and are then able to observe various steps in the ballot processing and tabulation process. In both cases, there may be space limitations that impact how many can participate.

ASSISTANCE FOR VOTERS WITH DISABILITIES

San Luis Obispo County is committed to ensuring every voter can cast their ballot privately and independently. Below is detailed information about assistance offered to voters with disabilities.

Vote-by-Mail: Mark your ballot. Once completed, sign and seal your envelope. If you are unable to sign, make your mark and have a witness sign in the designated spot. Return your ballot by mail, or in person at any drop box, elections office, or polling site in California.

Vote at a Polling Place: On Election Day, you may choose up to two people to help you vote at any polling place or at the County Elections Office. This person cannot be your employer or anyone who works for your employer, your labor union leader, or anyone who works for your labor union.

- Accessible ballot-marking (ICX) machines are available at every polling place on Election Day and at the County Clerk-Recorder's Office beginning 29 days prior to the election. The ICX can mark a ballot in a number of ways and generate a paper ballot with a QR code for tabulating.

- Curbside Voting: If you arrive at a polling place and cannot get to the voting area, call for assistance: **1-805-781-1888**

- Voter Information Guides are available on the County Clerk-Recorder's website for use with personal accessible navigational tools and screen reader technology.

- Large print format of the County Voter Information Guide and of the state ballot measures is available upon request.

REMOTE ACCESSIBLE VOTE-BY-MAIL (RAVBM)

The Elections Office offers voters the use of a Remote Accessible Vote-by-Mail system that allows a voter to mark their selections on a personal computer, using their own compatible technology or assistive device(s) (screen readers, tactile switches, closed captioning, sip and puff system, etc.) as needed, to vote independently and privately in the comfort of their own home.

VOTER BILL OF RIGHTS



You have the right to vote if you are a registered voter. You are eligible to vote if you are: a U.S. citizen living in California; at least 18 years old; registered where you currently live; not currently serving a state or federal prison term for the conviction of a felony; and not currently found mentally incompetent to vote by a court.



You have the right to vote if you are a registered voter, even if your name is not on the list. You will vote a provisional ballot. Your vote will be counted if elections officials determine that you are eligible to vote.



You have the right to vote if you are still in line when the polls close.



You have the right to cast a secret ballot without anyone bothering you or telling you how to vote.



You have the right to get a new ballot if, prior to casting your ballot, you believe you made a mistake. You can ask an election official at a polling place for a new ballot; exchange your Vote-by-Mail ballot for a new one at an elections office or at your polling place; or vote using a provisional ballot.



You have the right to get help casting your ballot from anyone you choose, except from your employer or union representative.



You have the right to drop off your completed Vote-by-Mail ballot at any polling place in California.



You have the right to get election materials in a language other than English if enough people in your voting precinct speak that language.



You have the right to ask questions to elections officials about election procedures and watch the election process. If the person you ask cannot answer your questions, they must send you to the right person for an answer. If you are disruptive, they can stop answering you.



You have the right to report any illegal or fraudulent election activity to an elections official or the Secretary of State's Office.

Education and Qualifications: As a United States Representative, I'm fighting to give people opportunities for a better life. BOND AUTHORIZATION

By approval of this measure by at least 55 percent of the registered voters voting on the measure, the Atascadero Unified School District (the "District") will be authorized to issue and sell general obligation bonds in the aggregate principal of up to \$110,000,000 at interest rates not to exceed legal limits and to provide financing for the specific types of school facilities projects listed in the Bond Project List described below, subject to all the accountability requirements imposed by law and specified below.

ACCOUNTABILITY REQUIREMENTS

The provisions in this section are specifically included in this measure in order that the voters and taxpayers in the District may be assured that their money will be spent wisely. Expenditures to address specific facilities needs of the District will be in compliance with the requirements of Article XIII A, Section 1(b)(3), of the State Constitution and the Strict Accountability in Local School Construction Bonds Act of 2000 (codified at Education Code Sections 15264 and following.)

Evaluation of Needs. The Board of Education of the District (the "School Board") has identified detailed facilities needs of the District and has determined which projects to finance from a local bond. The School Board hereby certifies that it has evaluated safety, class size reduction, enrollment growth, and information technology needs in developing the Bond Project List shown below.

Independent Citizens' Oversight Committee. Following approval of this measure, the School Board will establish an Independent Citizens' Oversight Committee, under Education Code Sections 15278 and following, to ensure bond proceeds are expended only on the types of school facilities projects listed below. The Oversight Committee will be established within 60 days of the date when the results of the election appear in the minutes of the School Board. No employee or official of the District and no vendor, contractor or consultant of the District shall be appointed to the Oversight Committee.

Performance Audits. The School Board will conduct annual, independent performance audits to ensure that the bond proceeds have been expended only on the school facilities projects listed below.

Financial Audits. The School Board will conduct annual, independent financial audits of the bond proceeds until all of those proceeds have been spent for the school facilities projects listed below.

Government Code Accountability Requirements. As required by Section 53410 of the Government Code, (1) the specific purpose of the bonds is set forth in this Full Text of the Measure, (2) the proceeds from the sale of the bonds will be used only for the purposes specified in this measure, and not for any other purpose, (3) the proceeds of the bonds, when and if issued, will be deposited into a building fund to be held by the San Luis Obispo County Treasurer, as required by the California Education Code, and (4) the Superintendent of the District shall cause an annual report to be filed with the District Board not later than January 1 of each year, which report shall contain information regarding the amount of funds collected and expended, as well as the status of the projects listed in this measure, as required by Sections 53410 and 53411 of the Government Code.

NO TEACHER OR ADMINISTRATOR SALARIES

Proceeds from the sale of bonds authorized by this measure shall be used only for the purposes specified in Article XIII A, Section 1(b)(3), those being for the construction, reconstruction, rehabilitation, or replacement of school facilities, including the furnishing and equipping of school facilities, and the acquisition or lease of school facilities, and not for any other purpose, including teacher and administrator salaries and other school operating expenses.

STATE MATCHING FUNDS

The following statement is included in this measure pursuant to Education Code Section 15122.5: Approval of this measure does not guarantee that each of the proposed projects that are the subject of bonds under this measure will be funded beyond the local revenues generated by this measure. The District's proposal for the project or projects described below may assume or require the receipt of additional funds such as State matching funds, which, if available, could be subject to appropriation by the Legislature or approval of a statewide bond measure.

INFORMATION ABOUT ESTIMATES AND PROJECTIONS INCLUDED IN BALLOT

Voters are informed that any estimates or projections in this bond measure and related ballot materials, including relating to estimated rates of *ad valorem* property taxes, the duration of issued bonds until fully repaid and related levies and collections of *ad valorem* property taxes are provided as informational only. Such amounts are estimates and are not maximum amounts or limitations on the terms of the bonds, the tax rate required to fully amortize the bonds or the duration of the levy supporting repayment of issued bonds. Such estimates depend on numerous variables which are subject to variation and change over the term of the District's overall facilities and bond financing plan, including but not limited to the amount of bonds issued and outstanding at any one time, the interest rates applicable to issued bonds, market conditions at the time of sale of the bonds, when bonds mature, timing of project needs and changes in assessed valuations in the District. While each of the estimates and approximations relating to this bond measure are provided based on information currently available to the District and its current expectations, all such estimates and approximations are not limitations nor maximums on the terms of the bonds nor on the related tax levies. In addition, the abbreviated and condensed statement of the bond measure presented to voters on the ballot label which is subject to a 75-word count limitation imposed by State law does not limit the scope and broader, more complete meaning of the measure provided in this Full Text of Bond Measure and related ballot materials.

BOND PROJECT LIST

Scope of Projects. Bond proceeds will be expended on the construction, modernization, reconstruction, rehabilitation, replacement, or otherwise improve school facilities of the Atascadero Unified School District, including furnishing and equipping, and the acquisition or lease of real property for school facilities, and not for any other purpose, including teacher and administrator salaries or other school operating expenses, in compliance with California Constitution Article XIII A, Section 1(b)(3). The projects in the Bond Project List are authorized to be completed at any current and future District properties and sites.

School Facility Project List. The types of projects authorized to be funded with bond proceeds are set forth below. Specific examples included on this project list of the more general types of projects authorized are not intended to limit the broader types of projects described and authorized by this measure.

The types of projects authorized pursuant to this measure are:

- Expand, renovate and revitalize existing or construct new classrooms, labs, workshops, school facilities and equipment for vocational and career training programs including robotics, coding, welding, construction, engineering, agriculture mechanics, woodworking, design and programming and the arts pathways, including ceramics, art, music and performing arts
- Expand, renovate and revitalize existing or construct new classrooms, labs and school facilities for Science, Technology, Engineering, Arts, and Math (“STEAM”) instruction
- Replace, repair, modernize deteriorating roofs, leaking pipes, outdated plumbing, sewer and gas lines, waterlines, water pumps, wells, storm drains and valves, heating, cooling, ventilation systems and electrical systems
- Modernize, upgrade, renovate existing classrooms and construct new classrooms, multipurpose rooms and multipurpose spaces
- Retrofit classrooms or other existing facilities
- Construct a high school career center and agriculture center, including new classrooms, workspaces, barns, and show arena
- Acquire, install and/or upgrade campus safety and security systems, including intercom and emergency communications systems, lighting systems, bell systems, video surveillance systems, alarms, install additional fencing and gates, pedestrian access, walkways, lighting, reconfigure entrances and drop-off/pickup locations, point of entry access and upgrade door locks
- Make health and safety improvements, such as installing necessary seismic reinforcements, repairing termite damage and repairing and/or replacing aging building materials including removal of hazardous materials identified either prior to or during construction
- Repair, modernize outdated portable classrooms or replace with permanent modern facilities
- Improve, upgrade and expand student and staff access to updated and modern technology, including acquiring and installing all necessary network infrastructure and connections, internet, wi-fi, wiring, hardware, software, computers, devices, classroom technology tools, data backup systems and remote learning software
- Renovate and modernize classrooms and school facilities including flooring, windows, window coverings, doors, lighting, interior and exterior finishes, and paint
- Renovate and modernize school libraries and media centers
- Renovate, expand and modernize classroom, workroom, office and conference room spaces for mental health, wellness and counseling
- Expand, renovate, construct and equip new transitional kindergarten, pre kindergarten, kindergarten and first grade classrooms, facilities, learning spaces, playgrounds and other play areas
- Expand, renovate, construct and equip special education and student intervention classrooms, facilities, learning spaces, playgrounds and other play areas
- Develop, construct, install and improve outdoor areas including playgrounds, outdoor learning and meeting areas, hardscaping, landscaping, irrigation improvements, and building/installing shade structures and seating
- Provide adequate furniture and equipment for all classrooms

- Renovate, repair, replace, expand, construct and/or install playfields, turf fields, running tracks, gyms, courts, playgrounds, play surfaces, other indoor and outdoor physical education and athletic facilities, locker rooms and all related improvements and equipment
- Renovate and repair restrooms
- Repair or replace deteriorating asphalt, concrete, sidewalks, parking lots, driveways and walkways
- Construct, modernize, retrofit central kitchen, cafeteria, serving and indoor and outdoor dining areas
- Improve energy efficiency and sustainability including installation of energy efficient lighting and systems, solar panels, battery storage, electric fleet, buses and electric vehicle charging stations
- Federal and State-mandated Americans with Disabilities Act (ADA) accessibility upgrades district-wide including site access, walkways, parking, staff and student restrooms, relocation of some existing electrical devices, drinking fountains, playground equipment and classrooms

Furnishing and Equipping; Incidental Expenses. Each of the bond projects described in this Bond Project List include the costs of furnishing and equipping such facilities, and all costs which are incidental but directly related to the types of projects described above.

Examples of incidental costs include, but are not limited to: costs of design, engineering, architect including DSA fees, legal and other professional and consultant services including fees relating to litigation, facilities assessments, inspections, site preparation, utilities, landscaping, construction management by third parties, general contractors and/or District personnel, and other planning and permitting, environmental review, rezoning and municipal license fees if any, legal, accounting and similar costs; independent annual financial and performance audits; a customary construction contingency; demolition and disposal of existing structures; the costs of interim housing and storage during construction including relocation and construction costs incurred relating to interim facilities; rental or construction of storage facilities and other space on an interim basis for materials and other equipment and furnishings displaced during construction; costs of relocating facilities and equipment as needed in connection with the projects; interim classrooms and facilities for students, administrators, and school functions, including modular facilities; all federal, state and locally-mandated safety upgrades; the costs of new or expanded infrastructure; the cost of providing parking and other facilities to accommodate new or expanded facilities; addressing any unforeseen conditions revealed by construction/modernization and other necessary improvements required to comply with existing building codes, including the Field Act; complying with all access requirements of the Americans with Disabilities Act and similar laws and regulations; costs of the election including other costs arising directly from the bond measure; litigation costs; project construction oversight, management and administration during the duration of such projects including by District personnel, and bond issuance costs.

Alternations to Scope and Nature; New Construction. The School Board is hereby authorized to alter the scope and nature of any of the specific projects described above as required or recommended by new conditions, discoveries or any other factors including economic factors and/or factors relating to the most effective delivery of the District's educational programs that may become apparent during the course of facilities planning, design and construction. In the event that the School Board determines that a modernization or renovation project is in the best interests of the District and its students to be undertaken as new construction based on cost or

safety considerations or other compelling factors, this bond measure authorizes said project to be undertaken in whole or in part as new construction, including land acquisition, relocation and construction at a new or alternative site, and/or demolition and reconstruction and/or repurposing on the original site, including an expanded site, and all costs relating thereto. In addition, to accomplish any of the projects included on the above list, this measure authorizes the acquisition of real property, including necessary rights of ways or other real property interests.

Interim Financing Included; Joint Use Projects Authorized. In addition, authorized projects include reimbursements for paid project costs and paying and/or prepaying interim or previously obtained financing for the types of projects included on the project list, such as bond anticipation notes or lease financings including certificates of participation relating to facilities projects and/or equipment previously financed. Finally, projects on this list may be undertaken and used as joint use projects with other public agencies.

Unforeseen Circumstances; Limited Funding Sources. Many factors may impact the District's ability to address each of the projects described herein, including but not limited to construction costs, supply chain issues which can cause project delays, labor shortages, unknown environmental factors or site conditions, overall facilities needs and related costs which exceed available bond funding sources, among others. The District is unable to anticipate all circumstances which may prevent some of the projects listed above from being undertaken or completed. Approval of the District's bond measure does not guarantee that all of the identified projects within the Bond Project List will be funded beyond what can be completed with funds generated by this bond measure. The District plans to pursue additional funding such as State matching funds, if available, to address its facilities needs.

Project List Not in Order of Priority; Board Determines Prioritization. The order in which projects are listed in the foregoing Bond Project List does not suggest an order of priority. Project prioritization is vested in and will be determined by the District Board.

Interpretation. The terms of this Bond Measure and the words used in the Bond Project List shall be interpreted broadly to effect the purpose of providing broad and clear authority for the officers and employees of the District to provide for the school facilities projects the District proposes to finance with the proceeds of the sale of bonds authorized by this proposition within the authority provided by law, including Article XIII A, Section 1(b)(3) of the California Constitution, Education Code Section 15000 *et seq.* and the Strict Accountability in Local School Construction Bonds Act of 2000. Words used in the Project List such as repair, improve, upgrade, expand, modernize, renovate, and reconfigure are used to describe school facilities projects in plain English but are not intended to expand the nature of such projects beyond what is authorized by law. The Bond Project List does not authorize, and shall not be interpreted to authorize, expending proceeds of the sale of bonds authorized by this measure for current maintenance, operation or repairs.

Severability. The District Board hereby declares, and the voters by approving this Bond Measure concur, that every section and part of this bond proposition has independent value, and the District Board and the voters would have adopted each provision hereof regardless of every other provision hereof. Upon approval of this measure by the voters, should any part be found by a court of competent jurisdiction to be invalid for any reason, all remaining parts hereof shall remain in full force and effect to the fullest extent allowed by law, and to this end the provisions of this bond measure are severable.

IMPARTIAL ANALYSIS OF MEASURE B-24

Bonds are financial instruments used to borrow money. Under the California Constitution, school districts may issue bonds if approved by at least 55 percent of voters within the boundaries of the district who are voting on a measure to authorize the issuance of bonds. The bonds are sold to the public and constitute a debt of the district. The principal and interest on the bonds are repaid by an annual property tax levy on all taxable real property within the jurisdiction of the school district, calculated on the current assessed value of each property (“an *ad valorem* tax”).

The Board of Trustees of the Atascadero Unified School District (“the District”) has placed Measure B-24 on the ballot, proposing the sale of bonds in an amount not to exceed \$110 million at interest rates not to exceed legal limits. The District’s Tax Rate Statement, included in the voter information guide that was mailed to voters of the District, reflects an estimate of the maximum property tax levies required to service the bonds.

Proceeds from the sale of the bonds (i.e., funds generated by the bonds) may only be used for the purposes identified in the measure, which may be described generally as being for the construction, modernization, reconstruction, rehabilitation, replacement and other improvements to school facilities of the District. (The specific types of improvement projects are more fully described in the full text of the measure.) The law prohibits the use of bond proceeds to pay for teacher and administrator salaries or other operational expenses.

Approval of the measure does not guarantee that all proposed projects to be improved with bond proceeds will be funded beyond the local revenues generated by the measure. The District’s proposal for the projects may assume the receipt of matching state funds, which could be subject to appropriation by the Legislature or approval of a statewide bond measure.

As required by law, the District must follow certain accountability provisions to oversee the funds collected and expended, including the establishment of an independent citizens’ oversight committee, the annual completion of performance and financial audits, and issuance of an annual report detailing the proceeds received by the sale of the bonds and the expenditures made. All of these requirements are reflected in the full text of measure.

The District’s Tax Rate Statement provides the District’s best estimate of the highest tax rate to be levied at \$49 per \$100,000 of assessed valuation while the bonds are outstanding. The final fiscal year in which the tax is anticipated to be collected is 2054-55.

A “yes” vote on this measure is a vote in favor of the issuance of \$110 million in general obligation bonds to be used for the purposes set forth in Measure B-24.

A “No” vote on this measure is a vote against the issuance of \$110 million in general obligation bonds for the purposes set forth in Measure B-24.

TAX RATE STATEMENT OF MEASURE B-24

An election will be held in the Atascadero Unified School District (the "District") on November 5, 2024, to authorize the sale of up to \$110 million in bonds of the District to finance school facilities as described in the measure. If such bonds are authorized and sold, principal and interest on the bonds will be payable only from the proceeds of *ad valorem* tax levies made upon the taxable property in the District. The following information is provided in compliance with Sections 9400-9404 of the Elections Code of the State of California. Such information is based upon the best estimates and projections presently available from official sources, upon experience within the District, and other demonstrable factors.

Based upon the foregoing and projections of the District's assessed valuation, the following information is provided:

1. The best estimate of the average annual tax rate which would be required to be levied to fund this bond issue over the entire duration of the bond debt service, based on a projection of assessed valuations available at the time of filing of this statement, is \$45.19 per \$100,000 of assessed valuation. The final fiscal year in which the tax is anticipated to be collected is 2054-55.
2. The best estimate of the highest tax rate which would be required to be levied to fund this bond issue, based on a projection of assessed valuations available at the time of filing of this statement, is \$49.00 per \$100,000 of assessed valuation. It is estimated that such rate would be levied in fiscal year 2025-26 through 2049-50.
3. The best estimate of the total debt service, including the principal and interest, that would be required to be repaid if all the bonds are issued and sold is approximately \$191.8 million.

Voters should note the estimated tax rate is based on the assessed value (not market value) of taxable property on San Luis Obispo County's official tax rolls. In addition, taxpayers eligible for a property tax exemption, such as the homeowner's exemption, will be taxed at a lower effective tax rate than described above. Property owners should consult their own property tax bills and tax advisors to determine their property's assessed value and any applicable tax exemptions.

The attention of all voters is directed to the fact that the foregoing information is based upon projections and estimates only, which amounts are not maximum amounts or durations and are not binding upon the District. The actual debt service, tax rates and the years in which they will apply may vary from those used to provide the estimates set forth above, due to factors such as variations in the timing of bond sales, the par amount of bonds sold and market interest rates available at the time of each sale, actual assessed valuations over the term of the bonds, and other factors. The date and amount of bonds sold at any given time will be determined by the District based on the need for project funds and other considerations. The actual interest rates at which the bonds will be sold will depend on conditions in the bond market at the time of sale. Actual future assessed valuations will depend upon the amount and value of taxable property within the District as determined by the San Luis Obispo County Assessor in the annual assessment and the equalization process.

IMPARTIAL ANALYSIS OF MEASURE L-24

The City Council of the City of Atascadero has determined to place a ballot measure on the November 5, 2024 general election ballot. If approved by the voters, Measure L-24, entitled **“Atascadero Local Roads and Vital Services Funding Extension Measure”**, would amend the Atascadero Municipal Code to extend the City’s existing Measure F-14 retail transactions and use tax, sometimes commonly referred to as a sales tax, as authorized by the State Legislature under Revenue and Taxation Code Section 7285.9.

This measure would continue the tax rate at one-half percent (.50%). At this rate, for example, a retail transaction \$100 in value would generate a tax of fifty cents. The current sales tax within the City, including other state and local sales taxes, is eight and three-quarters percent (8.75%), which would remain the same if voters approve Measure L-24. The proposed tax would be imposed upon the sale of all tangible personal property sold at retail within the City. This measure would authorize the City to contract with the State Department of Tax and Fee Administration to administer and collect the tax.

This measure requires all tax proceeds to be deposited into the City’s General Fund to be used for such general municipal governmental purposes as the City Council shall direct. Among such purposes are repair of neighborhood roads, aging infrastructure, along with other vital City needs. The City would not be required to use the revenues raised by the measure for any special purpose or for any particular program or service. The City estimates that the annual revenue to the City generated by this measure would be approximately three million dollars.

Measure L-24 would continue the existing fiscal accountability provisions from Measure F-14 to assist citizens in assessing if the tax revenues have been used in meeting community priorities. These provisions include: 1) a permanent "Citizens' Oversight Committee" to annually review revenues and expenditures from the collection of the tax; 2) an Annual Road Report prepared by the City and submitted to the Oversight Committee for review; 3) Oversight Committee findings and conclusions submitted to the City Council; and 4) an annual audit of the City's finances by an independent certified public accountant that includes the amount generated by the measure and how it was used.

This measure would provide several exemptions and exclusions from the tax. It would prohibit the issuance of any injunction to prohibit the collection of the tax. This measure will only become effective if approved by a majority of those electors voting on the measure. The measure provides that the proposed tax would remain in effect until repealed by the voters.

A **YES** vote approves the measure.

A **NO** vote rejects the measure.

IMPARTIAL ANALYSIS OF MEASURE M-24

The City Council of the City of Atascadero has determined to place a ballot measure on the November 5, 2024 general election ballot to place before the voters the question of whether the City Treasurer should be an appointed rather than an elected position.

State law requires each California city to have a City Treasurer. City Treasurers may be either elected or appointed. In Atascadero, the City Treasurer is currently elected and serves a four-year term. State law also establishes the qualifications for a City Treasurer, requiring that the person elected to this position must be a registered voter and resident of the City. There are no requirements that candidates for this office have any specific education, certification, or experience.

State law provides that City Treasurers are responsible for overseeing municipal finances. They must comply with state laws governing the deposit and handling of public funds and provide written accountings of all municipal funds. The day-to-day duties associated with the office of City Treasurer for the City of Atascadero, however, are currently handled by the Director of Administrative Services.

State law authorizes the City Council to place on the ballot the question whether the position of City Treasurer should be made appointive. If a majority of the voters approve making the position appointive, the City Manager will have the authority to appoint a person to this position upon the expiration of the current term of office, or earlier if there is a vacancy, and could appoint the person determined to be best qualified, regardless of that person's place of voter registration or residence. This measure would not change the duties of the City Treasurer as established pursuant to state law.

A **YES** vote approves the measure.

A **NO** vote rejects the measure.

ARGUMENT IN FAVOR OF MEASURE M-24

MAKING THE CITY TREASURER OF ATASCADERO AN APPOINTIVE POSITION

Atascadero is one of only two cities in SLO County that still elects its City Treasurer. In the five other cities, the City Treasurer is the full-time finance director already employed by the city, and is always an experienced and well-qualified individual. Our County's Grand Jury has recommended that all cities have appointed City Treasurers. We are out of sync with good government best practices by continuing to elect our City Treasurer.

While our current elected City Treasurer is highly experienced, having been the County Auditor Controller for many years before retiring and being elected City Treasurer, there is no guarantee of this level of qualification in the future.

State law allows no requirements for elected City Treasurers beyond being 18, a resident, and a registered voter in the City.

The City Treasurer receives \$400 a month and is eligible for health benefits. A person could run for City Treasurer just to receive benefits.

In 1994 a well-meaning but inexperienced Atascadero City Treasurer invested almost all City funds in the Orange County investment pool. The pool put money into very risky financial investments and lost over \$1 billion. This led to bankruptcy for Orange County and almost led to bankruptcy for the City of Atascadero.
