San Luis Obispo County Elections is sending this Verification Statement because you did not sign your vote-by-mail or provisional ballot identification envelope, **OR** your signature on your vote-by-mail or provisional ballot identification envelope does not match the signature on your voter registration record. **Your signature must match the signature on your voter registration record, which may include the signature appearing on your driver’s license or California identification card.**

YOUR VERIFICATION STATEMENT MUST BE RECEIVED AT THE COUNTY CLERK-RECORDER’S OFFICE NO LATER THAN WEDNESDAY, JUNE 24, 2026, AT 5:00 PM.

You may use one of the following options to return your completed statement:

- **Mail:** Mail your signed statement in the enclosed envelope to our office.
- **Email:** Email your signed statement to elections@co.slo.ca.us
- **Fax:** Fax your signed statement to our office at **(805) 781-1111**.
- **Drop Box:** Drop off your signed statement at any official ballot drop box through 8:00 PM on Election Day. A list of available drop box locations and hours can be found on the instructions included with your Vote-by-Mail ballot or on our website at www.slovote.gov.
***After Election Day**, our 24-hour secure drop box located at the Monterey entrance of the Katcho Achadjian Government Center will remain available until 5:00 PM on Wednesday, June 24, 2026.
- **Polling Location:** Drop off your signed statement at any polling place on Election Day prior to the close of polls at 8:00 PM. A list of polling locations can be found on the instructions included with your Vote-by-Mail ballot or on our website at www.slovote.gov.
- **In-Person:** Drop off your signed statement in person to the Clerk-Recorder’s office. Locations and days/hours of operation are as follows:

UNSIGNED IDENTIFICATION ENVELOPE STATEMENT & INSTRUCTIONS

READ THESE INSTRUCTIONS CAREFULLY BEFORE COMPLETING THE STATEMENT. FAILURE TO FOLLOW THESE INSTRUCTIONS MAY CAUSE YOUR BALLOT NOT TO COUNT.

1. We have determined either that the signature you provided on your vote-by-mail or provisional ballot identification envelope does not compare with the signature(s) on file in your voter record OR that you did not sign your ballot identification envelope.
2. You must sign your name where specified below and include your address. To ensure that your ballot will be counted, this completed Statement must be received by our office as soon as possible, but no later than 5 p.m. on Wednesday, June 24, 2026.
3. Place your completed Statement into the postage-paid return envelope if it is included with these instructions. If a return envelope is not included with these instructions, use your own mailing envelope addressed to your elections official. Mail, deliver, or have your completed Statement delivered to your elections official. If you mail your completed Statement using your own envelope, be sure there is sufficient postage and that the address of the election's official is correct.
4. If you do not wish to send your completed Statement by mail or have it delivered, you may submit your completed Statement by email or facsimile transmission to your elections official, or by other electronic means made available by your elections official, or submit your completed Statement to a polling place within the county or a ballot drop-off box before the close of the polls on Election Day.
5. Please note that the signature provided on the completed Statement may be added to your registration record to be used for signature comparison purposes in future elections.

I declare under penalty of perjury that I requested (or I received) and returned a vote-by-mail or provisional ballot and that I have not and will not vote more than one ballot in this election. I am a resident of the precinct in which I have voted, and I am the person whose name appears on the vote-by-mail or provisional ballot envelope.

I understand that if I commit or attempt any fraud in connection with voting, or if I aid or abet fraud or attempt to aid or abet fraud in connection with voting, I may be convicted of a felony punishable by imprisonment for 16 months or two or three years.

I understand that my failure to sign this Statement means that my vote-by-mail ballot or provisional ballot will be invalidated.
