To vote for a qualified write-in candidate, darken the OVAL to the LEFT of and write in the candidate's name on the Write-In line. To vote on a measure, darken the OVAL to the left of the word "Yes" or the word "No". All distinguishing marks or erasures are forbidden and make the ballot void. Changes condemnation rules. Fiscal Impact: Increased costs to many governments due to the measure's restrictions.
