To vote for a qualified write-in candidate, darken the OVAL to the LEFT of and write in the candidate's name on the Write-In line. To vote on a measure, darken the OVAL to the left of the word "Yes" or the word "No". All distinguishing marks or erasures are forbidden and make the ballot void.
