WHAT'S NEW THIS ELECTION

This election offers a myriad of changes for our voters both due to legislative actions and county processes.

ALERT: POLLING PLACE CHANGE

Polls for Cayucos Veterans Hall Relocated to Cayucos Community Church 60 S. 3rd St Cayucos, CA 93430 Consolidated Precincts 205 and 206

Due to the closing of the Cayucos Veterans Hall, the two precincts in Cayucos have been relocated to the Cayucos Community Church. When the Elections office was notified of the closing, sample ballots and voter information guides had already been printed with the Cayucos Veterans Hall as the designated location. Efforts are underway to inform voters of this change of venue.

NEW POLLING PLACES- VOTERS NEED TO CHECK POLLING PLACE LOCATION BEFORE HEADING OUT ON ELECTION DAY- In San Luis Obispo
County, we rely on public buildings for polling places. However the demand for these
buildings is great and although our local agencies, schools and churches are also
cooperative in ensuring we have sufficient space for Election Day activities, some
polling places may change from previous locations due to scheduling conflicts. As
always, it is important that voters check to make sure they know the polling place to
which they are assigned..

THE CALIFORNIA PRIMARY SYSTEM

TOP-TWO OPEN PRIMARY ACT: On June 8, 2010, California voters approved Proposition 14, which created the "Top Two Open Primary Act". This means candidates, regardless of their party preference, will appear on a single combined ballot and voters can vote for any candidate from any political party. This Act does not affect the election of President, which is still party specific.

The "Top-Two Open Primary Act" changes the way elections are conducted for all statewide (i.e. Governor, etc) and legislative offices (U.S. Senate, U.S. Representative, State Senate and State Assembly). These contests are now known as voter-nominated. In these contests, the two candidates who receive the highest and second-highest number of votes cast in the Primary Election will appear on the ballot at the General Election. The rules for Non-Partisan (State Superintendent of Schools, Judicial, County and other local jurisdictions) offices will remain the same.

NO PARTY PREFERENCE (NPP) (FORMERLY DECLINE TO STATE):

This is the designation for Decline to State or Non-Partisan Voters, along with all voters registered with unqualified political parties.

CANDIDATES STATE THEIR PARTY PREFERENCE: The primary contest for voter nominated offices is no longer conducted to select the party's nominee for an office, instead these candidates are nominated by the voters. All candidates

are required to state their party preference as indicated on their voter registration and this preference is printed on the ballot to the right of the candidate's name. If a candidate did not state a party preference on their voter registration it will be listed as Party Preference: None. The party preference of the candidate does not imply an endorsement of the party listed, however the parties are allowed to provide their endorsements and have those endorsements printed in the county sample ballot booklet at no charge to the party.

PARTY REGISTRATION STILL MATTERS: Because the Presidential nominee contest continues to be a partisan office, only those voters who are registered with a specific party can vote that party's ballot (with the exception of Cross-over voters- see below). This is also the case for the election of a Partisan Party's Central Committee or County Council Members. Voters registered with a qualified political party are not eligible to cross over to any other party's ballot.

CROSSOVER VOTING: Due to the Presidential primary contest, the ballots for the 2016 Primary Election will be comprised of 6 different party ballots and a Non-Partisan ballot. Voters who are listed as NPP have the option to participate in the election with the Non-Partisan ballot (no Presidential Contest) or cross over and request a party ballot from the parties allowing those voters to participate. The parties allowing NPP participation are the American Independent Party, the Democratic Party, and the Libertarian Party.

VOTE BY MAIL BALLOTS

REQUEST VOTE BY MAIL BALLOT BY PHONE: State legislation now allows a voter to request a vote by mail ballot by calling the elections office. Each voter must request their own ballot and the elections staff will confirm pertinent information before the request can be filled. This change will make it easier for voters to request a ballot, particularly when the deadline for requesting a ballot is looming.

However, Elections Code requires NPP voters who desire to receive a cross-over ballot must "personally affix" the name of the political party ballot in their request. In other words, a voter must complete the vbm request postcard in their sample ballot or make a request in writing and send it to the Clerk-Recorder, or visit the Clerk-Recorder's offices in San Luis Obispo or Atascadero and complete the request form in person.

EXTENSION OF DEADLINE FOR VOTE BY MAIL BALLOTS

New legislations allows county election officials to count vote by mail ballots that are postmarked by Election Day and received within three business days after Election Day. As a result of this new legislation, counties are allowed to open and process vote by mail ballots as early as ten business days before the election instead of the seven days allowed earlier. Also, counties are allowed to up thirty days to complete the canvass of the vote.

EXPANDED OPTION FOR MILITARY AND OVERSEAS VOTERS

It has long been a challenge to get vote by mail ballots to citizens living overseas and military voters, particularly those serving in areas with limited mail delivery. By law, ballots can be provided these voters 60 days before an election, but even with the extra time to mail the ballot, voters can be disenfranchised. To help alleviate this situation and efficiently get ballots to those serving our country, San

Luis Obispo County has partnered with Democracy Live on Live Ballot, a program which allows these voters to securely access their ballot and sample ballot information online. Once a voter notifies us that they wish to participate in Live Ballot, they receive an email notification that the information is available. They can then sign in, access the information specific to their ballot, print and mark the ballot and return it via mail (at no cost to the voter) or if circumstances permit, return it via fax.

WEBSITE CHANGES AND NEW FEATURES

NEW URL- The election information can now be accessed using **www.slovote.com**. This will link directly to the election page of the County Clerk-Recorder website.

ON-LINE VOTER REGISTRATION

Thanks to a collaborative effort between county registrars, the Secretary of State and Department of Motor Vehicles, voters can now register to vote on-line. The voter enters his or her information in the secure system and, if a match is found with the DMV database, the voter's information and signature will be forwarded to the appropriate county elections office. If there is no match found, the voter will be prompted to print the registration form, sign it and return it to their local elections office. This new system makes voter registration convenient and accessible to voters, especially as registration deadlines approach. The system has proved very popular. Leading up to the 2012 General Election, over 5,000 on line registrations were received in the last three weeks and over 1,000 received on the deadline. Registering online has the double benefit of being convenient for the voter, but beneficial to the elections office since the data keyed in by the registrant populates the county's database, thereby reducing the manual data entry associated with forms and the inherent errors caused by illegible information and computer entry mistakes. 
To access the information, the voter is required to enter their birthdate, last 4 digits of their CA driver's license and the numbers of their street address. If an exact match is found, their registration status will be confirmed, their vote-by-mail ballot status information for the current election and the districts in which they reside will be displayed. To maintain voter confidentiality, the system will not display the voter's name or address but will merely confirm their registration status. The system will be updated daily with both registration and vote-by-mail status information. If the voter is unable to find the information on the web, they can continue to contact our office by phone at 781-5228 or by email at elections@co.slo.ca.us.

Candidates with committees are required to file 2 pre-election campaign reports as well as contribution reports if they receive over \$1,000 from a single source. 
Campaign Finance Disclosures are now available online by visiting NetFile Public Portal for Campaign Finance Disclosures webpage

The portal allows you to search by name, id or all filings by date. The address information of donors has been redacted on the reports submitted on the web, however, the unredacted version is still available by visiting the offices of the Clerk-Recorder.



ACCESSIBILITY FEATURES AVAILABLE ON WEBSITE

With funding from a Help America Voter Act grant, the County Clerk-Recorder has photographed all polling places in the county and documented the accessibility features, including parking, path of travel and equipment that can be used by voters with special needs to access their polling place. Voters will also be able to view a sample of their ballot and get directions to their polling place. These features can be found in the polling place lookup feature on the Clerk-Recorder's website (www.slovote.com) and will be a valuable tool to help voters easily identify their polling place and how to navigate to the room where the polls are located.



AUDIO-ENABLED SAMPLE BALLOT AND VOTER INFORMATION GUIDE

Furthermore, voters will now have access to an audio-enabled sample ballot and voter information guide. By clicking on the links for an audio-enabled materials, voters will be able to use their screen reading devices so that the ballot (contests, candidates, measure) can be read to them. Materials in the voter information guide are also available (candidate statements, impartial analysis and arguments for/against measures).

POLITICAL PARTY CENTRAL COMMITTEES AND COUNTY COMMITTEES INSUFFICIENT NOMINEES

All political party central committees and county councils are elected at the primary election. These offices remain a partisan office and are open only to candidates and voters registered with the specific party. The following seats were open for each of the political parties: Democratic- 21 members, Republican- 25 members, - these two parties elect their central committees by supervisorial district and Green and Libertarian – 7 members- elected at large throughout the county.

During the nomination period, three races are contested: Democratic, 2nd District, Republican, 2nd and 5th Districts. These contests will appear on the respective partisan ballots. The remaining contests had nominees equal to or less than the number of positions in each contest. The candidates in these contests who filed the appropriate papers will be declared appointed in lieu of election by the Board of Supervisors.

PLACEMENT ON THE BALLOT/ROTATION OF CANDIDATES

The order in which candidates' names appear on the ballot is determined by a random drawing of the 26 letters of the alphabet. This random drawing is conducted by the Secretary of State and the County Clerk-Recorder prior to each election. The random drawing for this election was held on March 17, 2016.

Election law also requires the names of candidates for some offices to change positions, such as federal, statewide and county wide offices (i.e. Governor, United States Senator, Secretary of State, United States Representative). The purpose of the rotation is so one candidate's name does not always appear first, or last, on <u>all</u> of the ballots for the races.

As required by state law, names of candidates for certain offices are rotated on the ballot as follows:

OFFICE	ROTATION
Statewide Offices, United States Representative, Board of Equalization member	Candidates' names are arranged in accordance with the alphabetical drawing beginning with the lowest numbered Assembly District in the State or Congressional or Board of Equalization District. Thereafter, for each succeeding Assembly District, the candidate's name appearing first is placed last; the order of the other names remains unchanged. Since San Luis Obispo County is represented by only one Assembly District, these candidates will be in the same order on every ballot in this county.
State Senate and State Assembly	For multi-county districts, such as the senate and assembly each county conducts a random drawing and the candidates' names are arranged in accordance with each county's alphabetical drawing- no other rotation.

VOTE -BY- MAIL BALLOT INFORMATION

History: Absentee ballots were first made available by the North for the soldiers and sailors in the Civil War. California first allowed absentee voting in 1920 for those who were ill or disabled, lived too far from the polls and other special circumstances. In 1978 legislation was passed which allowed universal absentee voting. As a result of this change allowing any person to vote absentee (now vote-by-mail), it has become a very popular means to cast a ballot. See the chart on page 8 to track the trend of voters casting their ballots by mail. In 2002, permanent absentee voting was expanded to any voter upon request. There are currently over 98,500 permanent vote-by-mail voters in San Luis Obispo County totaling more than 64.7% of the total registered

voters.

How To Apply for a Vote-by-Mail Ballot:

The first day this office can issue a vote-by-mail ballot for the Primary Election is May 9, 2014 (29 days before the election). Vote-by-mail ballot requests must be received no later than May 31st in order for the ballot to be mailed to the voter. After that date, the voter must appear in the Office of the County Clerk-Recorder and complete an application indicating the reason they cannot appear at the polls on Election Day. Vote-by-mail ballots may be requested in one of four ways:

By calling the County Clerk-Recorder's office and requesting a Vote By Mail
ballot at 805-781-5228.
By filling out and mailing the Vote by Mail Application on the back cover of the sample ballot booklet. Sample ballot booklets were mailed May 2.
By letter to the County Clerk-Recorder, 1055 Monterey St., D120 San Luis
Obispo CA 93408. The letter must state the voter's name, residence address, address to which the ballot should be sent and voter's signature.
In person at the County Clerk-Recorder's Office- in San Luis Obispo at the address above or for voters living in the North County, at our office in Atascadero- 5955 Capistrano Ave., Suite B. The office hours in Atascadero are 7:30-4:00.
By faxing a written request to the County Clerk-Recorder's Office at 781-1111.

To be counted, the voted ballot must be returned by the voter personally at any polling place in the county no later than 8:00 p.m. or if mailed, postmarked no later than Election Day and received by the Elections office within three business days of Election Day. Nevertheless, it is recommended that voters mail ballots a week prior to the election to ensure that the ballot will be received in time. The voter may also authorize a designated family member to return the voted ballot to any polling place in the county or to the County Clerk-Recorder's Office.

WEEKEND VOTING

The County Clerk-Recorder's Office will be open on the Saturday before the election from 9:00 a.m. to 2:00 p.m. to issue vote-by-mail ballots. Voters may vote the ballot in the office at the voting booths or have a family member return the ballot for them by 8:00 p.m. on Election Day.

PREPARING FOR THE ELECTION

THE READER'S DIGEST VERSION E-120 TO ELECTION DAY

The staff of the County Clerk-Recorder's Office begins preparation for a county wide election at least six months prior to Election Day and after that every day is counted as E-the number of days left. You could ask any employee in our office (and probably any candidate) how many days until the election and we won't even have to think twice to answer. Some of the important dates and the activities surrounding them are:

E minus number	Date	Activity
E-158	January 4, 2016	First day to issue signature in lieu of filing fees petitions to candidates to help defray their filings fees.
E-127	February 1	Letters sent to polling places
E-113	February 16	Opening of the nomination period.
E- 110	February 18	Initial letters sent to potential precinct workers for commitments to work on election day.
E-88	March 11	Close of the nomination period. After the close of nomination, the ballot layout and preparation begins. Proofing of the sample ballots and ballot information continues through early April. The vote-by-mail ballots are received by the end of April and the sample ballot mailing is completed around the same time.
E-70	March 29	Assignment letters to precinct workers that have been assigned to polling places.
E-60	April 8	60 day close. This is the initial target date for ensuring that the voter rolls are as updated as possible. Any voter registration in our office by that date is processed into the system and all changes and deletes are accomplished before officially closing our files. The 60 day close file is sent to the Secretary of State and the printer who prepares and mails San Luis Obispo County sample ballots. These names constitute the first mailing of state ballot pamphlets and sample ballot pamphlets. Any changes or anyone who registers between this date and the 29 day close of registration (May 9) will be mailed the voter information in the second mailing, scheduled for mailing the week of May 23.
E- 56 to E-14	April 11 – May 24	Write-in candidate nomination period.
E-40	April 28	Sample Ballot booklets are mailed to voters who have not signed up to be a permanent vote-by-mail voter or do not live in a mail ballot precinct.

E-43 to E-20	April 25-May 18	Testing of voting machines and ballot counting software. Certification to transmit
		election night results to the Secretary of State.
E-29	May 9	The "informed voter" close of registration as well as the first day to issue vote-by-mail ballots. Vote-by-mail ballots are mailed to the 76,500 voters who are signed up a permanent VBM voters and to those who live in mail ballot precincts. During the week of the close of registration, staff is busy processing voter registrations. These must be completed by the end of the week so new voters can be sent their sample ballot booklets and state voter information guides in a timely manner. While this is going on the voting booths and precinct supplies are being prepared for delivery to the county's 135 precincts and last minute changes to precinct worker assignments are made. During the month of May, staff is conducting 15 training sessions for the 700+ volunteers working at the polls.
E-15	May 23	Official close of registration. Anyone registered between May 10 and May 23 is eligible to vote however, the voter will not receive the state voter information guide or the county sample ballot booklet. The voter will receive a postcard indicating their polling place location and where they can obtain voter information.
E-15	May 23	Elections staff begins opening and preparing the vote-by-mail ballots for counting.
E-12	May 27	Elections staff begins counting the vote-by-mail ballots. No results are released until after the close of polls on Election Night.
E-7	May 31	Copy of ballot counting software is deposited with the Secretary of State.
E-7	May 31	Last day to mail vote-by-mail ballots to voters. After this day, a voter must appear in the office to receive a ballot. The final week before the election precinct supplies are distributed to the precinct inspectors.
E-6 to E Day	June 1 – 7	Vote-by-mail ballots can be requested in person at the Clerk-Recorder's Office.
E-2	June 5	Delivery crew picks up voting booths, ballot box and other equipment for delivery to polls
E-1	June 6	Delivery crews deliver and set up voting equipment at 76 polling places throughout the county.
E Day	June 7	Polls are open from 7:00 am to 8:00 pm Election day begins at 6:00 a.m. and should end around 1:00 am for the County Clerk-

		Recorder staff, although final election night results should be completed by 12:30 am
E+1	June 8	Delivery crew picks up and returns all voting equipment to the Elections warehouse. Election staff records number of outstanding vote-by-mail and provisional ballots
E+2	June 9	Official Canvass begins – see process outline below.
E+30	July 7	Official canvass completion and election certification deadline.

ELECTION NIGHT PROCEDURES

After the last voter in line at 8:00 has cast their ballot, the precinct workers pack up and return precinct materials and the voted ballots in sealed containers to either the regional collection centers or directly to the Elections office in San Luis Obispo. Elections staff verifies that all ballots and required materials have been received and that security measures have been followed prior to releasing the precinct workers. All ballots and materials are brought to the Government Center in San Luis Obispo for ballot counting and secure storage.

SPEED OF BALLOT COUNTING ELECTION NIGHT

As in the past, results of early vote-by-mail ballots (those received by Saturday, June 4th) will be available immediately after 8:00 pm. The ballots will be counted centrally in the County Clerk-Recorder's office on Election Night instead of at the polls during the day. The ballots will be transported from our regional collection centers in Paso Robles, Atascadero, Morro Bay and Arroyo Grande to the Government Center and fed through the Accuvote scanners by county staff. Final election night results should be available by 12:30 a.m.

INCOMPLETE BALLOT COUNTING ELECTION NIGHT

The public is often surprised on the day after a major election when they learn that there are as many as 15,000 ballots county wide remaining to be counted after the election. There are three categories of ballots which cannot be processed on Election Night:

- 1. VOTE-BY-MAIL BALLOTS TURNED IN ELECTION DAY- Many vote-by-mail voters wait until Election Day to make their voting choices and then drop off their ballots at a polling place. These ballots are received after the polls close on election night. All vote-by-mail ballots must be pre-processed before they are counted- including entering that the ballot has been returned to protect against double voting and verifying the voter's signature on every envelope against the signature on file in our office.
- 2. PROVISIONAL BALLOTS- Provisional Ballots are voted at the polls when the precinct workers cannot determine the voter's eligibility to vote in that election. Provisional ballots are sealed in special envelopes and must be individually researched and verified at the County Clerk-Recorder's Office before the ballots is counted or rejected in accordance with election laws. There are several reasons why someone would be required to vote a provisional ballot at the

Voter is listed as having received a vote-by-mail ballot but does not have the ballot to surrender at the polls. Voter is voting under the fail safe provisions of the National Voting Rights Act. A fail safe voter is a registered voter in this county, who has moved and did not re-register to vote or notify the elections office of his/her change of address. Voter insists on voting a ballot for a party other than the party indicated in the roster. Voter's name is not on the roster, but the voter insists they are eligible to vote in that precinct.

□ Voter is required to show identification as a first time voter under the Help America Vote Act and cannot produce the required identification.

In each of these instances, the elections staff must verify that the voter is eligible to vote the ballot they were issued and verify the voter's signature prior to opening the ballot for processing.

 DAMAGED BALLOTS: Election Day ballots that are unable to be processed by the ballot scanners because of stray marks, overvotes or tears and need to be duplicated prior to counting.

The majority of the vote-by-mail ballots are counted by the Friday after the election. Some of these ballots require additional processing and their count is completed in the week following the election. Furthermore, the ballots postmarked by Election Day and received within the three days following the election will be processed during the following week as well. The provisional and damaged ballots are normally counted just prior to certification of the results. Results are released as a count is completed and a schedule of counting dates and times will be posted on the County Clerk-Recorder website after the election.

WRAPPING UP THE ELECTION WHAT IS THE OFFICIAL CANVASS?

The election canvass process is an internal audit required by state law to ensure the accuracy of election results. California election law allows 30 days to conduct the official canvass of final election results. The official canvass begins on Thursday, June 9 and must be concluded within 30 days, no later than July 7. San Luis Obispo County normally completes the official canvass within 21-25 days of the election. All aspects of the canvass are open to the public. The canvass concludes with the certification and issuance of official election results. Listed below are the major components of the official canvass.

Completion of the count for vote-by-mail and provisional ballots- as described above.

Election Materials accounted for- Staff verifies that all elections materials have been returned and accounted for and that precinct workers have correctly followed Election Day procedures.

As part of the official canvass, the signatures in each roster are re-counted and the number of signatures indicated by the inspector on the roster is compared to the number of ballots tabulated by the computer tally system. Any discrepancies are investigated. The balancing process normally takes 10 days to complete.

Manual Vote Tally- All voted ballots from at least 2 precincts (1% of the 137 precincts) are manually tallied for every contests and balanced against the computer counts to verify the accuracy of the election tally system. For any contest which is not on the ballot in one of those two precincts, an additional precinct's ballots are counted for that contest only. In addition, this same procedure is completed for 1% of the vote-by-mail ballots. The completion of the manual tally usually takes 2-4 days, depending on the number of contests on the ballot and the voter turnout.

Apply Voting History- All voters who voted at the polls are given credit for voting.

Account for all ballots- The number of precinct and vote-by-mail ballots printed, issued and unused are accounted for and balanced. Discrepancies are investigated.

Certify Election and report to the Secretary of State - Registrar of Voters certifies the Election and sends the certification, statement of vote and supplemental statement of vote to the Secretary of State. Board item is prepared to present to the Board of Supervisors.

PRESIDENTIAL PRIMARY ELECTION

Presidential Nominee Contest is "Party-Nominated"

- The Presidential Primary contest continues to be a partisan office, elected by voters affiliated with each party.
- Only those voters who are registered with a specific party can vote that party's ballot (with the exception of cross over voters – see below).
- Voters registered with a qualified political party cannot vote another party's ballot.
- Check on your voter registration status and party affiliation at www.slovote.com
- The rules for non-partisan contests (i.e. County Supervisor) did not change and will appear on every ballot.

Cross Over Voting

- The ballots are comprised of 6 different party ballots and a Non-Partisan ballot. Voters who are listed as No Party Preference (formerly Decline to State) voters can vote the Non-Partisan ballot (no Presidential race) or cross over and vote a party ballot from the <u>American Independent</u>, <u>Democratic</u>, and <u>Libertarian</u> parties only.
- To vote a <u>Green</u>, <u>Peace and Freedom</u>, or <u>Republican</u> party ballot, one must be registered with the respective party.
- Again, if you are already affiliated with one of the parties listed above, you will be issued that party's ballot.

Top Two "Voter-Nominated" Contests

- Applies to U.S. Senate, U.S. Congressional, Statewide and State legislative offices.
- All voter-nominated contests will appear on every ballot. Candidates, regardless of their party preference, will appear on a single combined ballot and voters can vote for any candidate from any political party.
- Only the two candidates who receive the highest number of votes cast in the Primary Election are on the ballot for the General Election.
- Write-in candidates are not allowed for these contests during the General Election.

Party Preference & Political Party Endorsement

- The political party preference, or no party preference, as indicated on the candidate's voter registration is listed next to or below the candidate's name on the ballot.
- The party designation shown is for the information of the voters only. It is not an endorsement by the party designated.

Parties may provide a list of candidates who have received the official endorsement of the party for printing in this booklet.

AN ORDINANCE CALLING FOR AN ELECTION WITHIN THE CAYUCOS FIRE PROTECTION DISTRICT ("DISTRICT"), SAN LUIS OBISPO COUNTY, FOR THE PURPOSES OF SUBMITTING TO THE QUALIFIED VOTERS OF THE DISTRICT THE PROPOSITION FOR REPEALING THE PRIOR SPECIAL TAX AND APPROVING A NEW SPECIAL TAX FOR FIRE PROTECTION, FIRE PREVENTION AND OTHER FIRE DEPARTMENT SERVICES RELATED TO THE PROTECTION OF LIVES AND PROPERTY WITHIN THE DISTRICT

ORDINANCE NO. 2015- 01

WHEREAS, pursuant to §§ 13800 et seq. of the California Health and Safety Code, the Cayucos Fire Protection District ("District") provides fire protection, fire prevention, and emergency medical or rescue services within the District boundaries; and

WHEREAS, pursuant to Ordinance adopted December 5th, 2012 and subsequently approved by the voters within the District, there is currently imposed a Special Tax, (herein "2012 Special Tax") for fire protection, fire prevention, and emergency medical or rescue services within the District in the amount of \$25.00 per unit of benefit; and

WHEREAS, the 2012 Special Taxes have increased in fiscal years 2014/2015 and 2015/2016 as authorized in Subsection B; however the District Board of Directors has determined that the current proceeds from the 2012 Special Tax are inadequate to provide fulltime fire protection services related to the protection of lives and property within the District; and

WHEREAS, Article XIII C of the California Constitution, § 13911 of the Health and Safety Code and § 50075 et seq. of the Government Code authorizes the voters within the District to approve and adopt a Special Tax for fire protection services, rescue services, emergency medical services, and any other services relating to the protection of lives and property within the District; and

WHEREAS, the District Board of Directors has determined that the public interest in necessity demand that the special tax amount be increased so that the District is able to provide fulltime fire protection services for the protection of lives and property within the District; and

WHEREAS, the District Board of Directors desires to submit to the qualified voters of the District the question of whether to repeal the 2012 Special Tax and adopt a new Special Tax for fulltime fire protection services, rescue services, emergency medical services, and other services, including training, relating to the protection of lives and property within the District; and

WHEREAS, the District Board of Directors intends to impose the new Special Tax as authorized by this Ordinance only in the event that two-thirds (2/3's) of the qualified voters within the District approve the measure imposing the new Special Tax.

NOW THEREFORE, THE PEOPLE OF THE CAYUCOS FIRE PROTECTION DISTRICT DO ORDAIN AS FOLLOWS:

<u>Section 1</u>: **Imposition of Special Tax.** Except as otherwise provided in this Ordinance, a new special tax to fund fulltime fire prevention and protection services is hereby imposed on every parcel of land within the Cayucos Fire Protection District (District). The tax shall be imposed each fiscal year by the District Board of Directors to furnish fulltime fire prevention, fire protection, and other services as provided in Section 2 of this Ordinance. The tax imposed by this Ordinance shall be a tax upon each parcel of property, and the tax shall not be measured by the value of the property.

<u>Section 2:</u> Special Tax Purpose. The proceeds of the Special Tax imposed by this Ordinance shall be placed in a special fund for the purposes of obtaining, furnishing, operating and maintaining fire department equipment and/or apparatus, real property and facilities, for fire protection services, rescue services, emergency medical services, and other services, including training, relating to the protection of lives and property, for paying salaries and benefits to District personnel and for no other purpose.

<u>Section 3:</u> **Special Tax Account.** A special account shall be created in which the proceeds of the Special Tax shall be deposited.

<u>Section 4:</u> **Special Tax Report.** The District's Chief Financial Officer shall file an annual report with the District Board of Directors no later than January 1 of the year following the election and at least once a year thereafter, containing both of the following:

- A. The amount of the funds collected and expended; and
- B. The status of any projects or services authorized to be funded as identified in Section 2 of this Ordinance.

<u>Section 5:</u> Special Tax Amount. Subsequent to the end of each fiscal year, but prior to August tenth of the ensuing fiscal year, the Board of Directors at a public hearing, after considering public input, shall determine the precise amount of the Special Tax to be levied during the ensuing fiscal year, provided that such Special Tax will not exceed the maximum amount set forth in Section 6 below without the approval of two-thirds of the voters of the District voting on the guestion.

<u>Section 6:</u> **Maximum Tax Amounts.** The maximum amount of the tax imposed on each parcel of real property within the District pursuant to this Ordinance shall be determined as follows:

A. Commencing fiscal year 2016/2017 a maximum special tax rate of One Hundred Twenty-Five (\$125.00) per unit of benefit shall be imposed on each parcel in accordance with the following schedule to be adjusted each year thereafter not to exceed the increase authorized in sub-section B. below:

Example: As an example, a residential single family dwelling would be assessed four (4) benefit units at \$125.00 per unit for a total of \$500.00 in the tax year 2017/2018.

B. Commencing fiscal year 2017-2018 and each fiscal year thereafter, the special tax amounts specified by sub-section A above may be increased by the percentage by which the Consumer Price Index for All Urban Consumers in the Los Angeles-Orange-Riverside area published by the Bureau of Labor Statistics of the U.S. Department of Labor, or any successor to that index, increases in the twelve months prior to March of the year in which the adjustment is made. The District Fire Chief shall annually recalculate the maximum tax amounts pursuant to this sub-section B. and shall give notice of that determination to the District Board of Directors.

Section 7: **Exemptions**.

- A. To the extent required by California and Federal law the following parcels shall be exempt from the tax imposed by this Ordinance:
 - 1. Parcels owned by federal or state governmental agencies;
 - 2. Parcels owned by local governmental agencies;
 - 3. Parcels exempt from taxation by the District pursuant to the laws or constitutions of the United States and the State of California.
- B. Any person or entity claiming an exemption from the tax imposed by this Ordinance shall file a verified statement of exemption on a form prescribed by the fire Chief prior to June 30th of the first fiscal year for which the exemption is sought.

<u>Section 8.</u> **Administration and Appeals.** The District Fire Chief shall administer this Ordinance. Appeals of any determination of the Fire Chief shall be submitted in writing to the District Secretary not later than July 1st of the fiscal year for which the tax is imposed. The District Board of Directors shall consider the appeal and issue a decision to the appellant in writing.

<u>Section 9.</u> **Amendment of Ordinance.** The District Board of Directors is hereby authorized to amend this Ordinance for the purpose of carrying out the general purposes of this Ordinance, to conform the provisions of this Ordinance to applicable state law, to permit the County Tax Collector or another public official to collect the Special Tax levied by this Ordinance in conjunction with County taxes, or to re-assign the duties of public officials under this Ordinance. In no event, however, may the District Board of Directors alter the provisions of Sections 5 or 6, of this Ordinance without the approval of two-thirds of the voters of the District voting on the question.

<u>Section 10.</u> **Special Tax Election.** Pursuant to the provisions of the Election Code and District Resolution 2016-01, it is ordered that this Special Tax Election be conducted pursuant to the uniform District Election Law commencing with Election Code § 10500 on June 7th, 2016.

1) Consolidation of Special Tax Election. Pursuant to § 1055 of the Election Code and District Resolution 2016-01, it is ordered that the Special Tax Election be consolidated with such other elections to be held on June 7th, 2016 under State law within the territory of the District, and shall be held and conducted, and all other proceedings incidental to and connected with the election, shall be regulated and done, in accordance with the provisions of law regulating regularly scheduled elections. The precincts, polling places for said precincts in the County of San Luis Obispo, and persons appointed and designated to serve as election officers for said election will be those determined, designated, and appointed pursuant to State law by the Registrar-Recorder/County Clerk of the County of San Luis Obispo (the "Registrar"). The District, by Resolution, has requested that the election be consolidated with the Statewide Election and that the Registrar conduct the election as well as performs the various other services required by law on behalf of the District. The District has determined the full text of the measure shall be printed in the sample ballot booklet. The full text will also be posted and copies available at the District Office and on the County Clerk-Recorder's website and a copy of the full text will be mailed to any voter upon request.

Section 12. Ballot Question. Pursuant to the California Elections Code, the abbreviated statement of the proposition, as it appears on the ballot is as follows:

"Shall Measure ____ be approved, which repeals the current 2012 Special Tax and imposes a new Special Tax at one hundred twenty-five (\$125.00) per unit of benefit, to be adjusted each year thereafter by the change in the consumer price index, for fire protection, rescue, emergency medical services, and other services relating to the protection of lives and property, and for no other purposes as provided in Ordinance 2015- 01".

Section 13. **Notice of Hearings.** In the absence of state law specifying the procedures for giving notice, notice of any public hearing held pursuant to this ordinance shall be given by publishing twice pursuant to Government Code Section 6066 in at least one (1) newspaper of general circulation within the District. This notice shall include the date, time, and place of the public hearing, a general explanation of the matter to be considered, and a statement of where additional information may be obtained.

Section 14: Collection of Special Tax. The Special Tax imposed by this ordinance shall be collected by the San Luis Obispo County Tax Collector at the same time as and along with, and shall be subject to the same penalties and appeal process, as property taxes collected by said Tax Collector.

Section 15. **Two-Thirds Approval; Effective Date**. This Ordinance and the proposed Special Tax Increase shall be effective only if approved by two-thirds (2/3) of the voters voting thereon and shall go into effect ten (10) days after the vote is declared by the District. The new Special Tax, if approved, shall commence with Fiscal Year 2016/2017.

<u>Section 16.</u> **Notice of Holding Election.** Notice of the time and place of holding the election is given and the District Secretary is authorized, instructed and directed to give further or additional notice of the election, in time, form and manner as required by law.

Section 17. Conduct of Special Tax Election. In all particulars not recited in this Ordinance, the election shall be held and conducted as provided by law for holding Special Tax Elections. The District Secretary shall make this Ordinance readily available for public inspection.

<u>Section 18.</u> **Repeal of 2012 Special Tax.** Upon approval of this Ordinance as provided in Section 15 above, the 2012 Special Tax shall be repealed in its entirety.

<u>Section 19.</u> **Severability.** If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held to be invalid or unenforceable by a court of competent jurisdiction, the remaining sections, subsections, sentences, clauses, phrases, or portions of this Ordinance shall nonetheless remain in full force and effect.

Section 20. Recitals. That the recitals set forth hereinabove are true, correct and valid.

<u>Section 21.</u> **Effective date.** This Ordinance and the proposed Special Tax Increase shall be effective only if approved by two-thirds (2/3) of the voters voting thereon and shall go into effect ten (10) days after the vote is declared by the District. The new Special Tax, if approved, shall commence with Fiscal Year 2016/2017.

IMPARTIAL ANALYSIS OF MEASURE C-16

This measure is intended to determine whether the special tax currently levied within the Cayucos Fire Protection District ("District") to fund fire prevention and protection services should be repealed and a new special tax imposed for the purposes stated in the measure.

Article XIIIC, section 2(d) of the California Constitution, Health and Safety Code section 13911, and Government Code section 50075 authorize the District to levy a special tax to fund the services set forth in Health and Safety Code section 13862, which include fire protection services, rescue services, emergency medical services and any other service relating to the protection of lives and property within the District, if approved by a two-thirds vote. The Board of Directors of the District ("the Board") has determined that revenue from a special tax approved by the voters of the District in 2012 to fund fire prevention and protection services is inadequate to fund the present needs of the District for these services. Therefore, the Board adopted Ordinance No. 2015-01 providing for the repeal of the special tax adopted in 2012 and the imposition of a new tax for the purpose of funding fire protection, rescue, emergency medical, and other services relating to the protection of lives and property within the District. In accordance with Article XIIIC, Section 2(d), the ordinance providing for the new tax will only become effective if approved by a 2/3rds vote of qualified voters.

If the measure is approved, the existing special tax of twenty-five dollars (\$25) will be repealed and, commencing fiscal year 2016-2017, a new special tax shall be imposed in an amount not to exceed the annual rate of one hundred and twenty-five dollars (\$125) per unit of benefit, to be increased annually thereafter only in accordance with increases in the consumer price index, as provided in the measure. The number of units of benefit applicable to the real property subject to the proposed new tax is set forth in the full text of the measure. In accordance with the terms of the measure, the Board will determine the precise amount of the tax to be levied during each ensuing fiscal year, provided that the tax shall not exceed the maximum authorized by the measure. If the measure is approved, the new special tax will be levied annually by the Board, and collected by the San Luis Obispo County Tax Collector in the same manner, along with, at the same time, and will be subject to the same penalties, as other property taxes collected by the Tax Collector.

A "yes" vote on this measure is a vote in favor of repealing an existing tax and imposing a new tax for the purposes of providing fire protection and prevention services within the District.

A "no" vote on this measure is a vote against repealing an existing tax and imposing a new tax for the purposes of providing fire protection and prevention services within the District.

ARGUMENTS IN FAVOR OF MEASURE C-16

The function of Cayucos Fire Department is to provide life safety and fire protection to the people and property owners of Cayucos. This requires adequate funding to supply the necessary equipment and personnel to address emergencies. A yes vote will enable your local district to continue to provide adequately staffed engines to respond.

Volunteer Fire departments are in decline nationwide, and this impacts Cayucos as well; as the demographics of the community have changed so has the ability to attract and retain volunteers. We are faced with the decision to transition to a full time paid fire department in order to meet the diverse and changing needs of the community and ensure adequate responses can be made to calls for service 24/7. The Cal Fire staffing contract for the winter months has become unsustainable with costs reaching nearly 50% of revenue. In order to meet the projected budget requirements for a full time department this bond measure is necessary for the future.

Timely response to an emergency is our highest priority and utilizing our own firefighters while maintaining local control through the elected officials of the Fire Protection Districts Board of Directors is our best option in order to maintain high standards and service delivery the community deserves.

Due to financial constraints we are faced with an equipment replacement problem needing to replace an engine immediately. We have foregone that replacement due to financial constraints.

This Board has reviewed alternative staffing and administrative possibilities, the least of which would cost the same as this measure requests while abdicating local control to the County. . Please vote YES on ballot measure C-16.
