Crime Victim's Bill of Rights* You have the Right to:

- Be treated fairly and with respect to your dignity and privacy.
- Be reasonably protected from the accused offender and from verbal, written, implied or physical harassment or threat.
- Be notified of court proceedings upon request.
- Attend all public court proceedings related to the offense, unless the court determines that your testimony would be materially affected if you heard other testimony at the trial.
- Confer with the prosecuting attorney upon request.
- Request the court to order restitution.
- Prepare a victim impact statement about the crime's emotional, physical and financial impact on you for inclusion in the pre-sentencing investigative report.
- Request and receive information about the conviction, sentencing, imprisonment and release of the offender.
- Receive information and referrals to programs that can assist you.

- Explanation of rights
- Assistance with court ordered restitution
- Case status/plea information
- Property return assistance (if recovered and used as evidence)
- Liaison with prosecuting attorney handling the case

- Determination of loss/ Victim Impact Report assistance



Information and Assistance for Victims of Property Crime

Court Terms

Arraignment: A court session at which a defendant is informed of the charge(s) and enters a plea of guilty or not guilty.

Pretrial Conference/Hearing: A hearing before a trial to facilitate settlement of a case.

Trial Setting Conference: A meeting between the judge, the deputy district attorney, and the defense attorney, setting a case for trial.

Pre-Preliminary Hearing (Felony only) or Readiness Conference: A hearing to confirm that everyone—witnesses, police, attorneys, etc. is ready for trial.

Preliminary Hearing (Felony only): A hearing where probable cause for pursuing the case is established.

Jury Trial: A legal proceeding in which the decision regarding the defendant's guilt is made by a group of citizens and concludes with a verdict.

People in the Courtroom


Defense Attorney: The attorney defending the defendant in a criminal prosecution.

Judge: An official with the authority and responsibility to preside in a court and make legal rulings.

Prosecuting Attorney: The attorney representing the People of the State of California in a criminal prosecution.

Victim Advocate: The person who provides information and assistance to victims or witnesses during the court process.

The Judicial Process



Criminal Justice System Terms

Arrest Warrant: A court order that directs a law enforcement office to arrest the person identified in the warrant.

Felony: A crime sufficiently serious to be considered punishable by death or incarceration in county jail or state prison.

In Screening: Under review by a deputy district attorney to determine if there is enough evidence to prosecute a case forwarded by an investigating agency.

Misdemeanor: A criminal offense, less serious than a felony, punishable by a fine and/or a county jail sentence of one year or less.

Plea Agreement: Negotiation between the defendant and the prosecutor in which the defendant agrees to plead guilty or "no contest".

Property Crime: *Non-injury crime to a person's property (anything owned by a person or entity).*

Restitution: Money paid to victims by the offender to compensate for harm or damage done.

Victim: Someone who has suffered as a result of another person's actions.

Victim Impact Report: A report used to record the losses to a victim as a result of a crime. Used to help determine restitution owed a victim.
