- 1. Meeting Introduction and Program Updates Maya Craig-Lauer
 - Program Updates
 - Grant Application for FY 24-25: PHEP and Plan Flu have been released, while the HPP grant is currently delayed but in progress.
 - We are working to submit our application.
 - This is a new 5-year grant cycle term with many new requirements.
 - The MRSE (Medical Response Surge Exercise) will be on June 12th. This drill involves the
 hospitals in the area to test a 20% patient surge. Monday, June 10th will be our
 Controller/Evaluator meeting for this exercise.
 - We are compiling a coalition wide AAR for the Earthquake Tabletop Exercise on May 9th.

- 2. HPP Updates Sara Schwall
 - CAHAN Redundant Communications Drill
 - The CAHAN drill was conducted on Thursday, May 30th. Through this drill, we found a
 major issue that our CAHAN emails were being marked as potentially suspicious and
 therefore not delivered. We are working with out IT department to resolve this issue.

- **3.** CA Mutal Aid System Javier De La Cerda Jr, Region I Regional Disaster Medical Health Specialist (RDMHS)
 - Javier gave an overview of SEMS (Standardized Emergency Management System) and the functions of the MHOAC (Medial Health Operational Area Coordinator) within that system.
 - Resource requesting begins at the local level with the MHOAC which can then be escalated through SEMS. The MHOAC will work with the RDMHS who, in turn, will work with the State.
