- 1. Meeting Introduction and Program Updates Maya Craig-Lauer
  - Program Updates
    - We are still in communications with the RDMHS and the State to schedule a CHEMPACK training. Delays are due to the response in LA.
    - The MRSE Exercise is scheduled for Thursday, April 24<sup>th</sup>, time is TBD. This
      exercise will include hospitals, ambulance providers, and OES.
    - The MRSE Scenario will be a moderate earthquake with passenger train derailment.
  - Bird Flu Tabletop Exercise
    - The bird flu tabletop exercise will be held in person on Friday, February 21<sup>st</sup> from 10-12 pm. This is a great way to collaborate with healthcare partners and share preparedness and response measures.

  - Hazard Vulnerability Analysis

- Breanne Davis: Seeing an extended orientation period for new staff. Post-COVID, hands-on skills and basic patient interactions are taking longer to learn.
- Brandi Colombo: Also experience a staffing shortage, especially with therapists.
