**Update on Bob Jones – segment 1 and 2 are fully funded and segment 1 construction is projected to start around March of 2026**

**Morro Bay to Cayucos, design and construction funded but no identified funding for maintenance or operations. Design is ~90% complete**

**Templeton to Atascadero Connector – parks recently allocated 200K for the project to continue through design and permitting but no construction funding has been identified or any maintenance or operational funding**

**Yerba Buena creek trail project – County Park is pursuing funding through Grants.**

**Department is launching a system wide parks and rec master plan development. Have hired BluePoint Planning for the 12-18 month long process.**
