Hoarding Definition vs. Clutterer or a Squalor

Hoarding is far more common in the United States and North America than anywhere in the world.

Clutterer

- > Clutter by choice
- ➤ Lacks discipline (lazy)
- Lacks the knowledge in how to properly store belongings

Squalor

> Extreme filth, especially if a result of poverty or neglect

Hoarder

- ➤ Effective 2013, it is considered a serious mental disorder apart from OCD diagnosis
- Persistent difficulty discarding or parting with possessions due to a perceived need to save the items
- > Their behavior causes clinically significant distress or impairment in social, occupational, or other important areas of functioning

Three Main Types of Hoarding

• Object Hoarding

- > Excessive accumulation of items, usually low value items
- > Emotional attachments (they will need in the future or sentimental value)

Animal Hoarding

- > Individuals collect many animals but are unable to properly care for them
- > Unsanitary and overcrowded living conditions
- > Often owners do not recognize the harm caused to the animals

• Digital Hoarding

- > Excessive accumulation of digital files (emails, photos and documents
- > Disorganization leads to high anxiety and stress due to lost files

Typically leads to isolation and strained relationships

Typical Reasons Given for Hoarding Behavior

Age 11-13 years: Signs of hoarding behaviors can begin to show

Age 13-20 years: Medium age for the onset of symptoms

Age 35-45 years: Symptoms intensify

Age 50+ years: Average age of a person seeking treatment for hoarding.

Without effective treatment, individuals who hoard often endure a lifelong struggle with hoarding. They tend to live alone and may have a family member with the problem.

Hoarding Increases the Difficulty of Rescues

Hoarding's Direct Impact on the Increase of Emergency Incidents

• Structural Integrity

- Floors (collapse from weight)
- > Pipes, appliances, etc.

Fire Hazards

- > Flammable items
- Space heaters
- Volume of Belongings

- > Tripping hazards
- > Buried alive from collapsed piles

Decay / Decomposition

- ➤ Mold
- Animal feces and infestations

Harmful Biohazards

> Toxic and Infectious

Personal Health

- Hygiene
- Respiratory diseases and infections
- Nutrition

Hoardings' Direct Impact on First Responders

Physical

- Limited access to the structure
- > Tripping hazards
- > Falling objects
- > Poor air quality
- Biological hazards
- Animal bites

Emotionally

- Stress and anxiety
- Moral distress
- PTSD potential

Operational

- Difficulty assessing situations (source of fire)
- Extended response time (additional time required to reach someone in need of help)
- Need for specialized equipment
- Special safety protocols and training

The Financial Consequences of Hoarding

• Financial Consequences

- > Financial mismanagement (i.e., unpaid bills, excessive spending)
- > Risk of eviction, foreclosure, legal fines due to property violations
- > Identification of hidden wealth
- Increased insurance costs or policy cancellations

• Fiduciary Role

- > Assist with regaining financial stability by managing income
- > Establish financial oversight, bill paying

- Educating families and guiding them on intervention options
- > Partnering with social services and legal professionals to secure resources
- Develop strategies for long-term care and housing stability safely aging in place or transitioning to alternative housing
- Provide oversight to prevent financial exploitation

Estate Planning & Risk to Heirs

- Ensuring legal documents are in place
- > Acts a facilitators in difficult family situations

Understanding the Impact of Hoarding

Hoarding's Direct Impact on the Hoarder

Cognitive behavioral therapy has shown the most success, with 70% of patients experiencing positive results. https://namimass.org

Hoarding's Five Level Rating Scale

- Level 1: Low: At this level, the home is generally neat and organized with minimal clutter.
- Level 2: Guarded: Clutter begins to accumulate. Items might be piled in certain areas, but movement in the house is still possible.
- Level 3: Elevated: Clutter may partially block key living spaces, such as kitchens or bathrooms, making them less usable.
- Level 4: High: Rooms are difficult to move through, and important living spaces are unusable.
- Level 5: Severe: The home (and property) is overwhelmed with clutter, making it nearly impossible to move through.

Health

- Respiratory issues
 - o Mold, mildew, and fungus exposure
 - Ammonia from decaying waste
 - o Uric acid from pet and human urine
 - o Poor ventilation from broken heating systems
- Sanitation Issues
 - o Plumbing broken, backed up, etc.
 - Spread of diseases from pets, rodents, bug infestations (defecation and death)
- Nutrition issues
 - Food poisoning eating spoiled food
 - o Diabetes quantity and quality of food
 - Alcoholism

Safety

- > Fire hazards
 - Build-up of flammable items, clutter around open flames (approx. 25% of deaths by house fire - due to hoarding)
- > Trip and fall hazards
- Objects falling or stacks collapsing (causes entrapment)
- > Structure hazards
 - Lack of routine home maintenance (flooring, roofs, plumbing, windows, etc.)
 - Structural damage to the building from increased weight and volume of clutter

Financial

- Risk of foreclosure, eviction or homelessness
- > Increase medical expenses that they can't afford

Hoarders' Direct Impact on the Community

Affects on Neighborhood

- Unsightliness spreads from inside to outside
- Decreased values in home prices
- Flooding caused by broken pipes
- Backed-up sewage issues
- Pest infestation due to condition of property

Affects to the City

- Loss of property taxes due to abandoned property
- > Increased costs due to emergency incidents for fires, falls, and health issues

Affects to the County

- Increased expenses to County services (warrants, citations, animal services, and mental health)
- Draining county non-profit and senior organization resources

San Luis Obispo County Hoarding Task Force

The first hoarding task force in the United States began in 1989 in Fairfax County, Virginia. Since then, the number of hoarding task forces has grown to 75 communities throughout the US to help coordinate care.

Proposed Task Force Mission

• A coordinated approach by multi-agency and community resources

Purpose: Individual and Community Resource Support

- Collaborative efforts to maximize available resources and address service limitations
- Development of compassionate strategies paired with enforcement, remediation, and legal action as needed
- Responds to requests for help from:
 - Hoarder themselves or a family member
 - > Resources, non-profit organization
 - > Government offices
- Maintains a "Hoarding-Specific Resource Directory"
- Provides crisis and emergency support

SLO Co. Hoarding Task Force

- To raise awareness of hoarding by developing collaborative efforts of local services and resources
- · To identify gaps in services and needs in the community
- To discuss complex cases, refer to each other, and build relationships
- To keep the health, safety, and dignity of the individual hoarder a priority

Professional and Volunteer Response Team Goals

- Comprehensive strategic approach
- Improve communication and response
- Earlier intervention efforts
- Improve community safety
- Share resourcing which reduces community costs
- Increase community education and awareness
