Central Coast Veterans Helping Veterans - Paul Worsham

- Central Coast Veterans Helping Veterans (CCVHV) is organized to assist the estimated 16,000 veterans residing in San Luis Obispo County. Many of these veterans have encountered a variety of problems in transitioning from military service to a fully productive life as civilians
- Initially formed as a non-profit
- Mike Patrick is the heart and soul of this service/program
- Mike Patrick finds senior veterans in need, evaluates the needs of veterans, sends the referral to Seniors Helping Seniors, and creates personalized gift baskets foreach veteran in need

Seniors Helping Seniors - Free VA In-Home Care - Maryanne Zarycka

- Seniors Helping Seniors is a home care service that connects senior caregivers with senior clients, providing companionship and assistance with daily tasks.
- SHS helps Veterans access VA benefits like Homemaker Home Health Aide Care services which is paid by the VHA (Veterans Healthcare Administration).
- Currently 27 veterans are being served by SHS with this HHHA VA paid service
- Homemaker Home Health Aide Care is funded through VHA Care in the Community program
- VA Homemaker/Home Health Aid (H/HHA) Referral Process showed in the presentation (contact Maryanne at Seniors Helping Seniors for more information)

VA Homemaker/Home Health Aid (H/HHA) Referral Process

- VA HHHA Referral Geriatrics and Extended Care Flyer
- VA HHHA Referral Homemaker and Home Health Aide Care Flyer
- The Veteran MUST VISIT their VA Primary Care Physician to obtain a Homemaker/Home Health Aid (H/HHA) Referral

• The Veteran MUST request a Homemaker/Home Health Aid (H/HHA)

Referral from the VA Primary Care Physician.

The Veteran MUST agree they need assistance with at least TWO

Activities of Daily Living (ADL's) to start the process for receiving benefit.

ADL's = Ambulation/transferring, Dressing/grooming,

Bathing/showering, Toileting/Incontinence care, Feeding

• The VA Primary Care Physician will submit the REFERRAL to the Veterans

Healthcare Administration for approval. This approval may take 8-12 weeks.

Salutes to Veterans in Hospice Comfort Care - Paul Worsham

- Brochures were passed out
- Salutes to veterans in hospice comfort care involve formal ceremonies, presentations of flags and certificates, and other expressions of gratitude to honor their service and sacrifice. These acts of recognition can bring comfort and closure to veterans at the end of life
- The importance of partnerships was emphasized
- Multi-sponsors

EDD Disabled Aging Veterans Employment - Esteban

- Currently 15,465 veterans in SLO county
- DOL funded program funded by the state
- They get referrals from the VA
- Helps veterans translate peer-to-peer level military service into a career to look for a job
- Spouses can also be included
- American Job Center has EDD staff for those that want to refer veterans in San Luis Obispo
- "JVSJ program" refers to the Jobs for Veterans State Grants. This program provides funding to state agencies to support employment services for veterans. JVS SoCal, a non-profit social service agency, also has a "Veterans First" program, which is separate from the JVSG program and focuses on career coaching, placement, and transition support for veterans and their spouses, according to JVS SoCal

Veteran Suicide Prevention - Mike Bossenberry/Paul Worsham

- CDC website from 2021-2022 age 65 had an % increase in suicide 433 including females and males
- Rate is greater with age group
- Generally the rates have increased nationwide
- The state of CA does a little better in % compared to nationwide numbers
- Anxiety, PTSD, mental health issues, self-destructive behavior, depression, repeated traumatic experience, direct or indirect exposure with sexual violence are some of the factors/indicators of suicide
- These factors/indicators become more pronounced with age
- Partner with agencies to support veterans at risk of suicide
- 60% of veterans who commit suicide are not enrolled with the VA
