**4.1. Implementing Five-Year Plan Line of Effort 3 – Improve and Expand Data Management Efforts Through HMIS and Coordinated Entry System to Strengthen Data-Driven Operational Guidance and Strategic Oversight**

#### **4.1.2. Homeless Management Information System (HMIS)**

##### **4.1.2.1. Information Item: Dashboard**

Kate presented the San Luis Obispo County Homelessness database dashboard covering the third quarter of 2025. The report reflected a total of 1,644 enrollments, which comprised of persons served in the following programs: Emergency Shelter, Transitional Housing, and Street Outreach programs.

##### **4.1.2.2. Information Item: PIT Count Update**

Kari reported that the Survey tool for the PIT Count is in development. She also mentioned that they have confirmed the 7 interns joining the Homeless Services Division temporarily in advancing PIT Count implementation and reporting. In addition, the start time, volunteer maps, volunteer group assignments, and locations of logistics centers countywide have also been confirmed.

##### **4.1.2.3. Information Item: HMIS Staff Report**

Kari shared that there are currently 17 participating HMIS agencies, 213 active HMIS users and 119 Projects. Since the last Data & Performance committee meeting, 574 messages were received of which forty eight percent (48%) were resolved in the first reply. Additionally, the HMIS Helpdesk has an ongoing training focused on FY 26 Data Standards Update. Also, besides editing more than six (6) articles, the Staff created four (4) knowledge base articles namely, Clarity Accessing Referrals Workflow, Clarity Coordinated Entry Monitoring, How to become an HMIS End User, and Data Quality and Corrections FAQ.

Kate presented data (based on report from Clarity as of November 16, 2025) on Measure 7: Successful Housing Placement from Street Outreach and Successful Placement in or Retention of Permanent Housing.
