1. Call to Order and Introductions

Janna called the meeting to order at 9:03 am. Introductions were made by those present at the meeting, both in-person and online.

2. Public Comment

None provided.

3. Consent: Approval of Minutes

Mark L moved the motion to approve the minutes. Mark F seconded the motion. Minutes were approved by voice vote.

4. Action/Information/Discussion

4.1. Implementing Five-Year Plan Line of Effort 3 – Improve and Expand Data

Management Efforts Through HMIS and Coordinated Entry System to Strengthen Data-Driven Operational Guidance and Strategic Oversight

4.1.1. Homeless Management Information System (HMIS)

4.1.1.1. Information Item: 2026 Unsheltered Point-in-Time Count Update

Kari provided information regarding the upcoming Point-in-Time Count in January 2026. She shared that volunteer registration is now live on the County HMIS website. Training information, media kit (flyers, social media posts, etc.) can be downloaded and shared with the community. So far, there are 35 community members who signed up to volunteer, and more is needed. She also shared that there are seven (7) Cal Poly students working as interns to help in this year's PIT Count.

Kari reported that the survey tool and mapping are in progress, volunteer training materials are also in development. She also mentioned that there are seven (7) logistic centers located countywide: San Miguel, Paso Robles, Atascadero, San Luis Obispo, Arroyo Grande & Nipomo.

4.1.1.2. Information Item: 2026 Sheltered Point-in-Time and Housing Inventory Count

Kari shared that every year, the completed sheltered count coincides with the housing inventory. The way the unsheltered count works is they ask the question of "where did you sleep the night of? (this time it will be January 26th). That is the reporting date of the Sheltered Point-in-Time Count and the Housing Inventory. There will be HIC / PIT training on January 20 from 1pm-2pm. All warming centers will be activated on the night of January 26th.

4.1.1.3. Information Item: HMIS Staff Report

Kari shared that there are currently 17 participating HMIS agencies, 217 active HMIS users and 119 Projects. Since the last Data & Performance committee meeting, 521 messages were received of which fifty-six percent (56%) were resolved on the first reply. Additionally, the HMIS Helpdesk has an ongoing training focused on FY 26 Data Standards Update. Also, besides editing more than six (6) articles, the Staff created five (5) knowledge base articles.

4.1.1.4. Discussion Item: System Performance Measures (SPM), Employment and Income Growth for Persons in CoC-Funded Projects

Kate shared data regarding SPM # 4, Employment and Income Growth for Persons specific to projects identified as funded through CoC Program in HMIS.

4.1.1.5. Information Item: Update on FY25 Longitudinal Systems Analysis Errors and Warnings

Kate briefly presented a data review status of the LSA Errors and Warnings for the SLO County CoC. As of this Committee's meeting, the data error remaining count was listed as 1, and warnings needing CoC action totaled 14.

4.1.1.6. Information Item: Progress Update for Data Integration with CenCal

Kate reported that the HMIS team has imported the first test data from CenCal containing CalAIM enrollment information and is currently evaluating quality assurance. Data will be available on the site two weeks from now. They will be working with CenCal to establish the frequency of the data to be imported.

The HMIS team will be organizing a group call or meeting with HMIS Participating Agencies to discuss more details of their CalAIM activities and how those are reflected in HMIS. They are hoping to organize more consistent data collection across the CoC on CalAIM.


