### 1. Call to Order and Introductions

Susan (on behalf of Michelle S.) called the meeting to order at 3:03 pm.

Brenda mentioned that issues about U.S. Immigration and Customs Enforcement need to be paid attention to.

Wendy shared that they received the final permit for the ECHO build-out in Atascadero. Breaking ground is targeted for October of this year and opening is scheduled for October of next year.

She also mentioned that as of date, they have a total of 226 individuals housed: 141 through shelter and outreach, and 85 individuals through their homeless prevention program.

Per Jack, funding has been secured for the rotating safe program, which is now rebranded as Community Safe Parking.

Janna moved the motion for approval of the minutes. Jack seconded the motion. The minutes were approved unanimously by voice vote
