1. Call to Order and Introductions

Chairperson Michelle Shoresman called the meeting to order at 1:04 pm. Introductions were made by alternate representatives and those new at the meeting.

2. Public Comments

Janna Nichols shared that 5CHC (5 Cities Homeless Coalition) Empty Bowls event is coming up on October 9th where they will be selling soups and hats with the 5CHC logo. Susan Lamont reported that Lumina Alliance has five transitional housing units that they are taking referrals for.

Wendy Lewis shared that El Camino Homeless Organization (ECHO) is hosting an event on Saturday, September 23 at its Atascadero location. The Long Walk Home Awareness March is an annual event aimed to raise awareness for those in the community who are experiencing or who may experience homelessness. In addition, she also mentioned that ECHO is having a groundbreaking ceremony for the launching of a new facility, the Balay Ko Family Resource Center on October 6th at 1:00 pm.

Jack Lahey from Community Action Partnership of San Luis Obispo (CAPSLO)/40 Prado will be having an event on October 11th to commemorate 60 years of CAPSLO. Proceeds will go

to support SLO County CAPSLO programs. He also mentioned that they are five days away from officially launching their rotating safe parking program. There will be 12 spots that rotate between six (6) safe parking sites annually. These new sites will increase the safe parking capacity to 24 spots.

Ashley Hernandez announced that they will be launching a blue bag program in the city of Paso Robles. She mentioned that this program will be in collaboration with the Behavioral Health Community Action Team and other organizations such as ECHO and Paso Cares.

Michelle Pedigo from Housing Authority of San Luis Obispo (HASLO) reported that Maxine Lewis Grove in San Luis Obispo will be completed by the end of October. This site will have 39 homeless units all going through Coordinated Entry.

Rick Gulino from People's Self-Help Housing and in collaboration with HASLO announced that Cleaver & Clark Commons project in Grover Beach has an anticipated completion by the end of this year. This development, comprised of 53 units, is intended for low-income households, farm workers and those at risk of homelessness.

Consent: Approval of Minutes

Jack Lahey moved the motion for minutes to be approved, seconded by Susan Funk. Minutes passed via voice vote.

3. Action/Information/Discussion

4.1. HSOC Administration

4.1.1. Information Item: Expiring and Vacant Seats on the Homeless Services Oversight Council

Laurel Weir shared information regarding HSOC expiring and vacant seats. She mentioned that application for membership can be found and downloaded at the HSOC website and are due September 30th. The list of expiring seats and list of current HSOC members were provided as part of the agenda packet.

4.1.2 Action Item: Vote to recommend Juanetta Perkins for the vacant At Large seat on the Homeless Services Oversight Council

Janna Nichols moved the motion to recommend Juanetta Perkins, seconded by Mark Lamore. Membership roll was called and the motion passed.

4.2. Implementing Five-Year Plan Line of Effort 3: Improve and expand data management efforts through HMIS and coordinated entry system to strengthen data-driven operational guidance and strategic oversight.

4.2.1. Action Item: Approve the Methodology for the 2026 Homeless Point in Time Count

Kari Howell from the Homeless Services Division shared background information and overview of the Point-in-Time (PIT) Count. She also presented the proposed methodology for the January 2026 PIT count census (included in the agenda packet).

Marie Bolin moved the motion to approve the methodology, seconded by Jack Lahey. Roll was called and the motion passed.

4.3. Implementing Five-Year Plan Line of Effort 1: Create affordable and appropriately designed housing opportunities and shelter options for underserved populations

4.3.1. Information Item: Housing Grants and Programs Update

George Solis from the Homeless Services Division provided an update on the affordable housing pipeline. He reported that for calendar year 2025, 288 units of affordable housing have been completed and occupied. He also mentioned that through September of this year, 592 new units of affordable housing have been completed since the inception of the Five-Year Plan. In addition, George said that they estimate an additional 121 new units will be completed and ready for occupancy by the end of this year. He also mentioned that 245 units are under construction and are anticipated to be completed sometime in 2026. He also shared that their records indicate an additional 669 units are in the planning pipeline.

George reported that on September 23, the Board of Supervisors will be considering the establishment of a Regional Housing Incentive Program from the Department of Planning and Building. This is a voluntary program wherein builders could either provide onsite guaranteed affordable housing or contribute to a regional housing fund, which would help identify funding gap for affordable housing.

George also provided an update regarding the August 2025 Request for Proposals. He reported that they received 23 applications totaling \$16 million in requests. They have \$6.5 million available for application. They were planning on taking funding recommendations to HSOC for this meeting, but due to the number of applications received and the new HSOC scoring guidelines, the grant review process will take longer. The funding recommendation will be presented to the HSOC in November and to the Board of Supervisors in December.

Additionally, the 2026 HUD Action Plan Notice of Funds Availability (NOFA) was released on September 11th. This includes the HUD entitlement grants, Community Development Block Grant (CDBG), HOME Investment Programs and Emergency Solutions Grants (ESG) plus County General Fund support. George mentioned that the applications will be due by October 10th.

He also reported that the 2026 Community Development Needs Assessment Survey was released on August 27th, and responses are due by October 14th. The survey results will help shape goals and priorities for the Five-Year Consolidated Plan, which helps guide County funding decisions or prioritize existing goals. The survey findings will then be presented to the Board of Supervisors on December 9th.

Michelle Pedigo from the Housing Authority provided a brief update on the federal budget in terms of the voucher funding.

4.4. Implementing Five-Year Plan Line of Effort 4 - Create, Identify, and Streamline Funding and Resources

4.4.1. U.S. Department of Housing and Urban Development Continuum of Care Grant Program

4.4.1.1. Information Item: Update on Continuum of Care Grant

Laurel Weir shared slides to provide information regarding the Continuum of Care Competition.

4.4.1.2. Action Item: Authorize 1) the Executive Committee to approve federal Continuum of Care project funding and ranking recommendations if the HSOC is unable to meet in time to approve; and 2) an Ad Hoc Application Committee to review and approve the final CoC Consolidated Application to the U.S. Department of Housing and Urban Development

Janna Nichols moved the motion with the suggested amendment to have different County department heads fill in the seats for the Executive Committee in case quorum is not achieved due to recusals. Motion was seconded by Jim Dantona. Roll was called and the motion passed.

4.4.2. Discussion Item: Federal, State and County Budget Updates

Laurel Weir provided a brief update. She mentioned that if there is a government shutdown, funding contracts with the agencies will be impacted.

4.5. Discussion Item: Committee Updates

Jack Lahey reported that the Coordinated Entry Committee reported have worked on revising and passing updated policies, establishing universal guidelines for the agencies that participate in the coordinated entry system. They are currently working on solidifying guidances in terms of housing referrals.

Wendy Lewis from the Services Coordinating Committee will report at the next meeting. Mark Lamore shared that the Data & Performance Committee besides developing the homeless dashboard, continue to track agencies using system performance metrics, and monitor HMIS data quality. At the last meeting, they developed a minimum intake form to have basic information for clients who are not participating in other services. In addition, Janna Nichols shared that they were able to expand the Committee to include members from the public who understand data.

ITEM: Vote to Recommend Eleven Persons for Appointment to the Homeless Services Oversight Council to Fill Expiring Seats for a Term Beginning January 1, 2026, Two Persons to Fill Vacant Seats for Terms Expiring on January 1, 2028, and One Person to Fill a Vacant Seat for a Term Expiring on January 1, 2027.

ACTION REQUIRED: It is requested that the Homeless Services Oversight Council (HSOC) vote to recommend eleven persons for appointment to the Homeless Services Oversight Council to fill expiring seats for a term beginning January 1, 2026, two persons to fill vacant seats for terms expiring on January 1, 2028, and one person to fill a vacant seat for a term expiring on January 1, 2027.

SUMMARY NARRATIVE:

There are 36 membership seats on the HSOC. Members are appointed to the HSOC by the County Board of Supervisors, except for seven seats reserved for the representatives of the seven incorporated cities. These seven seats are held by City Council members who are appointed by their respective City Councils.

Except for the seats reserved for elected officials, and the Youth Advisory Board seat, members are appointed to three-year terms. To ensure continuity of the HSOC, term expirations are staggered among the seats, such that approximately 1/3 of the seats expire in a given year. Terms expire in January of the year when the term ends. There is no restriction on the number of terms a member may serve, but HSOC Bylaws prohibit more than two people from a single organization from serving on the HSOC at the same time.

There are currently eleven seats due to expire in January 2026. Nine of these seats are tied to a specific category and can only be held by a representative from that category. The two remaining seats are At-Large seats, meaning they may be held by a representative from any of the following categories: County Government Service Providers, Currently or Formerly Homeless Persons, Advocates, Affordable Housing Developers, Businesses, Faith-Based Organizations, Hospitals, Public Safety Organizations, Behavioral Health Agencies, Nonprofit Homeless Assistance Providers, Organizations Serving Homeless Veterans, Housing Authority, County Office of Education, Local School Districts, Social Services Providers, Victim Service Providers,

and Other Community Organizations. The terms for these seats will begin on January 1, 2026, and expire on January 1, 2029.

In addition to the expiring seats, there are vacancies for the Organizations Serving Homeless Veterans seat, the Other Community Organizations seat, and the Social Services Organization seat. These seats became vacant partway through their terms, so they will have different expiration dates than the expiring seats. The Organizations Serving Homeless Veterans seat will expire on January 1, 2028, the Other Community Organizations seat will have a term expiring on January 1, 2027, and the Social Services Organization will have a term expiring on January 1, 2028.

At the September 2025 HSOC meeting, expiring membership terms were reviewed and a request was made for applications from the public. A total of fourteen applications were received. An ad hoc Nominating Committee met in October to consider the applications and recommended candidates. The HSOC Executive Committee met in October to consider the recommendations. HSOC Bylaws require the Executive Committee to review and comment on the recommendations and to submit the proposed roster for expiring seats to the full HSOC for approval.

Expiring Seats

The Executive Committee recommended the following eleven candidates for expiring seats on the HSOC for terms beginning in January 2026:

- Jack Lahey for an additional term for the At Large seat he currently holds for a term expiring in January 2029. Jack is currently the Chair of the HSOC Coordinated Entry Committee. He is the Director of Homeless Services for the Community Action Partnership of San Luis Obispo (CAPSLO).
- Luke Dunn for the Currently or Formerly Homeless Person seat for a term that will expire January 2029. Luke works for CAPSLO's Outreach and Engagement Team. Luke currently serves on the HSOC in an At Large seat.
- Mark Lamore for the Nonprofit Homeless Assistance Providers seat for a term that will expire in January 2029. Mark is the Director of Homeless Services and Housing at Transitions Mental Health Association (TMHA). Mark currently serves on the HSOC and was previously the Chair of the HSOC Data and Performance Committee.
- Frank Warren for the County Government Service Provider seat for a term that will expire in January 2029. Frank is the Deputy Director of the County of San Luis Obispo Behavioral Health Department and has worked for the Department for 31 years. He oversees Divisions at the Department that

provide direct and indirect services and partner with organizations that serve unhoused persons and those at risk of homelessness in San Luis Obispo County.

- Daniel Suttles for the Public Safety Organizations seat for a term that will expire January 2029. He is the Chief of Police for the City of Atascadero. In this role, he has overseen Departmental collaboration with community partners such as County Behavioral Health, ECHO, and the Wisdom Center to help bring resources to people experiencing homelessness or at risk of homelessness in Atascadero.
- Michelle Pedigo for the Housing Authority seat, for a term expiring in January 2029. Michelle serves as the Executive Director of the Housing Authority of San Luis Obispo (HASLO). She is currently a member of the HSOC and serves on the HSOC Executive Committee.
- Rick Gulino for the Affordable Housing Developers seat for a term that will expire January 2029. Rick is the Director of Resident Services at People's Self-Help Housing. Rick is a current member of the HSOC and has served as the Chair of the SLO Supportive Housing Consortium for over ten years.
- Kirsten Cahoon for the Advocate seat for a term that will expire January 2029. Kirsten is the Executive Director of Homeless Services for the Good Samaritan Shelter and is a Domestic Violence Certified Advocate. She is leading Good Samaritan's upcoming opening of the Welcome Home Village project in San Luis Obispo and has also managed the Supportive Services for Veteran Families program for over eight years in both San Luis Obispo and Santa Barbara Counties.
- Devon McQuade for the Nonprofit Homeless Assistance Providers seat for a term that will expire January 2029. Devon is the Associate Director of the 5Cities Homeless Coalition and is the incoming Executive Director effective January 1, 2026. Devon has worked with 5CHC for over eight years, serving in a variety of roles from case management to operations and administration.
- Wendy Blacker for an At Large seat for a term that will expire January 2029. Wendy is the Founder and CEO of 805 Street Outreach, which serves unhoused persons in San Luis Obispo County and operates a shower program for unhoused persons in Morro Bay. Wendy also has lived experience of homelessness in San Luis Obispo County.
- Rosie Ojeda for the Local School Districts seat for a term that will expire January 2029. Rosie is an Assistant Professor at Cal Poly. Rosie grew up in San

Luis Obispo County, attending school in the Lucia Mar School District and then teaching in Santa Maria. Her work at Cal Poly includes teaching incoming teachers about how they can help and be aware of students experiencing homelessness.

Vacant Seats

The Executive Committee is required by HSOC Bylaws to consider candidates for expiring seats but candidates for seats that are vacated mid-term are considered by the Nominating Committee and go directly to the HSOC for consideration. The HSOC currently has three vacant seats: Organizations Serving Homeless Veterans, Other Community Organizations, and Social Services Provider.

The Nominating Committee recommended James Davis for the Organizations Serving Homeless Veterans seat for a term that will expire in January 2028. James is an Air Force veteran and served as a volunteer consultant to Ride On Transportation/UCP+ of SLO County, develop, producing and promoting various fundraising events, including the annual Veterans Benefit Concert, benefitting the Veterans Express Shuttle that transports Veterans to medical, dental, and vision appointments. He operates a concert event and fund development company called Festival After Dark and a podcasting and media company. He previously worked as a residential care facility administrator, developing and overseeing programs that helped provide long term supported housing for mentally ill persons experiencing homelessness.

An application for an additional vacant seat, the Other Community Organizations seat that was previously held by Christy Nichols from CenCal Health, was received in October. The Nominating Committee met to consider the application and recommended Bao Xiong to fill the seat. Bao oversees the Housing and Homeless Incentive Program (HHIP) for CenCal Health. HHIP aims to reduce homelessness and improve housing stability for Medi-Cal members in Santa Barbara and San Luis Obispo County.

Additionally, at the September 2025 meeting of the HSOC, the HSOC voted to recommend Juanetta Perkins for an At-Large seat. Through the work with the County Clerk's office, it has been identified that the vacant seat for which she was nominated should have been classified as the Social Services Provider seat. Thus, the current recommendations found in Attachment C include a correction for the title of the seat for which Juanetta Perkins already has been nominated.

BUDGET/FINANCIAL IMPACT

No current fiscal impact is anticipated.

STAFF COMMENTS:

Outreach

At the October Executive Committee meeting, the Committee did request that additional outreach be done for the Public Safety Organizations and the Other Community Agencies seats, to ensure awareness of the opportunities and directed the Nominating Committee to meet in November to consider additional applications. One application was received for the Other Community Agencies seat, and no additional applications were received for the Public Safety Organization seat. The applicant for the Other Community Agencies seat, Bao Xiong from CenCal Health, was recommended by the Nominating Committee for the seat for which she applied.

Categories of Seats

Staff have been working with the County Clerk's office in preparation for submission of the proposed membership slate to the Board of Supervisors in December. Previously, members nominated for At-Large positions were listed according to their eligible membership category, e.g. Nonprofit Homeless Assistance Providers. This led to confusion about which seats members held. Going forward, all At-Large seats will be listed as At-Large seats.

It is recommended that the Homeless Services Oversight Council approve the recommendations as set forth in Attachment C. Upon HSOC's approval, staff will submit a recommendation for appointment to the full HSOC.

I qualify for the nonprofit homeless assistance organization seat through my extensive leadership and direct program experience in the homeless services sector. For the past 14 years, I have served as the Director of Homeless Services for Good Samaritan Shelter, overseeing multiple shelter programs across Santa Barbara County and leading the upcoming opening of a new shelter in San Luis Obispo. In addition, I have managed the Supportive Services for Veteran Families (SSVF) program for over eight years in both San Luis Obispo and Santa Barbara Counties.

My experience also includes operating a state-serving safe house for survivors of human trafficking and directing homeless street outreach teams in both counties for over a decade. Prior to my work with Good Samaritan, I worked in social services for the County of Santa Barbara and with foster youth and other youth organizations in both San Luis Obispo and Santa Barbara Counties.

I bring a strong background in policy and program implementation, coupled with ongoing professional development through annual participation in the National Conference on Homelessness in Washington, D.C., as well as other statewide and regional trainings. I am frequently invited to speak as a subject matter expert for schools, service organizations, and community forums, providing education and advocacy around homelessness.

Through this combination of direct program management, regional experience, and policy expertise, I am well-positioned to contribute meaningfully to the HSOC as a representative of nonprofit homeless assistance organizations.

I have overseen outreach teams in San Luis Obispo and Santa Barbara Counties for more than a decade, ensuring that unsheltered individuals are connected to shelter, healthcare, and permanent housing resources.

In addition, I have managed programs specifically designed for vulnerable populations, including veterans and survivors of human trafficking, both of whom face unique pathways into and out of homelessness. Through this work, I have witnessed the resilience of clients and the importance of trauma-informed, client-centered approaches.

Beyond direct service, I also bring governance and policy experience from my role as the 4th District Commissioner on the Santa Barbara County Human Services Commission. This combination of front-line service, program management, and policy-level decision-making has allowed me to develop a well-rounded understanding of the issues and solutions that are most effective in addressing homelessness in our region.

I would like to serve on the HSOC because I am deeply committed to advancing collaborative and effective solutions to homelessness in our region. Over the past 14 years as Director of Homeless Services for Good Samaritan Shelter, I have seen firsthand how critical it is for service providers, county partners, and community stakeholders to align their efforts in order to create meaningful pathways out of homelessness. Serving on the HSOC would allow me to contribute my experience and perspective at a policy and planning level, while also ensuring that the voices and needs of our most vulnerable community members are represented.

Good Samaritan Shelter is also expanding its footprint in San Luis Obispo County. With the upcoming Welcome Home Village project in San Luis Obispo, concentrated street outreach efforts across the county, and the continued growth of our veteran services, we are building deeper roots in this community. Serving on the HSOC would provide an important opportunity to align our work with countywide priorities, strengthen partnerships, and contribute to the shared goal of reducing homelessness in San Luis Obispo County.

Ultimately, my motivation to serve comes from a commitment to both practical solutions and long-term systems change. I believe my background in direct service, program management, and regional collaboration would be an asset to the HSOC as it continues to guide policy, funding, and strategies to address homelessness.



ACTION ITEM: 4.2.1

ITEM: Recommend funding allocations of Homeless Housing, Assistance and Prevention Program (HHAP)– Round 4 (\$1,270,298), and HHAP Program – Round 5 (\$1,985,629), Permanent Local Housing Allocation (PLHA) – Pismo Beach allocation (\$65,804), State Emergency Solutions Grant (ESG) (\$203,245), and Supplemental County General Fund Support (\$2,315,351) and approve release of Request for Proposals for \$464,470 to support Prevention and Diversion funded through Homeless Housing, Assistance and Prevention Program – Round 4.

ACTION REQUIRED:

Vote to:

1. Recommend funding allocations of HHAP Program – Round 4 (\$1,270,298), and HHAP Program – Round 5 (\$1,985,629), PLHA – Pismo Beach allocation (\$65,804), State ESG (\$203,245), and Supplemental County General Fund Support (\$2,315,351).
2. Approve release of Request for Proposals for \$464,470 to support Prevention and Diversion funded through HHAP Program – Round 4.

SUMMARY NARRATIVE:

On August 7, 2025, the County released a competitive Request for Proposals (RFP) to solicit proposals for homeless services and housing projects. The RFP was developed in alignment with funding priorities previously approved by HSOC and the Board of Supervisors (BOS). A total of 23 applications were submitted, requesting in excess of \$15 million in funding. However, only \$6.2 million in funding was available through a combination of state and county sources.

The available funding includes allocations from the State of California’s HHAP Program Rounds 4 and 5, ESG Program, the PLHA for the City of Pismo Beach, and Supplemental County General Funds approved by the BOS in June 2025.

HHAP-4 & HHAP-5

The County of San Luis Obispo and the San Luis Obispo County Continuum of Care (CoC) were eligible to receive a combined total of over \$8 million in HHAP funding across Rounds 4 and 5. These funds are disbursed in two phases, with the second disbursement contingent on meeting specific expenditure and obligation benchmarks. On April 24, 2024, HSOC approved funding recommendations for the 1st disbursement of HHAP-4. On May 14, 2025, HSOC approved the funding priorities to be included in the August 2025 RFP.

HHAP-4 (2nd disbursement) Priorities Approved by HSOC:

- \$774,117 to support operating costs/ supportive services in existing interim shelters
- \$464,470 to support Prevention and Diversion
- \$309,647 to support Capital for Permanent Housing that serves people experiencing homelessness, including conversion of underutilized buildings or existing interim or transitional housing into Permanent Housing
- \$186,534 to support youth set-aside.

Under state guidelines, at least 10% of the total funds must be spent on homeless youth populations and no more than 7% of the total funds may be used by the County to administer the HHAP-4 program.

HHAP-5 (1st disbursement) Priorities Approved by HSOC:

- \$707,920 to support Capital for Permanent Housing that serves people experiencing homelessness, including conversion of underutilized buildings or existing interim or transitional housing into Permanent Housing
- \$442,450 to support operating costs/ supportive services in existing interim shelters
- \$442,450 to support operating costs/ supportive services in Permanent Supportive Housing units (PSH)
- \$215,829 to support youth set-aside.
- \$176,980 to support Rapid Rehousing/ Rental Subsidies

Per state guidelines, at least 10% of the total funds must be spent on homeless youth populations and no more than 7% of the total funds may be used by the County to administer the HHAP-5 program.

A total of 11 applications were received for HHAP-4 and HHAP-5 with a total request of \$12,760,672 (see table #1).

Notably, HHAP-4 included a \$464,470 allocation specifically for prevention and diversion, which remains unawarded due to a lack of applications. Staff recommend releasing a new RFP to ensure these funds are distributed in alignment with HSOC's priorities.

FY2024 State ESG

The County, acting as the administrative entity for the State ESG program, was allocated \$205,927 for Fiscal Year 2024. ESG funds are federally sourced and must comply with strict guidelines, including a requirement that at least 40% be used for rapid rehousing and no more than 10% for homelessness prevention.

Action Item 4.2.1

On May 14, 2025, HSOC approved the FY24 State ESG funding priorities to be included in the August 2025 RFP. These priorities included:

- \$82,119 to support Rapid Rehousing/ Rental Subsidies
- \$121,125 to support operating costs/ supportive services in existing interim shelters

A total of four applications were received for State ESG with a total request of \$269,555 (see table #2).

CY2023 PLHA – Pismo Beach Allocation

The City of Pismo Beach delegated administration of its PLHA funds to the County through a formal agreement. The final year of the five-year PLHA plan includes an estimated \$69,268 in funding. 5% of the PLHA allocation is utilized for administration of the program.

One application was received for PLHA – Pismo Beach allocations with a total request of \$65,804 (see table #3).

Supplemental County General Funds

On June 17, 2025, the County Board of Supervisors adopted the FY 2025–26 Budget, which included a recommendation to allocate \$2.5 million in one-time funding to support homeless services. This funding, drawn from the Tax Reduction Reserve, was made contingent on city participation.

On August 6, 2025, the Board approved criteria for awarding these County General Funds, establishing that:

- Funds would be issued as grants to eligible Community-Based Organizations (CBOs).
- Eligible applicants must have received County funding in FY 2024–25 under one or more of the following programs:
CDBG, ESG, PLHA, HHAP, HUD CoC, or County General Funds.
- Eligible activities include:
Prevention, Outreach, Rapid Re-Housing, Emergency Shelter Operations/Supportive Services, and Permanent Supportive Housing Operations/Supportive Services.
- *Capital improvement projects were not eligible.*
- Funds must be used as funding for the last resort and may be rolled over for one additional fiscal year with approval.
- All applications must include:
 - A letter from city leadership outlining their participation in the project.
 - Documentation of leveraged funding sources supporting the project.

Action Item 4.2.1

A total of seven applications were received for Supplemental County General Funds with a total request of \$3,431,781 (see table #4).

Grant Review Committee Process

A non-conflicted grant review committee was convened to review and score project applications. This process was the first to incorporate the grant application performance criteria approved by the HSOC Executive Committee on February 19, 2025, and approved by the County of San Luis Obispo BOS on April 8th, 2025.

All performance data for service-related projects was provided from the County's Homeless Management Information System (HMIS) or an HMIS-compliant database. The metrics measured performance over the prior grant period.

Method for allocating funding to support interim shelter operations.

In an effort to equitably and strategically allocate interim shelter grant funding, staff have developed a performance-based formula that considers not only the scale of services provided, but also the needs of the population served and the effectiveness of each shelter in helping clients exit to permanent housing.

This approach ensures that funding supports both capacity and impact, while also recognizing the unique challenges faced by shelters serving higher-need populations.

Key Metrics Used in the Formula

The funding formula was based on three core performance indicators from the previous year:

- 1. Total Clients Served (40%)**

Reflects the overall scale and reach of each shelter's services.

- 2. Percentage of Chronically Homeless Clients Served (30%)**

Recognizes shelters that serve a higher proportion of individuals with long-term and complex needs.

- 3. Percentage of Exits to Permanent Housing (30%)**

Measures the effectiveness of each shelter in helping clients transition to stable, long-term housing.

Each metric was normalized and weighted to ensure a balanced and fair comparison across shelters of different types and sizes.

This formula-based method:

- Promotes equity by recognizing shelters that serve more vulnerable populations

Action Item 4.2.1

- Rewards performance by factoring in successful housing outcomes
- Supports sustainability by acknowledging the scale of operations

It also provides a transparent and data-driven framework that can be refined over time.

Method for allocating one-time supplemental County General Fund Support

To ensure a fair and strategic distribution of one-time supplemental funding for emergency shelter operations, staff developed a data-driven allocation model that prioritizes both operational need and fiscal responsibility. The funding was allocated using a formula that considers each agency's financial position and ability to leverage non-county resources.

Funding Objectives

The primary goals of this allocation were to:

- Address identified funding gaps in shelter operations
- Support agencies with larger operational footprints
- Recognize efforts to leverage external (non-county) funding
- Promote financial sustainability across the shelter system

Allocation Methodology

The funding was allocated based on four key financial indicators, each weighted to reflect its importance in achieving the above objectives:

Metric	Weight
Annual Operating Budget	25%
Total Leveraged Funding (including County)	20%
Identified Funding Gap	20%
% of Leveraged Funding from Non-County Sources	35%

Each agency's data was normalized and scored relative to the group, and the weighted scores were used to determine the percentage of the total funding each agency would receive.

Action Item 4.2.1

This approach ensures that funding is distributed equitably and transparently, based on measurable financial need and demonstrated fiscal stewardship. It also incentivizes agencies to diversify their funding sources and strengthens the overall sustainability of the emergency shelter system.

FUNDING RECOMMENDATIONS

The Grant Review Committee recommended funding for two affordable housing projects funded through HHAP-4 and HHAP-5 that demonstrated strong readiness and the potential for timely completion. These include:

- Transitions-Mental Health Association (TMHA) for the acquisition of two existing properties in the City of San Luis Obispo as part of the *Housing NOW* Permanent Supportive Housing (PSH) project.
- People's Self-Help Housing for the development of 72 new units of affordable housing at *Paseo Paloma* in the City of Atascadero.

Among all affordable housing applications received, the committee agreed these two projects were the most likely to move forward quickly and successfully.

For interim shelter operations, the committee recommended funding for 5Cities Homeless Coalition, Community Action Partnership of San Luis Obispo (CAPSLO), and El Camino Homeless Organization (ECHO) through HHAP-4 and HHAP-5. These recommendations were based on a formula-driven approach using the previous year's HMIS Annual Performance Report (APR) data. The formula considered three key metrics: the number of clients served, the proportion of chronically homeless individuals served, and the percentage of clients who exited to permanent housing. This approach was designed to equitably allocate funding based on both scale and effectiveness, while also recognizing the challenges faced by shelters serving high-need populations.

The committee also recommended continued funding for 5Cities Homeless Coalition's youth-focused programs through the youth set-aside allocations in both HHAP-4 and HHAP-5. This recommendation was similarly informed by HMIS APR data and reflects 5CHC's strong performance in serving youth experiencing homelessness.

Three agencies were recommended for funding to provide supportive services in permanent supportive housing units:

- Housing Authority of San Luis Obispo (HASLO) for services at the Paso Homekey site,
- People's Self-Help Housing for multiple PSH properties,
- Restorative Partners to support housing stability at the proposed Healing and Restoration Campus in San Luis Obispo.

For the State ESG program, the committee recommended funding for:

- CAPSLO to support operations at the 40 Prado Homeless Services Center,
- ECHO for shelter operations in Atascadero and Paso Robles, and for Rapid Rehousing assistance in North County,
- 5Cities Homeless Coalition to provide Rapid Rehousing assistance in the Central and South County.

Action Item 4.2.1

Under the PLHA – Pismo Beach allocation, 5Cities Homeless Coalition was recommended to provide Rapid Rehousing and Homeless Prevention Housing Navigation services in South County.

Regarding the Supplemental County General Funds, the committee reviewed applications from seven agencies. After review and consideration of all the applications, the committee focused on sustaining the existing interim shelter system, in alignment with the Board-approved funding guidelines. Two applications were deemed ineligible:

1. Restorative Partners requested funding for capital improvements to renovate a historic Victorian house at the Healing and Restoration Campus. However, capital projects were not eligible under this funding source.
2. SLO Food Bank proposed a valuable project to provide no-cook food bags for unsheltered residents. Unfortunately, the organization was ineligible because its prior funding in FY 2023–24 was for outreach, which fell outside the eligible activity categories for this round.

Additionally, CAPSLO's request included \$200,000 for renovation of a lobby and laundry facility. As capital improvements were not eligible, that portion of the request was excluded from consideration, while the remainder was evaluated by the committee.

To ensure a fair and strategic distribution of these funds, a financial model was used to assess operational need and fiscal responsibility. This model considered each agency's annual operating budget, total leveraged funding, identified funding gaps, and the percentage of leveraged funds from non-county sources.

The committee ultimately recommended 5Cities Homeless Coalition, CAPSLO, ECHO, and Lumina Alliance for one-time supplemental funding to help address operational funding gaps in their interim shelter programs.

The Committee decided not to allocate \$184,649 of the one-time Supplemental County General Funds at this time. After reviewing agency needs and applying the financial model, the committee determined that allocating this remaining amount would have exceeded the total funding requested by eligible interim shelter agencies. Staff will bring a recommendation to the BOS in December 2025 to include the balance of this funding (under the same requirements and priorities outlined in the RFP) as part of the 2026 Action Plan funding recommendations.

These funding recommendations align with the priorities established by HSOC and the BOS and support the implementation of the San Luis Obispo Countywide Plan to Address Homelessness, specifically:

- Line of Effort 1: Create affordable and appropriately designed housing opportunities and shelter options for underserved populations.
- Line of Effort 2: Focus efforts to reduce or eliminate barriers to housing stability for those experiencing or at risk of homelessness, including prevention, diversion, supportive services, and housing navigation.

Action Item 4.2.1

A list of all project application recommendations is included in Exhibit B.

BUDGET/FINANCIAL IMPACT:

This will have no financial impact on the HSOC. Should the Board approve the HSOC's recommendations in December, it will result in approximately \$5,840,327 being made available for homeless services and affordable housing through HHAP-4, HHAP-5, PLHA, State ESG, and supplemental County General funding sources.

Staff will request approval from the BOS to allocate the remainder of the Supplemental County General funds in the amount of \$184,649 in the funding recommendations for the 2026 HUD Action Plan.

If approved, staff will release a competitive Request for Proposals for Prevention and Diversion projects with HHAP-4 funding in the amount of \$464,470.

Once the County expends 50% of the 1st disbursement of HHAP-5 by the expenditure deadline of May 31, 2026, the second disbursement should be awarded to the County.

STAFF COMMENTS:

On March 19, 2025, HSOC hosted a public listening session to gather input on funding priorities and the Countywide Plan to Address Homelessness. Participants emphasized the importance of sustaining existing shelter programs and expanding affordable housing.

The proposed funding recommendations for HHAP-4, HHAP-5, PLHA, State ESG, and Supplemental County General Funds align with the funding priorities identified from the HSOC Listening Session.

EXHIBIT A

AUGUST 2025 RFP PROJECT APPLICATION NARRATIVES

HHAP-4 and HHAP-5

APPLICANT NAME: Housing Authority of the City of San Luis Obispo

PROJECT NAME: Paso Homekey

FUNDING REQUESTED: \$240,631

PROJECT DESCRIPTION: The funding will support case managers that provide direct placement and retention services to the homeless and at risk in the 62 permanent supportive housing units. They will perform outreach, client interviewing and assessment, establishment and management of case plans, all designed to enable the homeless to be successful in leasing and retaining the housing. Supported housing of this type has proven to be very successful, and essential in keeping the homeless housed, particularly those with mental health challenges, substance use disorders, PTSD and other issues.

The funding will also support the conversion of underutilized spaces into a community room. Community rooms empower residents by providing choices and opportunities to pursue their goals and interests. They can participate in planning activities and programs, taking ownership of their shared space and fostering a sense of responsibility. This sense of belonging can be vital in transitioning from homelessness to stable housing and contributing to the community in meaningful ways.

APPLICANT NAME: Housing Authority of the City of Paso Robles (PRHA)

PROJECT NAME: 298 Niblick

FUNDING REQUESTED: \$ 800,000.00

PROJECT DESCRIPTION: 298 Niblick is a proposed age-restricted (55 years and older), low-income residential housing community in Paso Robles, designed to address the growing shortage of affordable housing for seniors in San Luis Obispo County. The development will feature 30 units in total, including one on-site manager's unit, with a thoughtfully planned mix of 24 one-bedroom units and 6 two-bedroom units, ranging from approximately 626 to 885 square feet. The design prioritizes accessibility, safety, and community integration for older adults. Residents will benefit from Photovoltaic (PV) energy generation that will lower their residential utility rates as well as the project's overall

electricity expenses, lessening the economic liability for this vulnerable population. The target population includes residents from Paso Robles, the broader County of San Luis Obispo, and surrounding areas who meet both the age and income qualifications. All units will be rent restricted to households earning 30% to 60% of the Area Median Income (AMI), ensuring long-term affordability. 25% of the units will be specifically reserved for individuals and families who are “homeless” or “at risk of homelessness”, addressing a critical gap in the region’s housing continuum.

APPLICANT NAME: Transitions-Mental Health Association

PROJECT NAME: TMHA Housing NOW Property Expansion

FUNDING REQUESTED: \$ 450,000.00

PROJECT DESCRIPTION: TMHA’s Housing NOW program has been in operation for 10 years. Using a Housing First model, the program assists our County’s most vulnerable unhoused disabled community members. Since program inception, over 230 individuals and family members have received permanent supportive housing. Throughout the life of the program, adding to and maintaining our stock of viable properties remains a challenge.

TMHA has the opportunity to purchase two properties (8 units total) from the Housing Authority of San Luis Obispo. The first is located at 8753 Atascadero Avenue in the City of Atascadero. The house is 1,525 square feet on a .25 acre lot, built in 1964. It has 4 bedrooms and 2 baths, and currently houses 4 clients in TMHA's Housing NOW program. The second property is at 1480 Laurel Lane in the City of San Luis Obispo. This property is 1,938 square feet on a 7,540 square foot lot, built in 1962. It also has 4 bedrooms and 2 baths, and currently houses 4 clients in Housing NOW. Our expectation is that we will be able to purchase the two properties for \$1.4 million with a 10% down payment. Both houses will then need new appliances, windows, flooring and paint to improve living conditions and lower utility bills in the long-term.

APPLICANT NAME: Community Action Partnership of San Luis Obispo County, Inc. (CAPSLO)

PROJECT NAME: 40 Prado Homeless Services Center

FUNDING REQUESTED: \$ 1,614,245.00

PROJECT DESCRIPTION: The 40 Prado Homeless Services Center (Prado HSC) offers an Access Center and emergency shelter services, meals, showers, health screenings at the CHC on-site clinic, services to dual-diagnosed individuals, recuperative care for those recently released from the hospital, a Warming/Cooling Center during inclement weather, a Safe Parking program, animal kennels, laundry, internet access, and a mail and message center to facilitate job and housing searches. Case managers and staff assist clients in creating individualized plans to obtain housing and self-sufficiency.

CAPSLO operates the largest shelter program in SLO County, frequently providing shelter for 130-150 households per night through hoteling, shelter beds at Prado HSC, and the Overflow, Safe Parking and Warming/Cooling Center Programs.

Funding received for HHAP-4 and HHAP-5 will be used for staff costs at Prado HSC: housing navigators, Homeless Shelter Workers, housing stabilization/case manager, operating expenses, support at South Street and St. Stephen's offices (rent, office supplies, storage unit for outreach supplies).

CAPSLO was able to house 221 participants in the 24-25 fiscal year. We project that 250 will be housed, and 811 sheltered in 2025-2026.

APPLICANT NAME: People's Self-Help Housing Corporation

PROJECT NAME: Paseo Paloma

FUNDING REQUESTED: \$ 1,548,233.00

PROJECT DESCRIPTION: Paseo Paloma will bring 72 new affordable homes to a 2.5-acre site at El Camino Real and Musselman Drive in Atascadero. The state-owned land was declared surplus under Governor Newsom's Executive Order N-06-19 to promote affordable housing. In June 2023, PSHH secured site control through a Lease Option Agreement with the California Department of General Services, Housing and Community Development, and State Hospitals. The project will proceed under State Sovereignty entitlement for excess state land. The 72 rental units (1-3 bedrooms) will serve households and families earning 30-60% of AMI, with 5 homes reserved for individuals at risk of homelessness. A central community building will feature offices, a community room, kitchen, laundry, and maintenance space. Outdoor amenities include a basketball court, picnic areas, tot lot, and bike parking. On-site supportive services will help residents remain stably housed. Residences will be in three 3-story buildings inspired by Atascadero's historic colony and farmhouse architecture, with steep gables, large windows, and natural

tones. This all-electric project will use solar energy, water-efficient landscaping, and high-efficiency fixtures, exceeding environmental standards.

APPLICANT NAME: El Camino Homeless Organization (ECHO)

PROJECT NAME: ECHO Paso Robles & ECHO Atascadero

FUNDING REQUESTED: \$ 3,679,509.98

PROJECT DESCRIPTION: ECHO operates two Navigation Centers, ECHO Atascadero and ECHO Paso Robles, each with comprehensive services for San Luis Obispo County residents experiencing homelessness and those in danger of becoming homeless. ECHO also works to meet the needs of unsheltered residents who have not yet sought emergency shelter through street outreach services and the needs of residents who are housed but in danger of losing their housing through homeless prevention services. ECHO's Navigation Centers operate 90-Day Emergency Shelter programs that support clients in securing permanent housing; with this support, 60% of clients who participate for at least 30 days find a home.

Requested funds will support the operations of both Navigation Centers including shelter services, shelter and outreach case management, shelter coordination, eviction prevention and rapid rehousing case management and housing assistance funds, volunteer coordination, staff supervision, and administration costs. A total of 1,330 clients per year are expected to access services. ECHO leverages volunteers, partners, and community support to serve and house a large number of people with a small operating budget.

APPLICANT NAME: People's Self-Help Housing

PROJECT NAME: Supportive Housing Program for Non-Chronically Homeless Households in Permanent Supportive Housing

FUNDING REQUESTED: \$ 558,414.00

PROJECT DESCRIPTION: PSHH will provide comprehensive supportive services to 89 households experiencing homelessness across five properties in San Luis Obispo and Pismo Beach, including 35 TAY units. Our Supportive Housing Program delivers immediate services with no waiting lists through licensed clinical social workers (AMFTs, LMFTs, ACSWs, LCSWs). Services include intensive case management, crisis intervention, benefits enrollment (SSI/SSDI with SOAR-trained staff, SNAP, Medi-Cal), This proposal the requests equivalent of one year of program support for all units listed.

Projected Outcomes:

- Serve 89 households annually across 89
- 98% housing retention rate
- 100% eligible households enrolled in Medi-Cal
- 100% TAY participants connected to age-appropriate services

The project leverages PSHH's proven model demonstrating 99.9% retention rates, combining HHAP funding with other resources to ensure comprehensive wraparound services.

APPLICANT NAME: People's Self-Help Housing Corporation

PROJECT NAME: Cambria Pines Apartments

FUNDING REQUESTED: \$ 1,769,800.00

PROJECT DESCRIPTION: Cambria Pines Apartments will bring 33 new affordable homes to the Cambria community. The 33 rental units (1–3 bedrooms) will serve households earning 30–60% of AMI, with 8 homes reserved for individuals experiencing homelessness. Project design supports older adults and the medically vulnerable in that 10% of units will be designed with communication features for the hearing and vision impaired and 15% of units will have mobility accessibility features. Amenities include a community building with on-site shared laundry, community room, playground, and picnic areas. All residents regardless of income level will be offered free on-site enriched services, and residents who were previously experiencing homelessness will additionally have access to on-site licensed clinical social workers through PSHH's Supportive Housing Program (SHP). The SHP provides free, voluntary, and confidential services to PSHH residents. The program is designed to assist residents in achieving and maintaining independent functioning and self-sufficiency by providing direct services that include crisis intervention, case management, counseling, homeless prevention, home management, financial management, advocacy, assistance with obtaining benefits, etc.

APPLICANT NAME: 5Cities Homeless Coalition

PROJECT NAME: Shelter and Winter Warming Center Operations

FUNDING REQUESTED: \$ 1,215,000.00

PROJECT DESCRIPTION: 5CHC has operated a winter warming center for more than 10 years and in 2022 added the first permanent shelter in South County, with the opening of the Cabins for Change program. This 20 bed facility provides shelter, basic needs and housing stabilization/navigation services. A second 30-bed facility, Balay Ko On Barca, opened in July 2024 and operates similarly to Cabins for Change. These programs are targeted so serve those who are most vulnerable and chronically homeless. The average length of time homeless prior to program entry for clients served in 24-25 was 4.23 years; with more than 100 reporting co-occurring disorders (such as substance abuse and mental illness).

APPLICANT NAME: 5Cities Homeless Coalition

PROJECT NAME: Transitional Age Youth - Housing Navigation and Sheltering Countywide

FUNDING REQUESTED: \$ 294,045.00

PROJECT DESCRIPTION: 5CHC seeks funding to serve at least 80 TAY youth annually, plus full-time case management of 30 TAY at Beacon Studios Homekey Project in partnership with People's Self-Help Housing (opening 2026). This request includes housing support expenses for non-Homekey participants and three case managers to allow for expanded services. Through this program 5CHC offers intensive case management with added support for housing, basic needs, benefits acquisition, transportation, financial literacy, job development, and education.

The program includes a variety of housing options that will be individually tailored to client needs including short-term Rapid Re-Housing assistance; transitional housing through master leases, emergency housing vouchers, and a variety of services to support housing search, housing stabilization, family reunification, safety and basic needs.

Based on the tenets of Housing First, 5CHC works to offer voluntary developmentally-appropriate programs. Services will be prioritized for those most vulnerable, including pregnant and parenting youth; LGBTQ+; youth of color; those who do not yet have a high-school diploma; and those of very-low income.

APPLICANT NAME: Restorative Partners, Inc.

PROJECT NAME: The Path Forward Project 2025

FUNDING REQUESTED: \$ 590,794.08

PROJECT DESCRIPTION: The Path Forward Project 2025 is an evidence-based initiative supporting justice-involved individuals in the San Luis Obispo community. Through comprehensive risk and needs assessments, individualized reentry plans are developed to maximize long term success. As the county's recognized reentry leader, RP will ultimately serve 56 participants, aiming for 85% of them to successfully complete their individualized reentry plans, while reducing recidivism by 90% and achieving income stability for 75% of participants within six months. Participants will receive wraparound services including case management, career coaching, prosocial workshops, vital documents, employment and education support, transportation, housing navigation, and financial planning. Staff remain committed to continuous training and participant responsiveness to ensure quality care. With HHAP 4 funding, 27 individuals will be housed for six months while their dwellings are brought up to H&S Code, eliminating unsheltered homelessness during renovation. Built on proven Warm Handoff Reentry Services and Housing First models, this project leverages stable housing and intensive support to reduce recidivism, foster independence, and create safer communities.

PROJECT NAME: 40 Prado Homeless Services Center (Prado HSC)

FUNDING REQUESTED: \$ 52,317.00

PROJECT DESCRIPTION: The 40 Prado Homeless Services Center (Prado HSC) in San Luis Obispo offers an Access Center and emergency shelter services, meals, showers, health screenings at the CHC on-site clinic, services to dual-diagnosed individuals, recuperative care for those recently released from the hospital, a Warming/Cooling Center during inclement weather, a Safe Parking program, animal kennels, a community garden, laundry, internet access, and a mail and message center to facilitate job and housing searches. Case managers and staff assist clients in creating individualized plans with set goals and objectives to obtain housing and self-sufficiency.

CAPSLO operates the largest shelter program in SLO County, frequently providing shelter for 130-150 households per night through hoteling, shelter beds at Prado HSC, and the Overflow, Safe Parking and Warming/Cooling Center Programs.

HCD-ESG funding will be utilized for utility costs of 40 Prado Homeless Services Center, program supplies, and client assistance as they move from the shelter into permanent housing, which could be furniture and/or other necessary household items.

With its new Housing Focused Shelter Program, CAPSLO was able to house 221 participants in the 24-25 fiscal year. We project that 250 will be housed, and 811 sheltered in 2025-2026.

APPLICANT NAME: El Camino Homeless Organization (ECHO)

PROJECT NAME: ECHO Paso Robles & ECHO Atascadero

FUNDING REQUESTED: \$ 123,179.00

PROJECT DESCRIPTION: ECHO operates two Navigation Centers, ECHO Atascadero and ECHO Paso Robles, each with comprehensive services for San Luis Obispo County residents experiencing homelessness and those in danger of becoming homeless. ECHO also works to meet the needs of unsheltered residents who have not yet sought emergency shelter through street outreach services and the needs of residents who are housed but in danger of losing their housing through homeless prevention services. ECHO's Navigation Centers operate 90-Day Emergency Shelter programs that support clients in securing permanent housing; with this support, 60% of clients who participate for at least 30 days find a home.

PROJECT DESCRIPTION: The County of SLO has supported Lumina Alliance's Emergency Shelter Program for more than a decade, and ESG funding was awarded in Spring 2024 to

help our organization bridge the growing gap between SA/IPV survivors' countywide need for emergency support and our capacity to provide the necessary shelter and services. Our agency operates two emergency shelters in safe, confidential locations in Atascadero and SLO for survivors fleeing SA/IPV. Shelter residents and their families are offered a variety of wraparound supportive services including a 24-hour crisis and information line, clinical therapy, self-sufficiency planning, referrals, advocacy, and accompaniment services. Lumina Alliance also provides homelessness prevention through housing relocation and stabilization services, such as covering hotel or motel stays and short- or medium-term rental assistance to help survivors remain in or obtain safe housing. We project the following outcomes through anonymous client surveys after receiving services: 50 survivors and their families will receive emergency shelter and services or homelessness prevention assistance during the grant period, 80% of clients report increased self-sufficiency, 80% of clients report increased self-esteem, 80% of clients report increased sense of safety, and 80% of clients report that services were culturally-appropriate.

APPLICANT NAME: 5Cities Homeless Coalition

PROJECT NAME: South County Rapid Re-Housing and Street Outreach Program

FUNDING REQUESTED: \$95,804

PROJECT DESCRIPTION: Rapid Re-Housing: Utilizing a strengths-based approach, 5CHC's housing stabilization team works with the participant to focus on the household's resources and strengths that can be called upon to address their barriers to stable housing. A case plan is jointly developed for actions steps for housing stability. Each program participant is assisted with case management and education sessions offered by 5CHC staff and volunteers to address the breath of issues that can affect housing stability.

Street Outreach: 5CHC seeks continued funding for its highly successful Outreach Program, serving the southern portion of San Luis Obispo County (including the Santa Maria Riverbed). People living on the streets are more than likely to suffer from poor health conditions that are generally neglected as far as treatment is concerned due to issues of poverty, ignorance.

Increased prevalence of substance use in this population further adds to the concern of poor treatment outcomes. These unmet needs such as poverty, job concerns, poor access to food supply add to mental stress and burden and lead to poor immunity, in the background of poor hygienic conditions. 5CHC engages to help clients overcome systemic

fear and complex housing barriers, by providing basic necessities, and access appropriate service interactions through a model of progressive engagement.

APPLICANT NAME: 5Cities Homeless Coalition

PROJECT NAME: Rapid Rehousing and Homeless Prevention Housing Navigation - South County

FUNDING REQUESTED: \$ 65,804.00

PROJECT DESCRIPTION: 5CHC seeks to continue its highly successful housing navigation program (for both Rapid Rehousing and Homeless Prevention) to help families at-risk of homeless remain in their home, with an anticipated 11 households (35 people) receiving assistance. 5CHC's track record has demonstrated that less than 5% of those served in the prior 24 months have fallen into homelessness after receiving assistance.

APPLICANT NAME: Lumina Alliance

PROJECT NAME: Emergency Shelter and Supportive Services for Sexual Assault and Intimate Partner Violence Survivors

FUNDING REQUESTED: \$ 104,253.00

PROJECT DESCRIPTION: The County of SLO's GFS funding has supported Lumina Alliance's Emergency Shelter Program for more than a decade to provide SA/IPV survivors' countywide with emergency shelter and supportive services. Our agency operates two emergency shelters in safe, confidential locations in Atascadero and SLO for survivors fleeing SA/IPV. Shelter residents and their families are offered a variety of wraparound supportive services including a 24-hour crisis and information line, clinical therapy, self-sufficiency planning, referrals, advocacy, and accompaniment services. We project the following outcomes through anonymous client surveys after receiving services: 100 survivors and their families will receive emergency shelter and supportive services during the grant period, 80% of clients report increased self-sufficiency, 80% of clients report increased self-esteem, 80% of clients report increased sense of safety, and 80% of clients report that services were culturally-appropriate.

APPLICANT NAME: Community Action Partnership of San Luis Obispo County, Inc. (CAPSLO)

PROJECT NAME: 40 Prado Homeless Services Center (Prado HSC)

FUNDING REQUESTED: \$ 833,932.00

PROJECT DESCRIPTION: Prado HSC offers an Access Center, emergency shelter services, meals, showers, health screenings at the CHC on-site clinic, services to dual-diagnosed individuals, recuperative care, a Warming/Cooling Center during inclement weather, a Safe Parking program, animal kennels, laundry, internet access, and a mail and message center.

Supplemental General Fund support will be utilized to fund staff, including homeless shelter workers.

In order to increase safety for clients, CAPSLO proposes building a lobby to Prado HSC to accommodate a reception desk, seating area, and new doors to the main facility that guests access once checked in. Guests who are simply picking up their mail or need a grab-and-go snack can be served without entrance into the main sleeping and dining areas. Re-doing the front entry way for safety will change the flow of the building and implementation of day habilitation.

The current laundry facility for Prado HSC does not meet the needs of the population served. There are critical electrical and appliance upgrades needed for the laundry facility to be running at full capacity. These upgrades would ensure daily laundry services for anyone who needs it and the ability for staff to launder all program materials.

APPLICANT NAME: Restorative Partners

PROJECT NAME: Bridge to HARC

FUNDING REQUESTED: \$ 317,727.80

PROJECT DESCRIPTION: Restorative Partners (RP) seeks funding to renovate the historic Victorian house at DeVaul Ranch, the Healing and Restoration Campus, into a trauma-informed hub for wraparound services. Renovations will modernize infrastructure, reconfigure spaces into counseling rooms, flexible program areas, and communal spaces, and upgrade bathrooms and kitchenette to ensure safety, accessibility, and H&S code compliance. The restored facility will expand RP's capacity to provide case management,

counseling, career coaching, housing navigation, and financial literacy. By creating both private and open areas, RP will enhance confidentiality, engagement, and service quality, directly improving outcomes. Once operational, the program will serve 56+ participants annually, achieving: 85% completion of individualized reentry plans, 90% reduction in recidivism, and 75% income stability within six months. With HHAP-4 support, 27+ individuals will also be housed for six months during renovation, eliminating unsheltered homelessness. The project preserves a valuable community asset while modeling restorative justice, equity, and innovation to create safer, healthier neighborhoods.

FUNDING REQUESTED: \$ 833,333.00

Utilizing a strengths-based approach, 5CHC's housing stabilization team works with the participant to focus on the household's resources and strengths that can be called upon to address their barriers to stable housing. Street Outreach: 5CHC seeks continued funding for its highly successful Outreach Program, serving the southern portion of San Luis Obispo County (including the Santa Maria Riverbed). Shelter: 5CHC has added 50 permanent shelter beds in South County since 2022. These programs are targeted so serve those who are most vulnerable and chronically homeless. The average length of time homeless prior to program entry for clients served in 24-25 was 4.23 years; with more than 100 reporting co-occurring disorders (such as substance abuse and mental illness).

PROJECT DESCRIPTION: No-Cook Bags are bags of healthy, portable foods designed for the diverse homeless population of San Luis Obispo County. The name of the bags refers to the ability of their contents to be safely enjoyed without access to a stove, refrigerator, or kitchen equipment. Each No-Cook Bag is carefully curated to contain a full day's supply of foods that meet the unique nutritional and dental challenges experienced by homeless residents, including shelf-stable proteins, snack items, and nutritious drinks. These bags are distributed by community partners throughout San Luis Obispo County who work directly with people experiencing homelessness, including nonprofits and faith-based organizations, as well as County of San Luis Obispo law enforcement and social service departments.

Each No-Cook Bag contains one day's worth of food at a cost of \$4.80, enough for three meals and three snacks. We plan to distribute 2,600 bags per month in 2025-26 to meet the high level of demand from community partners and ensure that our unhoused neighbors have the food they need to survive.
