**1. Call to Order and Introductions**

Jack called the meeting to order at 9:04am. Introductions were made by those present at the meeting.

**2. Public Comment**

No public comment presented.

### **3. Consent: Approval of Minutes**

Janna moved the motion to approve the minutes. Allison seconded. Voice vote was taken, and minutes were approved unanimously.

### **4. Action/Information/Discussion**

#### **4.1. I Action Item: Approve Emergency Transfer Plan Policy for Victims of Domestic Violence, Dating Violence, Sexual Assault, and/or Stalking**

Janna moved the motion for approval with the amendment that Housing Provider language needs to be further defined. Jack seconded. The roll was called, and all were in favor and the motion passed.

#### **4.2. Committee Updates**

##### **4.2.1. Information Item: Warming and Cooling Centers**

Jack shared at CAPSLO at Prado operates a cooling center when there is a heat advisory according to the NOAA (National Oceanic and Atmospheric Administration) forecast, specific to the San Luis Obispo zip code. People are welcome to come at 8am. There is no capacity limit. He mentioned that they offer showers, laundry, meals, hygiene kits, etc. The warming center is offered when the temperature is at 38 degrees or colder or 50 percent chance of rain or higher, and is open from 4pm through 6am. Nobody who has sex offender background is allowed. Pets (with vaccination documents) are allowed.

Janna reported that 5 Cities Homeless Coalition Center has now acquired a building to serve as a permanent site for their warming center located at 1023 East Grand in Arroyo Grande. The building has a capacity to accommodate 34 people. They take families as well. They have adopted the same criteria as CAPSLO, that they open when the temperature is at 38 degrees or colder or there is 50 percent chance of rain or higher. Janna also shared that they do not take individuals with sex offender criminal background and those with history of manufacturing of drugs. They are not currently operating a cooling center. She also mentioned that in addition to the flyer with a QR code and sending out an e-blast, they also have a text messaging service for those who want to be notified when the center is open.

Austin reported that ECHO in Paso Robles offers a day use cooling center when the temperature is 95 degrees and above, from 10am through 4 pm, and as long as they have available staff. They are also running a shower program, Monday through Friday. He also mentioned that they do not offer overnight warming shelter services, just day use warming center during cold and extreme weather conditions.

Suzie presented slides showing weather center notifications.
