A. Changes to the Dissolution Law - See attached on Summary of SB 107 published by the League of California Cities.
B. Last \& Final ROPS - SB 107 provides that a Last \& Final ROPS may be prepared beginning January, 2016, as follows:

Health \& Safety Code Section 34191.6: (a) Beginning January 1, 2016, successor agencies may submit a Last and Final Recognized Obligation Payment Schedule for approval by the oversight board and the department if all of the following conditions are met: (1) the remaining debt of a successor agency is limited to administrative costs and payments pursuant to enforceable obligations with defined payment schedules including, but not limited to, debt service, loan agreements, and contracts; (2) all
remaining obligations have been previously listed on a Recognized Obligation Payment Schedule and approved for payment by the department pursuant to subdivision ( m ) or (o) of Section 34177; and (3) the successor agency is not a party to outstanding or unresolved litigation.

Though the DLA is not a party to Lucia Mar's current appeal, it is a named party to the lawsuit filed by the School District which is the subject of the appeal. As a result, Successor Agency and Oversight Board counsel consider the Successor Agency to be a party to outstanding or unresolved litigation under the statute, and therefore not eligible to file Last \& Final ROPS at this time.
C. Status of Lucia Mar Unified School District Litigation - The District has appealed the Judgment requiring it to file the case in Sacramento. Such appeal could result in the case staying in San Luis Obispo County for up to a year. The District and Department of Finance completed briefing their respective cases at the Appeals Court as of December 31, 2015, and amicus briefs were recently filed in the case. The parties are scheduled for oral argument April 13, 2016. There is no required action of the DLA unless and until the case is removed to Sacramento.
D. Estimated Timing for Closure of DLA - There have been no changes since the last meeting. The DLA cannot be closed until the Lucia Mar litigation is resolved and the housing entity administrative cost allowance is paid in full (which is anticipated to be no later than December 31, 2018). If the litigation is resolved prior to that date, the DLA may request to close earlier, but DOF will have no obligation to permit an earlier closure.
E. Update on Housing Asset Transfer - There have been no changes since the last meeting. The Department of Finance ("DOF") approved both the transfer of the housing assets and the payment of the housing cost administrative cost allowance ("HACA") to HASLO. All housing assets have been transferred to HASLO and all HACA received to date has been paid to HASLO. The ROPS 16-17 includes a request for HACA consistent with the amounts approved by the DLA, Oversight Board and DOF.
