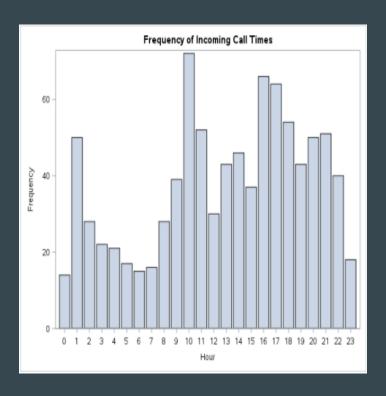

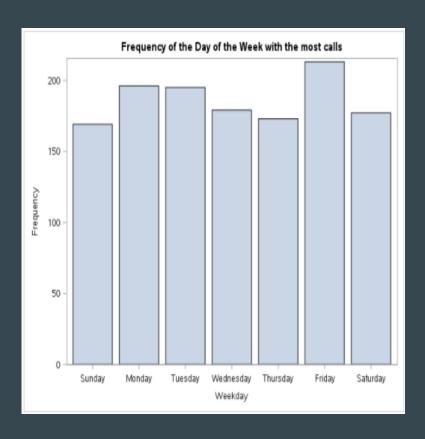

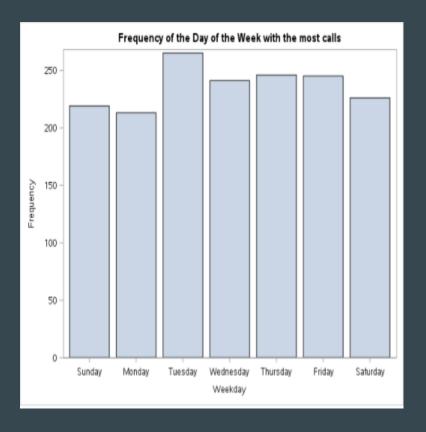




Year 15-16 Year 16-17

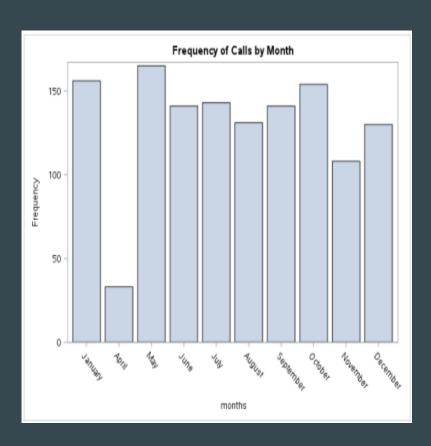
Day of the Week

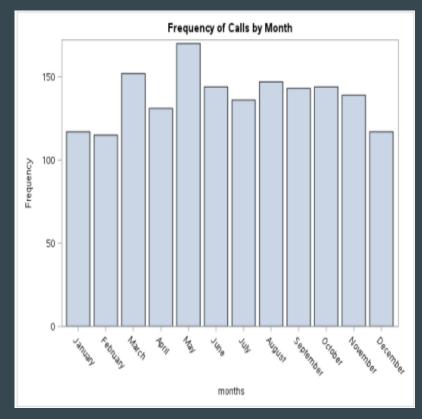




Year 15-16 Year 16-17

Frequency of Months





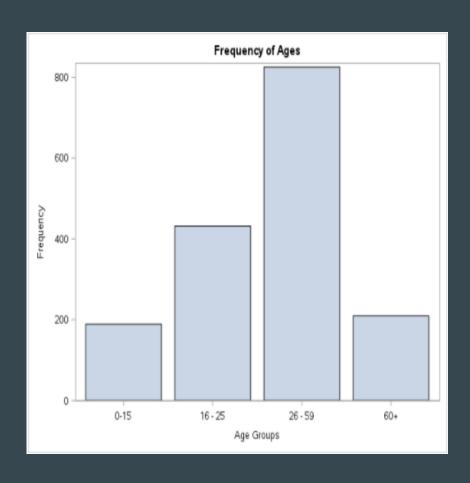

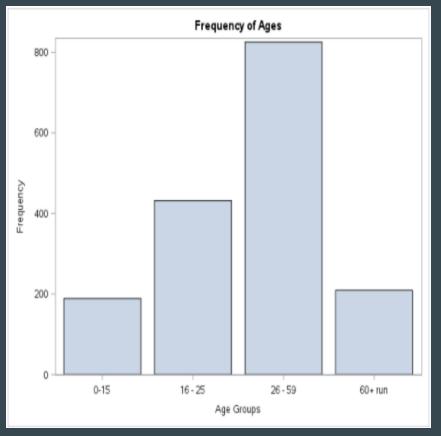
Day of the Year

The days of the year where responders received the most calls in the 2015-2016 fiscal year were May 17th (15 calls), September 18th (13 calls), and June 24th (11 calls).

The most common days of the year for which responders received calls in the 2016-2017 fiscal year were June 7th (13 calls), August 3rd (13 calls), March 26th (12 calls), May 5th (12 calls), September 28th (12 calls) and December 17th (12 calls).

Suggestions

- Use drop down menus for the majority of the variables
- Keep note section consistent (consistent abbreviations, capitalization, decrease spelling mistakes, etc.)
- Create a variable that can measure the client's baseline health so we can see if their health improved after the call (can then be measured again in the follow up call)

Prevention & Early Intervention (PEI)

- 1. Mental Health Awareness and Stigma Reduction (TMHA & SLOBHD)
 - 1. Approval of Suicide Prevention Coordinator (approx. \$102k)
- 2. School-based Wellness (CAPSLO, SLOBHD, & The LINK))
- 3. Family Education and Support (Center for Family Strengthening (CFS), CAPSLO)
- 4. Early Care and Support for Underserved Populations (Cuesta College, Public Health & Wilshire CS)
- Integrated Community Wellness (Community Counseling Center, TMHA & SLOBHD)
- Stakeholders approved increase of \$35k for CalMHSA statewide PEI projects
- We will seek MAC approval (in lieu of PEI stakeholder mtg) for a LGBTQ Needs Assessment
 - One-time cost of \$25-30k (based on Cal Poly indirect rate)
 - Will not affect future spending of \$33k for new programming

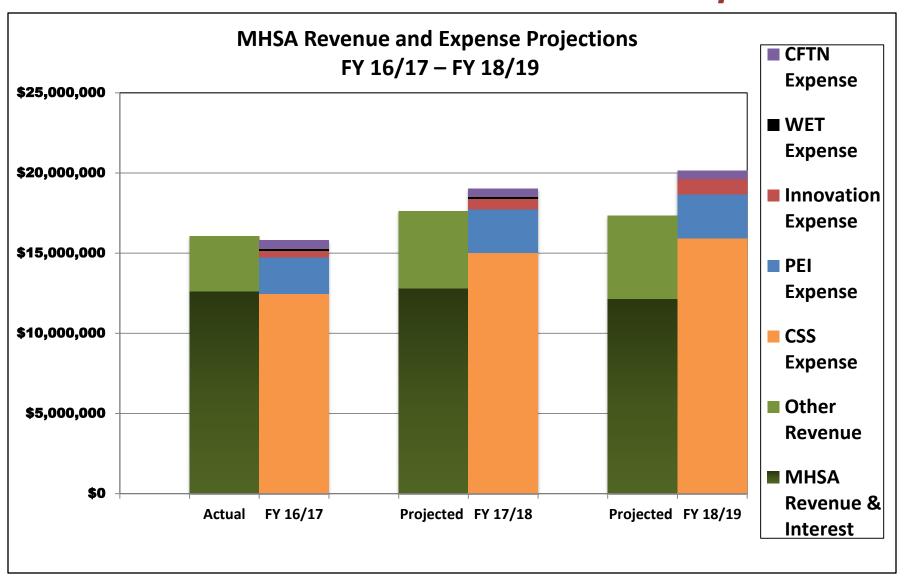

MHSA Fiscal Update



MHSA Quick Fiscal Update

- <u>CSS</u>
- Total addition \$500K
- Less (115K) for CAT member
- Remaining \$385K
- Less (120K) for WET transfer or movement of programs to CSS (with MAC approval)
- Remaining \$265
- PEI
- Total addition \$170K
- Less (35K) for CalMHSA increase
- Less (102K) for Suicide Prevention Coordinator
- Remaining \$33K
- Less (25K) LGBTQ Needs Assessment (with MAC approval)
- Remaining \$8K in 17-18 (\$33k beginning 18-19)

MHSA Quick Fiscal Update

- Innovation Update:
 - Next round of planning to be begin in FY 17/18
 - Can add up to \$300K in FY 18/19
 - Can potentially add up to \$200K in FY 19/20
- Workforce, Education & Training Update:
 - Estimating by FY 18/19 there will be \$0 remaining from the initial allocation
 - Options:
 - Transfer WET programs into CSS
 - Transfer CSS funds to WET

Old Business

- O Support for Community Action Team
 - RFP in October
 - O \$115 approved in August
- **O** LGBTQ Needs Assessment
 - O Proposal adjusted to \$20k
 - O Negotiating indirect rate with Cal Poly
 - Recommending approval of one-time funds: \$25-30k
- O CSU: RFP for Services
 - Proposals due October 16
