The District Attorney of San Luis Obispo County, California, hereby accuses the
above named defendant of the following criminal offenses:

Count 1

On or about March 13, 2025, in the County of San Luis Obispo, State of California, the
crime of Possession Of Matter Depicting Minor Engaging In Sexual Conduct in violation of
PC311.11(a), a Felony, was committed in that GREGORY ALLEN KORNMAN did
knowingly and unlawfully possess and control matter, to wit: Child Pornography ON
DEFENDANT'S CELL PHONE the production of which involved the use of a person under

1 the age of 18 years, said defendant knowing that the matter depicted a person under the
2 age of 18 years, personally engaging in and simulating sexual conduct as defined in Penal
3 Code Section 311.4(d).

4 NOTICE: Conviction of this offense will require you to register pursuant to Penal Code
5 section 290. Willful failure to register is a crime.

6 **Sentencing Enhancement - Special Allegation #1**

7 It is further alleged as to Count 1 that at the time of the commission of the above offense,
8 the matter that was possessed by the defendant contained more than 600 images that
9 violate Penal Code section 311.11 subdivision (a), and the matter contains 10 or more
10 images involving a prepubescent minor or a minor who has not attained 12 years of age,
11 within the meaning of Penal Code section 311.11(c)(1).

12 NOTICE: A true finding of this special allegation increases the maximum punishment in
13 state prison for a conviction of the offense of Penal Code section 311.11(a).

14 **Sentencing Enhancement - Special Allegation #2**

15 It is further alleged as to Count 1 that at the time of the commission of the above offense,
16 the matter that was possessed by the defendant portrays sexual sadism or sexual
17 masochism involving a person under 18 years of age, within the meaning of Penal Code
18 section 311.11(c)(2).

6 It is further alleged as to Count 2 that at the time of the commission of the above offense,
7 the matter that was possessed by the defendant contained more than 600 images that
8 violate Penal Code section 311.11 subdivision (a), and the matter contains 10 or more
9 images involving a prepubescent minor or a minor who has not attained 12 years of age,
10 within the meaning of Penal Code section 311.11(c)(1).

11 NOTICE: A true finding of this special allegation increases the maximum punishment in
12 state prison for a conviction of the offense of Penal Code section 311.11(a).

13 **Sentencing Enhancement - Special Allegation #4**

14 It is further alleged as to Count 2 that at the time of the commission of the above offense,
15 the matter that was possessed by the defendant portrays sexual sadism or sexual
16 masochism involving a person under 18 years of age, within the meaning of Penal Code
17 section 311.11(c)(2).

18 NOTICE: A true finding of this special allegation increases the maximum punishment in

9 4.421(b)(5) The defendant's prior performance on probation, mandatory supervision, post
10 release community supervision, and parole was unsatisfactory.
