Count 1

On or about April 28, 2020, in the County of San Luis Obispo, State of California, the crime of Human Trafficking Of A Minor For A Sex Act in violation of PC236.1(c)(2), a Felony, was committed in that DOMINICK ANTHONY ALLEVA did willfully and unlawfully cause, induce and/or persuade, Jane Doe, who was less than 18 years of age, to engage in a commercial sex act, with the intent to effect and/or maintain a violation of Penal Code section 311.4.

Count 2

On or about March 15, 2020 to April 28, 2020, in the County of San Luis Obispo, State of California, the crime of Distribution of Child Pornography, in violation of Penal Code section 311.2(b), a Felony, was committed in that DOMINICK ANTHONY ALLEVA engaged in an act of unlawful sexual intercourse with Confidential Victim, a minor, not the spouse of the defendant, the minor being more than three years younger than the defendant.
