20 The District Attorney of San Luis Obispo County, California, hereby accuses the
21 above named defendant of the following criminal offenses:

22 Count 1

23 On or between September 30 to October 15, 2023, in the County of San Luis
24 Obispo, State of California, the crime of Lewd Act Upon A Child in violation of Penal Code
25 section 288(a), a FELONY, was committed in that TANNER WILLIAMDEAN FITE did
26 willfully, unlawfully, and lewdly commit a lewd and lascivious act upon and with the body
27 and certain parts and members thereof of Confidential Victim, a child under the age of
28

1 fourteen years, with the intent of arousing, appealing to, and gratifying the lust, passions,
2 and sexual desires of the said defendant; to wit Hand to Vagina (living room).

3 NOTICE: Conviction of this offense will require you to register pursuant to Penal Code
4 section 290. Willful failure to register is a crime.

5 NOTICE: Pursuant to Penal Code Sections 11166 and 11168, a Suspected Child Abuse
6 Report (SCAR) may have been generated in this case. Penal Code Section 11167 and
7 11167.5 limit access to a SCAR. A protective order issued by a court is necessary to
8 obtain a copy of the report.

9 NOTICE: The above offense is a serious felony within the meaning of Penal Code Section
10 1192.7(c) and a violent felony within the meaning of Penal Code Section 667.5(c)

11 NOTICE: Conviction of this offense will require the court to order you to submit to a blood
12 test for evidence of antibodies to the probable causative agent of Acquired Immune

14 **Count 2**

19 and certain parts and members thereof of Confidential Victim, a child under the age of
20 fourteen years, with the intent of arousing, appealing to, and gratifying the lust, passions,
21 and sexual desires of the said defendant; to wit Hand to Thigh (living room).

22 NOTICE: Conviction of this offense will require you to register pursuant to Penal Code
23 section 290. Willful failure to register is a crime.

24 NOTICE: Pursuant to Penal Code Sections 11166 and 11168, a Suspected Child Abuse
25 Report (SCAR) may have been generated in this case. Penal Code Section 11167 and
26 11167.5 limit access to a SCAR. A protective order issued by a court is necessary to
27 obtain a copy of the report.

1 NOTICE: The above offense is a serious felony within the meaning of Penal Code Section

7 On or between September 30 to October 15, 2023, in the County of San Luis Obispo,
8 State of California, the crime of Lewd Act Upon A Child in violation of Penal Code section
9 288(a), a FELONY, was committed in that TANNER WILLIAMDEAN FITE did willfully,
10 unlawfully, and lewdly commit a lewd and lascivious act upon and with the body and
11 certain parts and members thereof of Confidential Victim and Jane D, a child under the
12 age of fourteen years, with the intent of arousing, appealing to, and gratifying the lust,
13 passions, and sexual desires of the said defendant; to wit: Hand to Buttocks (living room).

14 NOTICE: Conviction of this offense will require you to register pursuant to Penal Code
15 section 290. Willful failure to register is a crime.

16 NOTICE: Pursuant to Penal Code Sections 11166 and 11168, a Suspected Child Abuse
17 Report (SCAR) may have been generated in this case. Penal Code Section 11167 and
18 11167.5 limit access to a SCAR. A protective order issued by a court is necessary to
19 obtain a copy of the report.

20 NOTICE: The above offense is a serious felony within the meaning of Penal Code Section

28 288(a), a FELONY, was committed in that TANNER WILLIAMDEAN FITE did willfully,

1 unlawfully, and lewdly commit a lewd and lascivious act upon and with the body and
2 certain parts and members thereof of Confidential Victim, a child under the age of fourteen
3 years, with the intent of arousing, appealing to, and gratifying the lust, passions, and
4 sexual desires of the said defendant; to wit: Hand to Vagina (bedroom).

5 NOTICE: Conviction of this offense will require you to register pursuant to Penal Code
6 section 290. Willful failure to register is a crime.

7 NOTICE: Pursuant to Penal Code Sections 11166 and 11168, a Suspected Child Abuse
8 Report (SCAR) may have been generated in this case. Penal Code Section 11167 and
9 11167.5 limit access to a SCAR. A protective order issued by a court is necessary to
10 obtain a copy of the report.

11 NOTICE is hereby given that adjudication as a ward of the Court for this offense and a
12 disposition to the California Youth Authority will require you to register pursuant to Section
13 290 of the Penal Code. Willful failure to register is a felony.

14 NOTICE: The above offense is a serious felony within the meaning of Penal Code Section
15 1192.7(c) and a violent felony within the meaning of Penal Code Section 667.5(c)

16
17 The People hereby give notice of the People's intent to admit evidence of prior sexual acts
18 pursuant to Evidence Code section 1108. These incidents include the prior incident(s)
19 described in the police report, chronological report, and/or tapes already provided, and
20 other alleged incidents of abuse, which will be provided as they are obtained by the
21 prosecution.

24 It is further alleged pursuant to Penal Code Section 1170(b)(2) that one or more of the
25 following factors in aggravation listed in California Rule of Court 4.421 may apply to the
26 defendant(s) or to conduct of the defendant(s):

27 4.421(a)(1) The crime involved great violence, great bodily harm, threat of great bodily
28 harm, and other acts disclosing a high degree of cruelty, viciousness and callousness.

- 1 4.421(a)(2) The defendant was armed with or used a weapon at the time of the
- 2 commission of the crime.
- 3 4.421(a)(3) The victim was particularly vulnerable.
- 4 4.421(a)(4) The defendant induced others to participate in the commission of the crime
- 5 and occupied a position of leadership and dominance of other participants in its
- 6 commission.
- 7 4.421(a)(5) The defendant induced a minor to commit and assist in the commission of the
- 8 crime.
- 9 4.421(a)(6) The defendant threatened witnesses, unlawfully prevented and dissuaded
- 10 witnesses from testifying, suborned perjury, and in any other way illegally interfered with
- 11 the judicial process.
- 12 4.421(a)(7) The defendant is charged with other crimes for which consecutive sentences
- 13 can be imposed but for which concurrent sentences shall be imposed.
- 14 4.421(a)(8) The manner in which the crime was carried out indicates planning,
- 15 sophistication, and professionalism.
- 16 4.421(a)(9) The crime involved an attempted or actual taking or damage of great monetary
- 17 value.
- 18 4.421(a)(10) The crime involved a large quantity of contraband.
- 19 4.421(a)(11) The defendant took advantage of a position of trust and confidence to commit
- 20 the offense.
- 21 4.421(a)(12) The crime constitutes a hate crime under section 422.55 of the Penal Code
- 22 and no hate crime enhancements under section 422.75 of the Penal Code shall be
- 23 imposed and the crime is not subject to sentencing under section 1170.8 of the Penal
- 24 Code.
- 25 4.421(b)(1) The defendant has engaged in violent conduct that indicates a serious danger
- 26 to society.
- 27 4.421(b)(2) The defendant's prior convictions as an adult and sustained petitions in
- 28 juvenile delinquency proceedings are numerous and of increasing seriousness.

1 4.421(b)(3) The defendant has served a prior term in prison and county jail under section
2 1170(h).

3 4.421(b)(4) The defendant was on probation, mandatory supervision, post release
4 community supervision, and parole when the crime was committed.

5 4.421(b)(5) The defendant's prior performance on probation, mandatory supervision, post
6 release community supervision, and parole was unsatisfactory.
