20 The District Attorney of San Luis Obispo County, California, hereby accuses the
21 above named defendant of the following criminal offenses:

22 Count 1

23 On or about June 4, 2022, in the County of San Luis Obispo, State of California, the crime
24 of Willful, Deliberate, And Premeditated Murder in violation of PC187(a), a Felony, was
25 committed in that ANGEL EDUARDO RAMOSRAMIREZ did unlawfully and with malice
26 aforethought murder Daniel Diaz, a human being. It is further alleged that the aforesaid
27 murder was committed willfully, deliberately and with premeditation within the meaning of

1 Penal Code section 189, and is a violent felony pursuant to Penal Code section 667.5(c)(1)
2 and a serious felony pursuant to Penal Code section 1192.7(c)(1).

Enhancement

PC12022(b)(1): Spec Alleg-Use Of Deadly Weapon

5 It is further alleged as to Count 1 that in the commission of the above offense, the said
6 defendant, ANGEL EDUARDO RAMOSRAMIREZ, personally used a deadly or dangerous
7 weapon, to wit, knife, said use not being an element of the above offense, within the
8 meaning of Penal Code Section 12022(b)(1), and causing the above offense to be a
9 serious felony within the meaning of Penal Code section 1192.7(c)(23).

Enhancement

PC186.22(b)(1): Spec Alleg-Street Terrorism - Serious Felony

12 It is further alleged pursuant to Penal Code section 186.22(b)(1) as to Count 1 that the
13 above offense was committed for the benefit of, at the direction of, or in association with a
14 criminal street gang with the specific intent to promote, further or assist in criminal conduct
15 by gang members. Said act also caused the above offense to become a serious felony
16 pursuant to Penal Code section 1192.7(c)(28).

17 NOTICE: Conviction of this offense will require you to register pursuant to Penal Code
18 section 186.30(a). Willful failure to register is a crime.

Enhancement

PC190.2(a)(22): Spec Alleg - Street Gang Murder

21 It is further alleged, pursuant to Penal Code Section 190.2(a)(22), that the defendant
22 intentionally murdered Daniel Diaz in the first degree while the defendant was an active
23 participant in a criminal street gang, as defined by Penal Code Section 186.22(f), and the
24 murder was carried out to further the activities of the criminal street gang.

Count 2

26 On or about September 4, 2021, in the County of San Luis Obispo, State of California, the
27 crime of Assault With A Deadly Weapon in violation of PC245(a)(1), a Felony, was

1 committed in that ANGEL EDUARDO RAMOSRAMIREZ did willfully and unlawfully commit
2 an assault upon Abel Cortezmoreno with a deadly weapon, to wit, a knife.
3 NOTICE: The above offense is a serious felony within the meaning of Penal Code Section
4 1192.7(c)(23).

Enhancement

PC969F(A): Spec Alleg-Serious Felony; Weapon Allegation

7 It is further alleged that as to the offense listed in Count 2, ANGEL EDUARDO
8 RAMOSRAMIREZ personally used a dangerous or deadly weapon, to wit a knife, within
9 the meaning of Sections 1192.7(c) and 667 and 969F(A) of the Penal Code.

Enhancement

PC12022.7(a): Spec Alleg-Great Bodily Injury

12 It is further alleged as to Count 2 that in the commission of the above offense the said
13 defendant, ANGEL EDUARDO RAMOSRAMIREZ, personally inflicted great bodily injury
14 upon Abel Cortezmoreno, not an accomplice to the above offense, within the meaning of
15 Penal Code Section 12022.7(a), and also causing the above offense to become a serious
16 felony within the meaning of Penal Code Section 1192.7(c)(8).

17 NOTICE: This offense is a serious felony and a violent felony within the meaning of Penal
18 Code sections 1192.7(c)(8) and 667.5(c)(8)

Prior

20 It is further alleged, pursuant to Penal Code section 667(a), that defendant ANGEL
21 EDUARDO RAMOSRAMIREZ has suffered the following prior conviction of a serious
22 felony:

1 Prior

2 It is further alleged, pursuant to Penal Code sections 667(d) and (e), and Penal Code
3 sections 1170.12(b) and (c), that defendant ANGEL EDUARDO RAMOSRAMIREZ has
4 suffered the following prior conviction of a serious and/or violent felony:

6 It is further alleged pursuant to Penal Code Section 1170(b)(2) that one or more of the
7 following factors in aggravation listed in California Rule of Court 4.421 may apply to the
8 defendant(s) or to conduct of the defendant(s):

9 4.421(a)(1) The crime involved great violence, great bodily harm, threat of great bodily
10 harm, and other acts disclosing a high degree of cruelty, viciousness and callousness.

11 4.421(a)(2) The defendant was armed with or used a weapon at the time of the
12 commission of the crime.

13 4.421(a)(3) The victim was particularly vulnerable.

14 4.421(a)(4) The defendant induced others to participate in the commission of the crime
15 and occupied a position of leadership and dominance of other participants in its
16 commission.

17 4.421(a)(5) The defendant induced a minor to commit and assist in the commission of the
18 crime.

19 4.421(a)(6) The defendant threatened witnesses, unlawfully prevented and dissuaded
20 witnesses from testifying, suborned perjury, and in any other way illegally interfered with
21 the judicial process.

22 4.421(a)(7) The defendant is charged with other crimes for which consecutive sentences
23 can be imposed but for which concurrent sentences shall be imposed.

24 4.421(a)(8) The manner in which the crime was carried out indicates planning,
25 sophistication, and professionalism.

1 4.421(a)(9) The crime involved an attempted or actual taking or damage of great monetary
2 value.

3 4.421(a)(10) The crime involved a large quantity of contraband.

4 4.421(a)(11) The defendant took advantage of a position of trust and confidence to commit
5 the offense.

6 4.421(a)(12) The crime constitutes a hate crime under section 422.55 of the Penal Code
7 and no hate crime enhancements under section 422.75 of the Penal Code shall be
8 imposed and the crime is not subject to sentencing under section 1170.8 of the Penal
9 Code.

10 4.421(b)(1) The defendant has engaged in violent conduct that indicates a serious danger
11 to society.

12 4.421(b)(2) The defendant's prior convictions as an adult and sustained petitions in
13 juvenile delinquency proceedings are numerous and of increasing seriousness.

14 4.421(b)(3) The defendant has served a prior term in prison and county jail under section
15 1170(h).

16 4.421(b)(4) The defendant was on probation, mandatory supervision, post release
17 community supervision, and parole when the crime was committed.

18 4.421(b)(5) The defendant's prior performance on probation, mandatory supervision, post
19 release community supervision, and parole was unsatisfactory.
