

Please consider these comments when considering proposed maps and adjustments to district boundaries.

I strongly caution against wholesale changes in district boundaries as I sense that this will be perceived by the public as motivated by political self-interest and partisan concerns. I readily expect that such action will be challenged in court, and while it may be challenging for the county to defend against in the legal arena, it would be even more difficult if not impossible for the board itself to defend against in the public arena.

With the delayed census results and unprecedented tight timeline for review, public input, board discussion, with eventual certification of district boundaries, I feel that the county would not benefit from a further delay which may be occasioned by a legal challenge to the final map. Most of the proposed maps before you include wholesale boundary changes, and I fear that pursuing this direction will further open your board up to public criticism and accusations of favoritism, if not outright partisanship. Persistent perceptions of partisan decision-making have already seriously weakened your board's leadership standing. Please do not add to this unproductive trend.

Much has been made of the principle of keeping so-called communities of interest intact, but this term is ill-defined and is being used at every possible scale such that it translates to an arbitrary argument for exclusion based on perceived differences. As a 40+ year resident of the county, I've come to deeply appreciate our potential to develop a common identity based on shared values of land stewardship, a healthy environment, natural beauty in abundance, cultural diversity, quality educational opportunities, and a strong tradition of innovation. This is why I implore you to reject motivations of exclusion when drawing or adjusting district boundaries.

Please work towards keeping current district boundaries more or less intact, with minor adjustments as needed to correct discrepancies or past error .



Dear Board of Supervisors:

At its regular monthly meeting last night, November 17th, the North Coast Advisory Council (NCAC) voted to recommend to the San Luis Obispo Board of Supervisors (BOS) that they adopt the draft Map A for the 5 supervisorial districts in SLO county, which keeps the boundaries of the districts largely as they now exist.

Cambria is currently in District 2, along with several other North Coast unincorporated areas, including San Simeon, Cayucos, and Los Osos. These communities, along with Morro Bay (which is incorporated), constitute a Community of Interest (COI) because of their similar concerns about coastal resources, including the proposed development of offshore energy and the existing and proposed marine sanctuaries, and our reliance on tourism for a major portion of our economy.

Keeping COI's together is an important principle in redistricting; therefore, it is fitting that Cambria remain in this COI and not be grouped with other, more urban, areas that do not share our particular concerns, which draft Map C would specifically do.

In addition, because the county's population since the last census in 2010 did not change sufficiently to warrant that district boundaries be redrawn, Map A is legally sufficient. This choice also preserves the compactness of the district.

The NCAC urges the Board of Supervisors to be mindful of these considerations during its redistricting deliberations and adopt Map A.


Dear Supervisors--

Dear Honorable Board of Supervisors:

I am a long-time resident of the County who lived in Atascadero for six years and then moved to SLO where I have lived and owned a business for the past 30 years. I have served on many non-profit boards and have been deeply involved in the community, working on such issues as business and economic development (SLO Chamber, Economic Vitality Corporation, County Economic Strategy Steering Committee), youth (YMCA, SLO Rotary de Tolosa), land conservation (SLO County Land Conservancy), intimate partner violence (RISE, Lumina Alliance) and literacy (Literacy for Life).

I am writing today to ask for your thoughtful consideration of the issues relating to redistricting. I am quite concerned that some of the maps which are being proposed will adversely affect citizens and communities of interest throughout our County. While the census shows some population shift, there is nothing earth-shattering and certainly nothing that requires a dramatic modification of supervisorial districts like that proposed in some of the maps.

To the extent that adjustments are appropriate, I support the proposed **SLO County 2030** map which makes minor modifications to the current districts so as to maintain communities of interest (Cal Poly, North Coast, Santa Margarita/Garden Farms, Creston/Shandon, Oceano/Nipomo) in the same district. In addition, the map insures that each district contains a significant agricultural presence so that this cultural, historic and economic driver of our County is considered by every supervisor when making decisions regarding economic

development and land use (e.g., adjusting the Second District border eastward along Highway 46 and 41 to ensure that there is a substantial agricultural representation in that district). The **SLO County 2030** map also ensures that each district contains both urbanized, incorporated cities along with unincorporated communities, and it maintains Diablo Canyon and Oceano Dunes in separate districts so that they might remain a top priority for one supervisor.

In short, there is no reason to make a radical adjustment to the current supervisorial districts as is contemplated by some of the maps which have been submitted. To the extent that modifications are appropriate, the proposed **SLO County 2030** map is the best solution and I strongly encourage you to adopt it.

Thank you for your careful consideration of this matter, and for your service to the citizens of our County.

Dear Board of Supervisors:

At its regular monthly meeting last night, November 17th, the North Coast Advisory Council (NCAC) voted to recommend to the San Luis Obispo Board of Supervisors (BOS) that they adopt the draft Map A for the 5 supervisorial districts in SLO county, which keeps the boundaries of the districts largely as they now exist.

Cambria is currently in District 2, along with several other North Coast unincorporated areas, including San Simeon, Cayucos, and Los Osos. These communities, along with Morro Bay (which is incorporated), constitute a Community of Interest (COI) because of their similar concerns about coastal resources, including the proposed development of offshore energy and the existing and proposed marine sanctuaries, and our reliance on tourism for a major portion of our economy.

Keeping COI's together is an important principle in redistricting; therefore, it is fitting that Cambria remain in this COI and not be grouped with other, more urban, areas that do not share our particular concerns, which draft Map C would specifically do.

In addition, because the county's population since the last census in 2010 did not change sufficiently to warrant that district boundaries be redrawn, Map A is legally sufficient. This choice also preserves the compactness of the district.

The NCAC urges the Board of Supervisors to be mindful of these considerations during its redistricting deliberations and adopt Map A.

Members of the San Luis Obispo County Board of Supervisors,

I am a homeowner in San Luis Obispo and have been so for more than 20 years. I attended this morning's Board of Supervisors meeting about redistricting maps for about two hours. I am writing this email in lieu of making a public comment at the meeting as I was not able to stay long enough to do so.

The 2020 census results show our population has not changed enough to legally require significant changes to the current supervisor map. I urge you all to retain the current district lines or to keep changes to a minimum, as in Plan A. The current lines are fully compliant with election laws. The current districts efficiently and fairly balance geography, population, communities of interest, and party registration.

I heard many speakers this morning commenting in favor of the Richard Patten map, but I agree with the guy who got up and said: "Simply restating over and over again that the Patten map meets the requirements doesn't make it so." Many of those who spoke in favor of the Patten map insisted that the city of San Luis Obispo and Cal Poly have to be in one district. That argument seems very disingenuous to me as the vast majority of those speakers do not even live in San Luis Obispo and none of them are at all concerned about the impact their preferred Patten map would have on overall balance or on other communities of interest, for example residents of our northern coast. The reality is, keeping San Luis Obispo in one district is difficult to do while balancing other factors of compliance and fairness because my

community is the largest, population-wise, in the county. Balance, fairness and of course compliance are the overall goals, not keeping the city of San Luis Obispo/CalPoly in one district. Gerrymandering behind a false facade of supposedly "protecting a community of interest" is still gerrymandering.

The argument made by Lynn Compton that our districts were gerrymandered by a Democratic majority in 2011 doesn't make any sense either. If those maps had been egregiously gerrymandered in 2011, Lynn Compton's party would not hold the majority on the board at the present time. This is another disingenuous argument which it seems to me is being made as cover, ironically, for an attempt to gerrymander to the advantage of her own party.

To Chair Le Mons,

On behalf of the Arroyo Grande City Council, I am writing to articulate the City's concerns with the Assembly District visualizations considered by the California Citizens Redistricting Commission (Commission) during the week beginning October 27, 2021. The district map visualizations currently being considered by the Commission would radically change the City's representation in the California Assembly. Currently, the residents of the City of Arroyo Grande are represented by Assembly District 35, which encompasses all of San Luis Obispo County plus areas of northern Santa Barbara County. This configuration honors the integrity of our community of interest, which includes what is known as the Five Cities region, representing the cities of Arroyo Grande, Grover Beach, and Pismo Beach, and the communities of Oceano and Shell Beach. This area is known as the Five Cities not only because we share jurisdictional boundaries, but also because we share vital services to our communities, such as fire and emergency services provided through the Five Cities Fire Authority and homelessness services provided by the 5Cities Homeless Coalition. Moreover, the current Assembly District configuration sustains the shared interests of all of the jurisdictions within County of San Luis Obispo, as well as areas of northern Santa Barbara County, including the City of Santa Maria, which are tied to our region through shared water, human, and economic resources.

By contrast, the proposed new Assembly District would remove the City of Arroyo Grande from its shared representation with its adjacent cities and communities of Grover Beach, Oceano, and Pismo Beach and disregards our community's close connectivity with the Five Cities and South San Luis Obispo County region, as well as the remainder of its County representation. This development has the potential to complicate efforts to seek legislative support for regional projects and to collectively advocate for legislative solutions that impact our jurisdiction. For example, the cities of Arroyo Grande, Grover Beach, and Pismo Beach are jointly developing a recycled water project, the Central Coast Blue Project, that will ensure sustainable water for the region and protect the precious groundwater resource that we all share within the Santa Maria Groundwater Basin, which underlies the area from Pismo Beach down to Santa Maria. Significant grant funding is needed to ensure the success of this project, and redrawing district boundaries to separate Arroyo Grande from its partners will needlessly complicate advocacy efforts for this project. It is important for the City to retain the ability to jointly seek support from its Assembly representative on regional projects and needs, from infrastructure to community services that we share with our regional partners.

The City is aware of the amount of feedback to be received in the coming weeks about the statewide visualization, and that the Commission's task is incredibly complicated. But as the process occurs, please consider the importance of keeping Arroyo Grande a part of the Five Cities and South San Luis Obispo County region in all levels of State representation. The City deserves representatives selected by its community of interest, so that they may be responsive and understanding of our unique and shared needs.
