19 The District Attorney of the San Luis Obispo County, California, hereby accuses the
20 above named defendant of the following criminal offenses:

21

Count 1

22 On or about December 4, 2017, in the County of San Luis Obispo, State of California, the
23 crime of Assault To Commit A Felony During The Commission Of A First Degree Burglary
24 in violation of PC220(b), a Felony, was committed in that TYRONE ANDERSON did during
25 the commission of a first degree burglary assault Confidential Victim, with the intent to
26 commit rape, sodomy, oral copulation and a violation of sections 264.1, 288, and 289.

27 NOTICE: Conviction of this offense will require you to register pursuant to Penal Code
28 section 290. Willful failure to register is a crime.

1 NOTICE: The above offense is a violent felony within the meaning of Penal Code 667.5(c).
2 NOTICE: Being charged with this criminal offense can result in mandatory pre-conviction
3 HIV/AIDS testing and disclosure of the results to a victim and the Chief Medical Officer of
4 the jail or prison facility where you are incarcerated pursuant to Penal Code Section
5 1524.1 and Health and Safety Code section 121055 following a probable cause hearing
6 resulting in a court order.

7 Enhancement

8 PC667.61(a) and (e): Spec Alleg-Sex Crimes - Aggravated Circumstances

9 It is further alleged, within the meaning of Penal Code sections 667.61(a) and (e), as to
10 defendant, TYRONE ANDERSON, as to count 1 that the following circumstances apply:
11 The defendant comitted the present offense during the commission of a burglary in
12 violation of Section 459.

13 Enhancement

14 PC667.61(a) and (e): Spec Alleg-Sex Crimes - Aggravated Circumstances

15 It is further alleged, within the meaning of Penal Code sections 667.61(a) and (e), as to
16 defendant, TYRONE ANDERSON, as to count 1 that the following circumstances apply:
17 The defendant engaged in the tying or binding of the victim or another person in the
18 commision of the present offense.

19 Count 2

20 On or about December 4, 2017, in the County of San Luis Obispo, State of California, the
21 crime of First Degree Burglary, Person Present in violation of PC459, a Felony, was
22 committed in that TYRONE ANDERSON did enter an inhabited dwelling house and trailer
23 coach and inhabited portion of a building occupied by Confidential Victim, with the intent to
24 commit larceny and any felony.

25 NOTICE: The above offense is a serious felony within the meaning of Penal Code Section
26 1192.7(c). It is further alleged that the above offense is a violation of Penal Code
27 Section 462(a). It is further alleged that the above offense is a violent felony within the
28

1 meaning of Penal Code 667.5(c) in that another person, other than an accomplice, was
2 present in the residence during the commission of the above offense.

3 Count 3

4 On or about December 4, 2017, in the County of San Luis Obispo, State of California, the
5 crime of Sexual Battery in violation of PC243.4(e)(1), a Misdemeanor, was committed in
6 that TYRONE ANDERSON did willfully and unlawfully touch an intimate part of
7 Confidential Victim, against the will and for the specific purpose of sexual arousal, sexual
8 gratification and sexual abuse.

9 Count 4

10 On or about May 7, 2018, in the County of San Luis Obispo, State of California, the crime
11 of Kidnapping To Commit Another Crime in violation of PC209(b)(1), a Felony, was
12 committed in that TYRONE ANDERSON did unlawfully kidnap and carry away Confidential
13 Victim to commit rape.

14 NOTICE: The above offense is a serious felony within the meaning of Penal Code Section
15 1192.7(c).

16 Count 5

17 On or about May 7, 2018, in the County of San Luis Obispo, State of California, the crime
18 of Assault By Means Likely To Produce Great Bodily Injury in violation of PC245(a)(4), a
19 Felony, was committed in that TYRONE ANDERSON did willfully and unlawfully commit an
20 assault on Confidential Victim by means of force likely to produce great bodily injury.

21 Count 6

22 On or about May 7, 2018, in the County of San Luis Obispo, State of California, the crime
23 of Assault With A Deadly Weapon in violation of PC245(a)(1), a Felony, was committed in
24 that TYRONE ANDERSON did willfully and unlawfully commit an assault upon M. Rummel
25 with a deadly weapon, to wit, a knife.

26 NOTICE: The above offense is a serious felony within the meaning of Penal Code Section
27 1192.7(c).

Count 7

On or about December 4, 2017, in the County of San Luis Obispo, State of California, the crime of False Imprisonment By Violence in violation of PC236, a Felony, was committed in that TYRONE ANDERSON did unlawfully violate the personal liberty of Confidential Victim, said violation being effected by violence, menace, fraud, and deceit.


Count 8

On or about December 4, 2017, in the County of San Luis Obispo, State of California, the crime of Assault By Means Likely To Produce Great Bodily Injury in violation of PC245(a)(4), a Felony, was committed in that TYRONE ANDERSON did willfully and unlawfully commit an assault on Confidential Victim by means of force likely to produce great bodily injury.

2 provided and against the peace and dignity of the people of the State of California.
