

Stakeholder Survey Results

8 Responses, 3 blank surveys, 11 total

5 female, 3 male; 7 White (Non-Hispanic), 1 Asian

Identified/represent the following: BHB Member; Adult/Senior with Severe Mental Illness (SMI),; Family of children, adults, and/or seniors with SMI (3); Provider of Services (4); Law Enforcement; Education; Social Services (3); Health Care Organization; Non-Profit (6); and Advocate for Underserved Population (3), serving Spanish (3), Families, Homeless (2), and Low Income populations.



Time allotted | 30minutes | Agenda topic Program Update | Presenter Frank W

Frank and several of the providers present spoke about their programs and provided some highlights on services and outcomes. SLOBHD staff spoke about the Student Assistance Program and its success with reaching children early through outreach, advocacy, brief interventions, and referrals to appropriate services. Other speakers included Shannon M. (TMHA) and Shana P (CAPSLO)

Time allotted | 30minutes | Agenda topic Funding Levels | Presenter Raven L

Discussion Raven reviewed the funding sources for MHSA, as well as speak about the Revenue and Expense projections for FY 2015-16 through FY 2018-19. Raven spoke about the types of programs these funds may cover, as well as speak about funding increases for current FY 2015-16 PEI providers. There was discussion of the prudent reserve funds, which had been previously approved to be used for CalMHSA funding. Since there may be additional funding changes, the recommendation was made to hold on using these funds until more information on the changes is available.

Conclusion: Group agrees to hold off on using the funds for now.

Time allotted | 15minutes | Agenda topic PEI Regulations | Presenter Juan M.

The current regulations were approved in October 2015, and included refinements in the language governing reporting documents (Annual Report and 3-year Plan), and demographic information. There are additional discussions on the topics of Access and Linkage, in particular the measurement of Duration of Untreated Mental Illness (DUMI). The four topics being discussed are:

- i. Number of individuals with SMI referred to treatment, and the type of treatment
- ii. Number of individuals who followed through on referrals (participated in one program)
- iii. Average DUMI
- iv. Average interval between referral and follow-through on it

As more information becomes available the group will receive updates.

Time allotted | 15minutes | Agenda topic New Business | Presenter Frank W

Discussion around potentially expanding the SAP programming to reach additional middle schools, as well as high schools. There is also interest from schools to replicate the student wellness center that AHS created; there was some conversation about possibly wanting to fund, or seed, such programs going forward. The group also talked about expanding the SAFE program as part of the parent educator programming.
