6)	<p>Project Updates:</p> <ul style="list-style-type: none"> Final project closeout documents and grant reimbursement request for \$2.2M has been submitted to DWR for the Prop 84 IRWM Implementation Grant. The grant funding match of 25% was covered by other projects in the grant proposal like the Los Osos Water Recycling Facility. The Prop 84 grant was fully utilized and all \$2.2M of awarded funds are processing for reimbursement. Final project closeout documents and the final reimbursement request for the Prop 1E Stormwater Management Grant are being prepared. This grant award is for a total of \$2.8M and is being processed for reimbursements. Final project closeout documents and the final reimbursement request for the FEMA Hazard Mitigation Grant Program have been sent. This grant award is for a total of \$3.0M. Reimbursements are going out at the end of the month <p>Next phase: Meadow Creek Watershed Lagoon Restoration Plan</p> <ul style="list-style-type: none"> Eric Laurie Update: Stillwater Sciences completed the first phase of work which involved data collection and summary of data gaps. Next steps include meeting with the Science Panel, establishing criteria for model development and alternatives development.
