4. Reports

• Sustainable Groundwater Management Act (SGMA) Update

Brendan Clark, Secretary, informs the Committee about the June 10, 2020 San Luis Obispo Valley Groundwater Basin workshop for Chapter 6: Water Budget of the Groundwater Sustainability Plan taking place at 3:30.

Mid-Higuera Bypass Project Updates

Brian Nelson, City Engineer, updates the Committee about the 90% design deliverable set to be submitted by the Consultant in June 2020. The City is currently applying for a \$6 million California Natural Resources Agency Urban Flood Protection grant opportunity. The City expects the receive grant award notice in Fall 2020. The City reports that discussions with the Madonna family regarding property access will be pursued once project funding is secured.

• Creek Maintenance Updates

Freddy Otte, City Biologist, provides an update about creek maintenance activities. A few downed trees were removed by tree contractors. Freddy reports that winter storm events did not present any significant issues. It is anticipated that flood control technicians will resume work in Winter 2020.

Arundo Removal Updates

Kaila Dettman, Land Conservancy, provides the update on the annual arundo treatments that will begin in August 2020. Freddy Otte, City Biologist, informs the committee that removal of large stand of arundo at Los Osos Valley Road will be addressed in conjunction with the Calle Joaquin Sewer Line Project in September 2021.

5. Fiscal Year 2020/21 Budget Presentation by County Finance

Jana Etteddgue, County Finance, presents the form Schedule 15 for the Fiscal Year 2020/21 Zone 9 budget. Jana notes that the \$60,000 loan to Zone 1 was repaid in in Fiscal Year 19/20 and there are no impending loans. Jana notes that reserves were increased by \$134,462. Jana reports that the County Board of Supervisors Budget Hearing took place the week of June 8, 2020 and the final budget will be approved in September 2020. Jana reports that Covid-19 related changes in budget projections will not affect Fiscal Year

2020/21 budget but will likely affect Fiscal Year 2021/22 budget due to a decrease in revenues.

Updates

Update

San Luis Obispo Basin is designated as a high priority basin. The County and City of San Luis Obispo as GSAs in the basin are developing a GSP for the SLO Basin and coordinating as the Groundwater Sustainability Commission (GSC) with other basin partners.

- The next GSC meeting is December 9, 2020.
- **September 9, 2020** A virtual special GSC meeting was held on September 9, 2020. The project team presented preliminary draft monitoring network, draft representative monitoring wells, and draft sustainable management criteria. The project team will continue to refine the draft sustainable management criteria in the next public workshop on October 1st. A draft Data Management Plan was also presented. The GSC recommended the draft Data Management Plan to be received and filed by the Board of Supervisors and City Council and released for public review and comments. The comment period for the draft Data Management Plan closes on October 31, 2020.
- October 1, 2020 The Public Workshop#3 was held to continue to engage the public and stakeholders regarding further refinements on details of the sustainable management criteria and alternatives and their rationales.

SUBJECT: Agenda Item #3b: Mid-Higuera Bypass Project Updates

Update

The design consultant delivered the full 90% project plans and specifications package in Mid-August. City staff are routing that deliverable for internal review, and have also sent it to County staff to begin the environmental permitting process.

City Staff recently submitted a concept proposal for a Department of Water Resources (DWR) Coastal Watershed Flood Risk Reduction Grant, with total Proposition 1 available program funding amount of \$27 million, available until 2024. This grant would require a 50% matching contribution, with possible reductions under certain project conditions. Feedback from DWR was positive, and staff are beginning work on a full grant proposal, due to DWR on November 20th. As a reminder, staff also applied for a California Natural Resources Agency Grant (CNRA) in April and have yet to hear back from that agency.

Based on the current status and future needs to continue making progress on several projects, the City is requesting the following funding from Zone 9 for the 2021-2022 Fiscal Year.

Project Name	Requested FY 2021/22
General Creek Maintenance	\$130,500
Silt Removal	\$130,000
Mid Higuera Bypass	\$40,000
Total	\$300,500

General Creek Maintenance

\$130,500 to fund ongoing general creek maintenance which includes channel clearing, including removal of trees, vegetation, and arundo from creeks. Funding is planned to be used as follows:

 1. Contract Labor - Channel Clearing:
 \$51,500

 2. Channel Tree Removals:
 \$46,000

 3. Vegetation Disposal:
 \$5,000

 4. Arundo Removal:
 \$28,000

Silt Removal

Existing funding to support Silt Removal is approximately \$230,000. Available funding remains high due to lower than expected design and construction costs for prior projects. As a result, these remaining funds will support design and permitting work for 2021 silt removal locations.

Typically, silt removal projects address 1-2 locations per year. Existing funds, in addition to the request of \$130,000, will support an expansion of the program in 2021 and fund design, permitting, and construction at up to five creek locations. Currently, the following locations are prioritized:

- Prefumo ARM Prefumo Creek at LOVR
- 2. Unnamed Tributary to Acacia Creek Sacramento at Ricardo Court
- 3. Sydney Creek East of Railroad Safety crossing, south of Sinsheimer Park
- 4. Prefumo Creek South of Madonna at Laguna Lake outfall
- 5. San Luis Creek Bypass channel at LOVR and HWY 101

Mid Higuera Bypass

\$40,000 is requested for the Mid Higuera Bypass project for consultant work to negotiate with adjacent property owners regarding project right of way, construction access, and demolition of the "pinch-point" structure at 306 Higuera Street.
